Referral Requirements	Your primary care physician (PCP) is responsible for providing or referring all necessary health care services. If your PCP determines you need care that is not available from your primary doctor or clinic's system of providers, your PCP will provide a written referral to a participating specialist indicating the number of visits and the length of time allowed for those visits. We will send a copy of the referral letter to you, your PCP and the specialist. Whenever possible referrals are made within Atrium's extensive specialty physician network.
Prior Authorization Requirements	Atrium Health Plan, Inc. reviews services to verify that they are medically necessary and that treatment provided is the proper level of care. Prior authorization (PA) is recommended before you receive selected services so that you avoid incurring charges for services that may not be considered medically necessary. Contact customer service regarding services requiring PA. In-network providers will obtain the PA for you. We recommend that the provider contact us at least 10 working days prior to receiving care to determine if the services are eligible. We will notify you, in writing, of the decision within 10 working days provided that the PA request contains all the information needed to review the service. With PA, we guarantee payment for services approved in advance if the services are otherwise covered under your certificate and you are covered on the date you receive care. All contract provisions continue to apply. The PA will indicate a specified time frame in which you may receive the services. Any service not performed in the specified time frame will need to be prior authorized again.
Medicare Claims Procedure	Primary and contract specialists submit claims for retirees with Medicare benefits directly to Atrium Health Plan after filing with Medicare.

PCP Restrictions

Each family member may select a different primary care physician/clinic. If a change is requested, we must receive the request on or before the 15th of the month to make the change effective the first of the following month. The Health Insurance Change form is available through your Human Resources office, or if you are an annuitant, through Employee Trust Funds.

Dental Benefits If Provided

Preventive dental benefit for all ages. Covered services include: oral examinations and cleanings every six months; bitewing x-rays every 12 months, and fluoride treatments once a year for persons under age 19. These services are covered at 100%. Sealants are covered at 100% (once per lifetime) for dependent children to age 19. You can find out if your dentist participates in the plan by calling the dentist's office or by checking the dental section of your 2005 Provider Directory.
