BUDGET AND OPERATIONS UPDATE

Mr. Stohr provided an update on the following:

- the implementation of the 2013 Wisconsin Act 20 provisions that relate to the Wisconsin Retirement System (WRS) and rehired annuitants;
- and the development of frequently asked questions and webinars on the recent law changes.

Mr. Stohr provided an operations update on retirement estimates and applications, comparing the first and second quarter of 2013.

- Retirement estimates were down from 6,676 estimates in first quarter, compared to 5,953 in second quarter of 2013.
- Retirement applications were up from 2,379 in first quarter to 3,529 applications in second quarter of 2013.
