CONSIDERATION OF MINUTES OF PREVIOUS MEETING



BUDGET AND OPERATIONS UPDATE

Mr. Stohr provided the following updates:

- The number of retirement estimates in 2014 was 25,930; in 2013 there were 22,586.
- The number of applications processed in 2014 was 14,452; in 2013 there were 13,841.
- ETF worked with its tax counselors who suggested changing how we issue 1099Rs, effective with the 2014 tax year. There were some member questions as a result of the changes that were implemented. More information will be provided at the ETF Board meeting later today.

2015-2017 STATE BUDGET UPDATE

Ms. Hunter discussed the 2015-2017 state budget provisions as proposed by the governor that affect ETF programs and operations (Ref. JM | 4.2.15 | 4B).

TRANSFORMATION, INTEGRATION, AND MODERNIZATION (TIM) INITIATIVE AND **PROJECT PORTFOLIO**

Mr. Martin provided an update on the TIM Initiative and the Benefit Administration System (BAS) project, including rollouts 1, 2 and 3. Mr. Martin provided a review of the budget for the BAS project and its subprojects. Updates were also provided on the other projects in the Department. The Committee recognizes and appreciates the efforts of staff who are working on the projects and those who are filling in for those who are devoted to the projects.
