This memo is for informational purposes only. No action is required.

Below is the Department of Employee Trust Funds modernization project update for the period ending February 28, 2023. This provides the Board an overview of the project highlights, health, major milestones, and key issues and risks.

Executive Summary:

The Insurance Administration System (IAS) Implementation project continues to be on track. The second amendment to the contract is ready for signature. This amendment addresses employer groups and the selection of a billing option. An additional amendment will be needed for COBRA administration and is expected to be completed within the next month. This is a current function performed by employers that will transfer to ETF and its oversight of the IAS vendor, BenefitFocus. Please reference the Group Insurance Board Memo - Insurance Administration System Update presented on February 22, 2023, for additional details.

The Data Management (DM) Program overall is on target. Focus is on supporting data for the Insurance Administration System project. The Data Storage, Warehouse and Business Intelligence project is seeing some delays due to staff turnover.

A key dependency to successfully deliver IAS is to ensure members' identity is verified. The Identity Proofing project, Strategic Initiative 4.3.5, is being reported here for reference, and the project is at risk due to delays in contracting to complete the proof of concept. This does not have an impact on any other projects currently.
