Glide Path

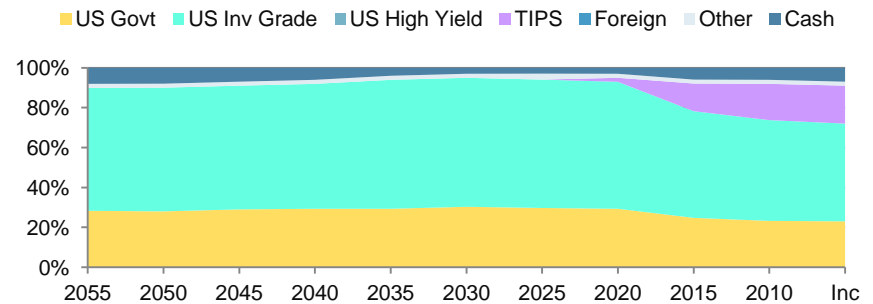

ASSET LOADINGS (Returns-based)

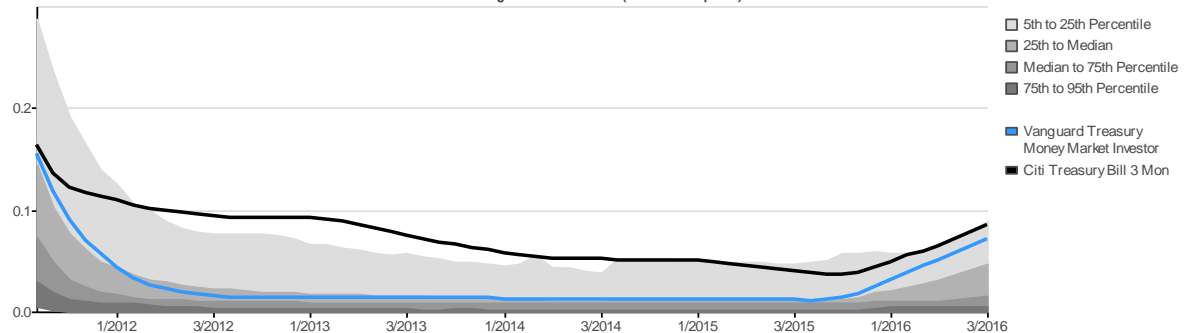

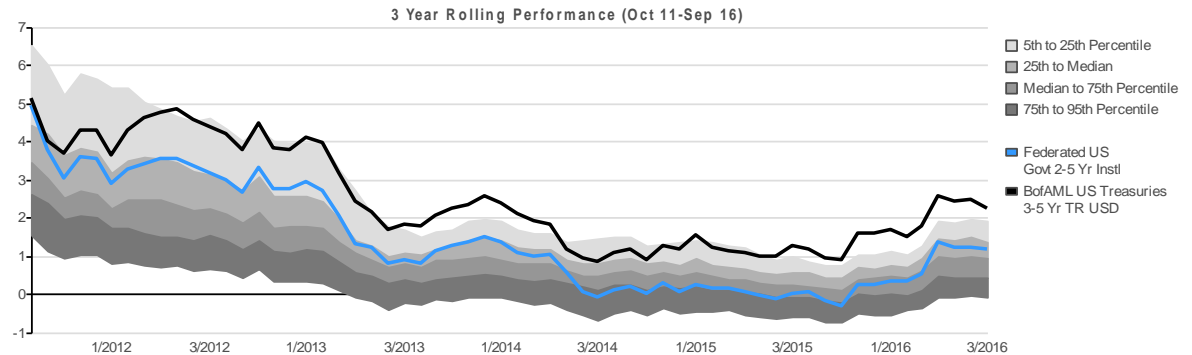
ASSET LOADINGS (Returns-based)

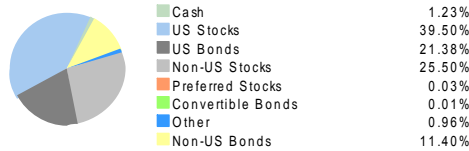

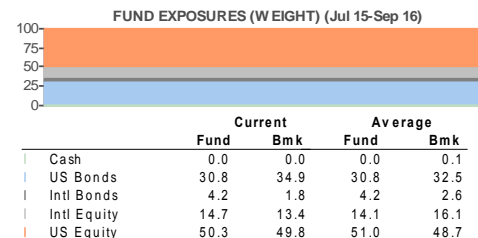

Summary

U.S. Economy

- Economic growth continued at a slow pace in the second quarter
 - The final estimate came in at an annualized rate of 1.4%. This reflects an increase from 0.8% in the first quarter
- After some very inspiring jobs numbers in June and July, the numbers slipped a bit in August
- The U.S. Federal Reserve again passed on a rate increase at their most recent meeting in September
 - The Fed Funds rate currently remains targeted at 0.25%

U.S. Markets

- 2016 has been a volatile year in the financial markets
 - Despite the ups and downs, year-to-date returns have generally been positive for both equities and fixed income
- The S&P 500 Index closed the quarter with a gain of 3.9%
 - The third quarter gain brought the year-to-date return up to 7.8%
 - Three- and five-year annualized trailing returns are even stronger at 11.2% and 16.4%, respectively
- Small cap stocks had a stronger quarter than large caps
- Returns on commodities slipped again during the quarter
- The third quarter was generally a good period for fixed income investors, despite a marginally rising rate environment
 - The yield on the benchmark 10-year treasury increased from 1.49% at the end of the second quarter to 1.60% by the end of the third quarter
 - The Bloomberg Barclays U.S. Aggregate Bond Index posted a return of 0.5% during the second quarter

- Analysis conducted by Great-West Capital Management shows that historically there has been little correlation between interest rate movements and stock market performance
 - This suggests that rising rates do not directly impact future stock market returns
 - The stock market has actually performed marginally better during rising rate environments, on average, than it has during falling rate environments

Global Economy

- The long-term implications of Brexit remain unknown
- At the end of the third quarter the Organization of the Petroleum Exporting Countries (OPEC) agreed to cut oil production
 - The announcement marks the first time in eight years that OPEC has cut production

Global Markets

- Outside of the U.S., equity markets returns were very strong during the quarter
 - The MSCI EAFE Index realized a total return of 6.4% during the quarter, dragging the year-to-date return into positive territory at 1.7%
 - The MSCI Emerging Markets Index was even more impressive, generating a total return of 9.0% during the third quarter
- Longer-term international equity market returns continue to lag domestic equity returns

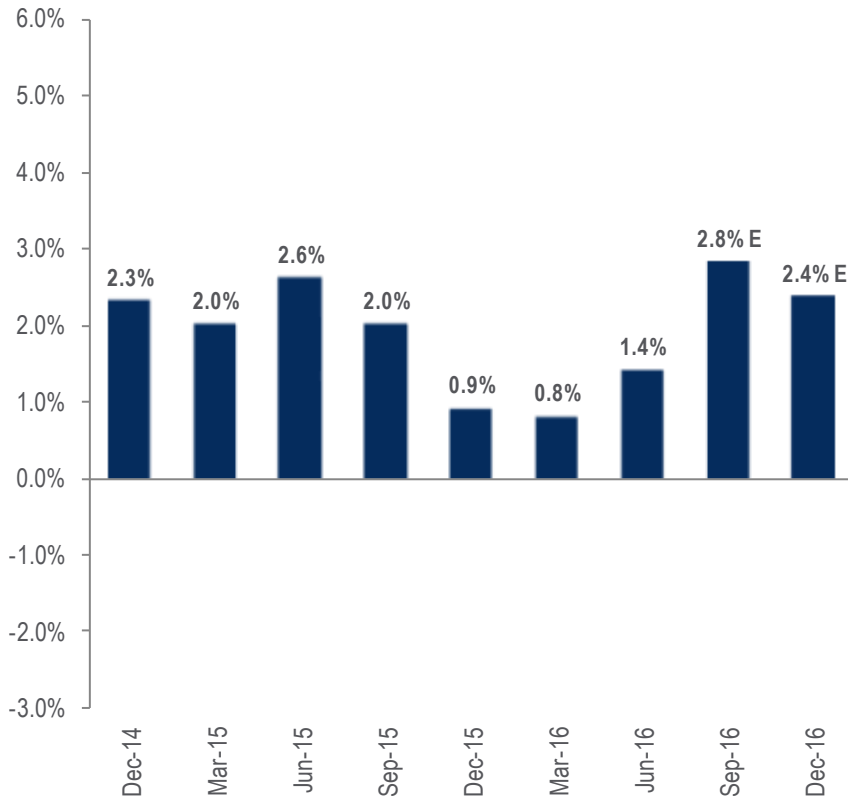

annual percent change, through August 2016



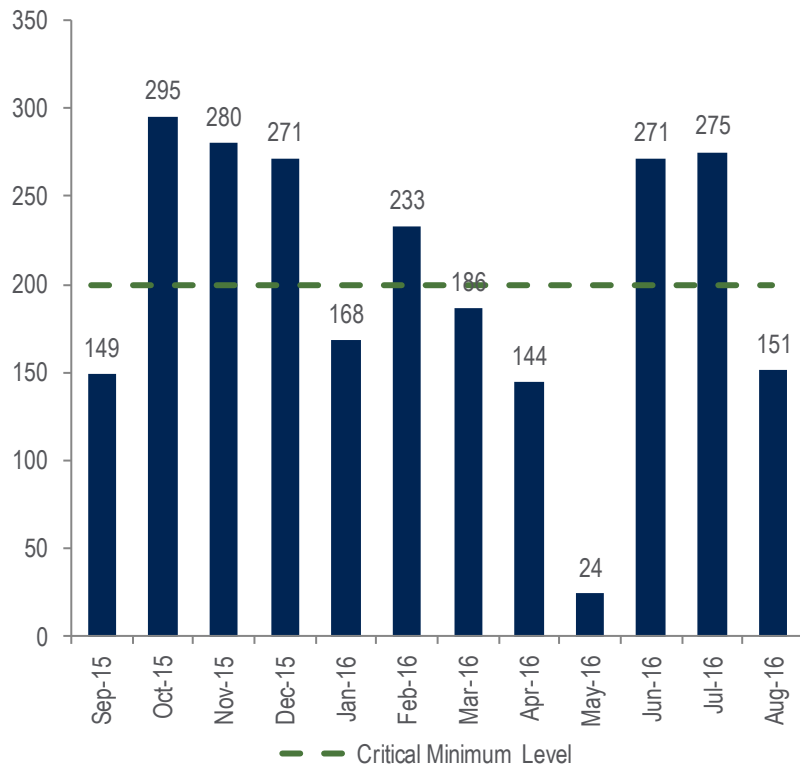

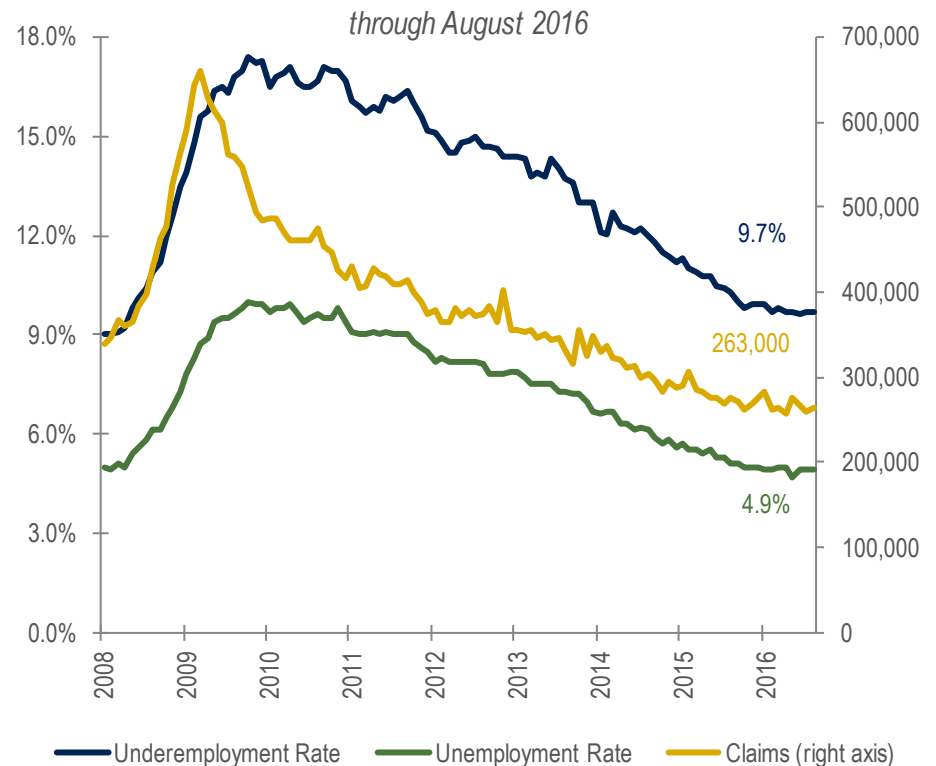

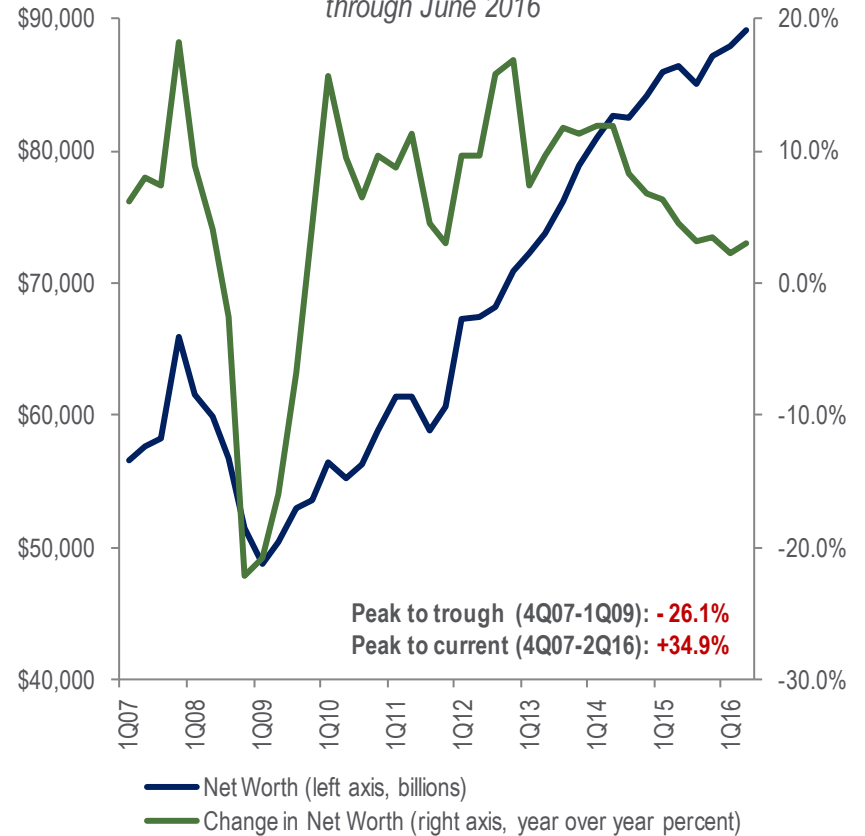

through July 2016



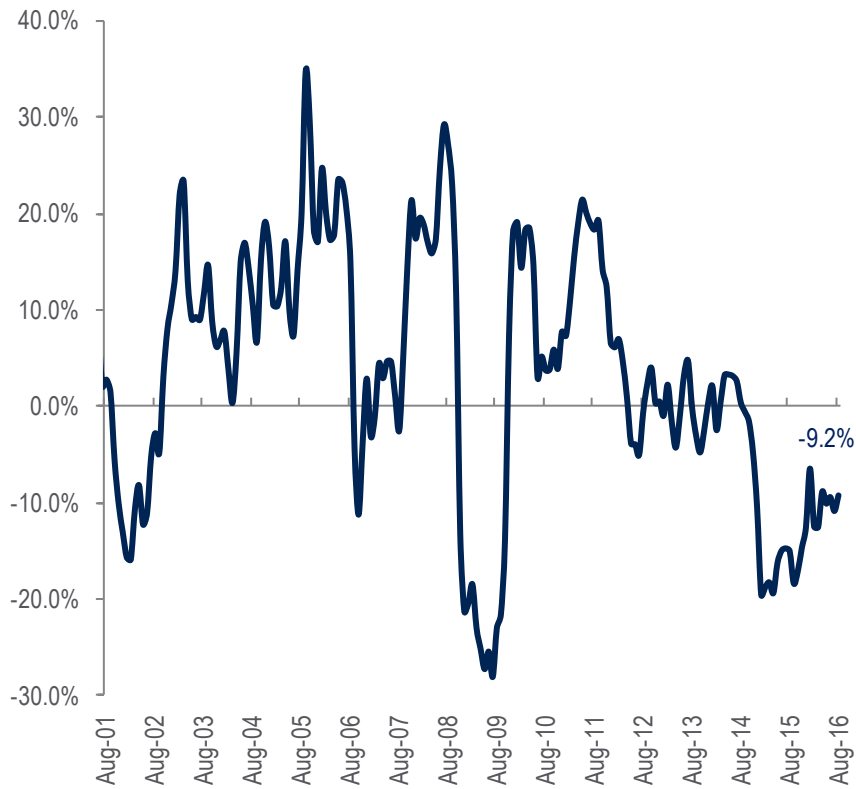

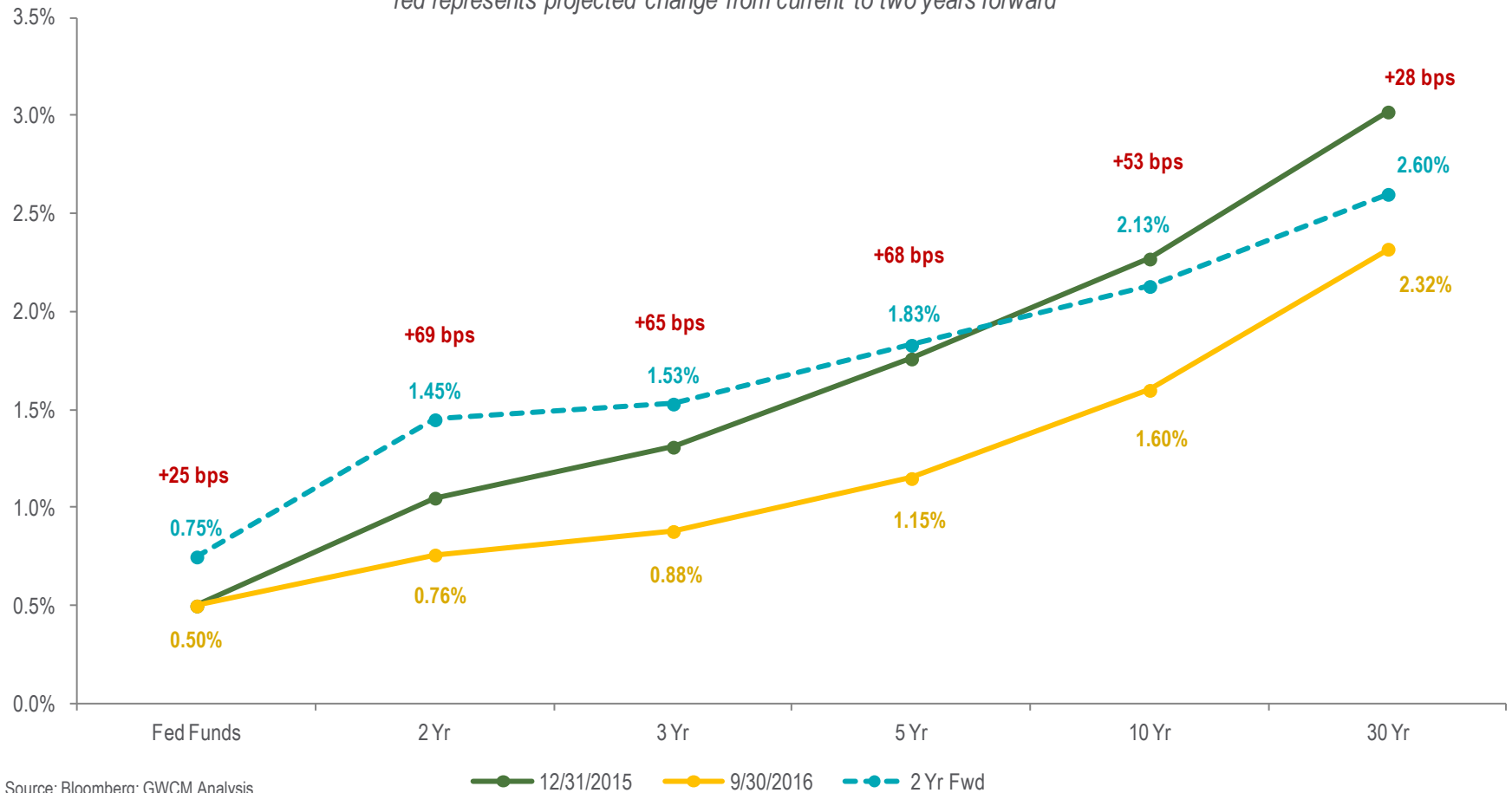

red represents projected change from current to two years forward

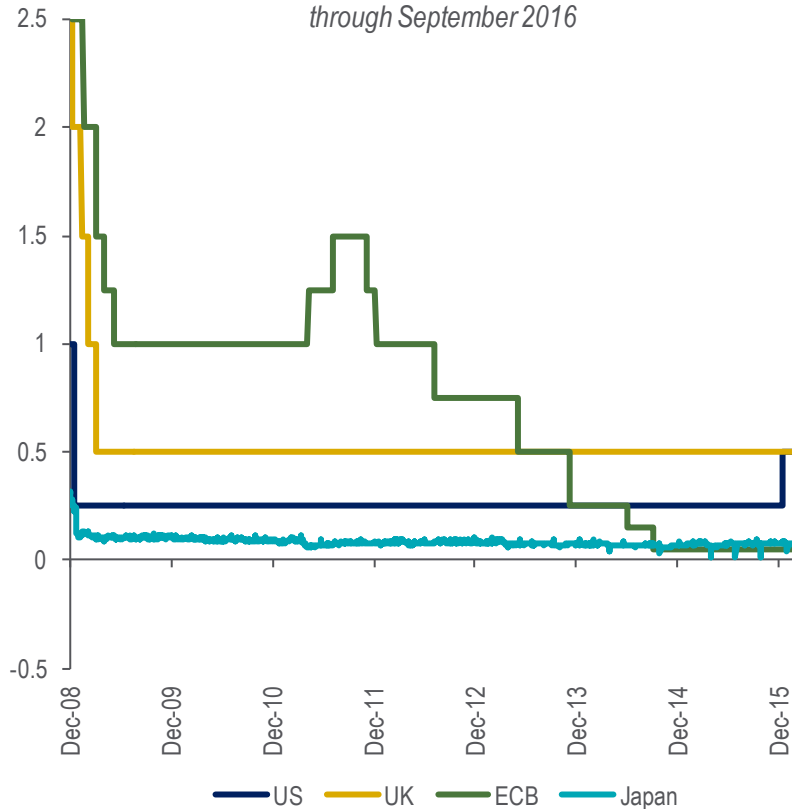

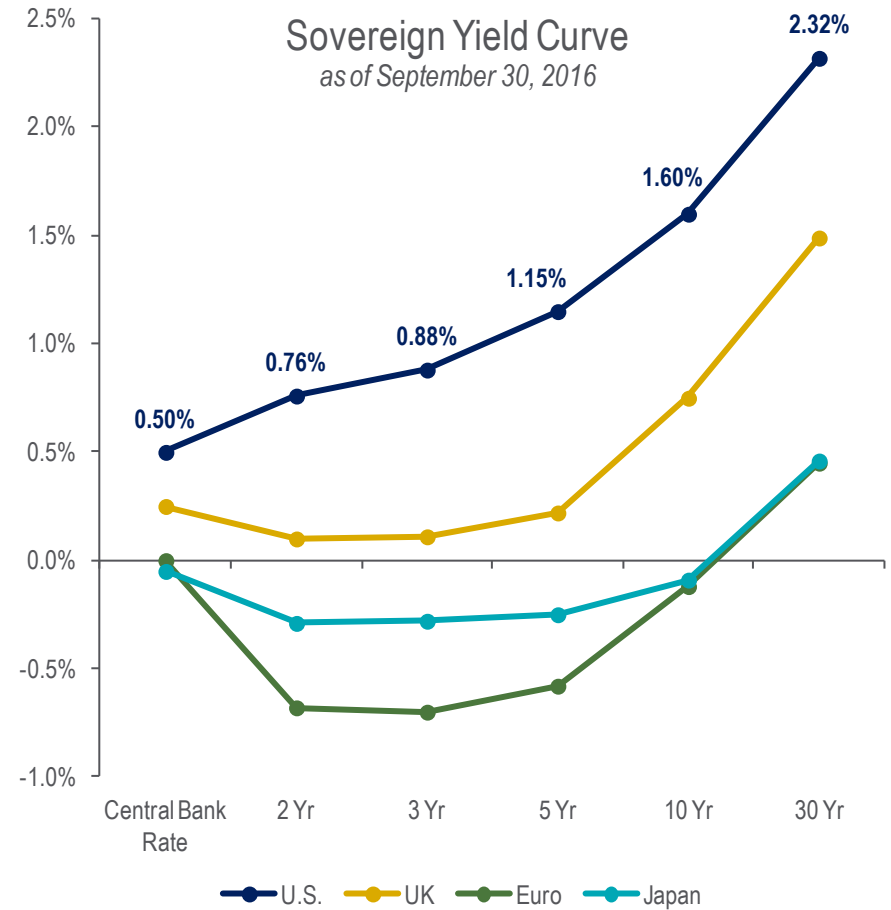
Global Monetary Policies and Interest Rates

through September 2016

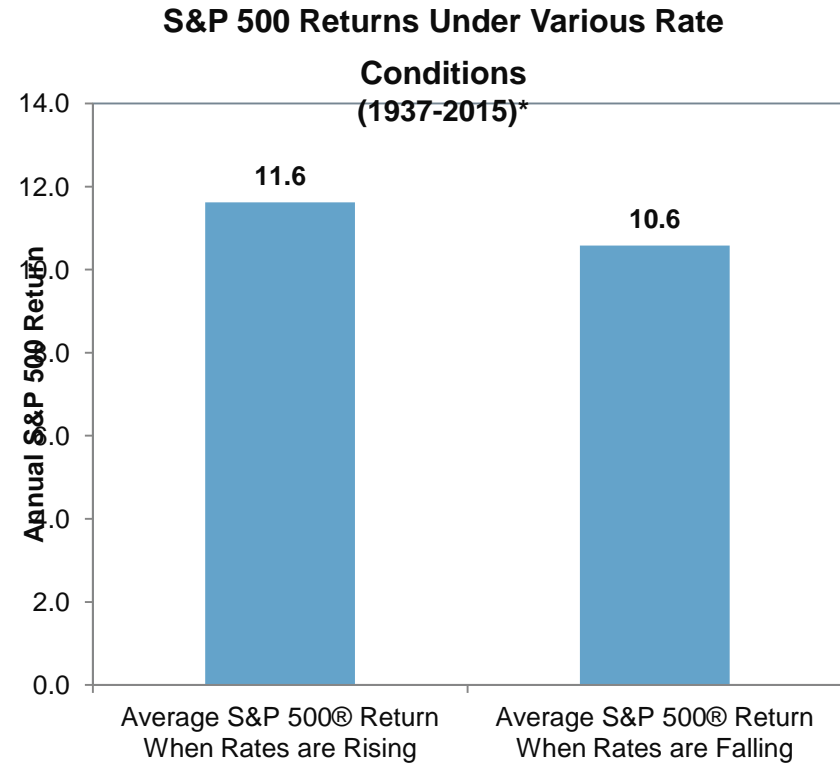
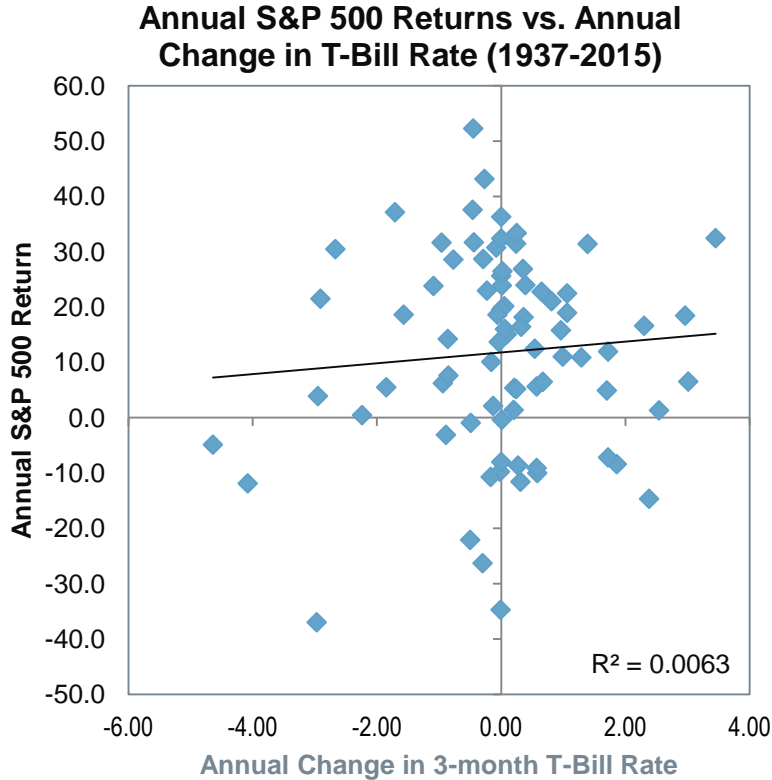

as of September 30, 2016



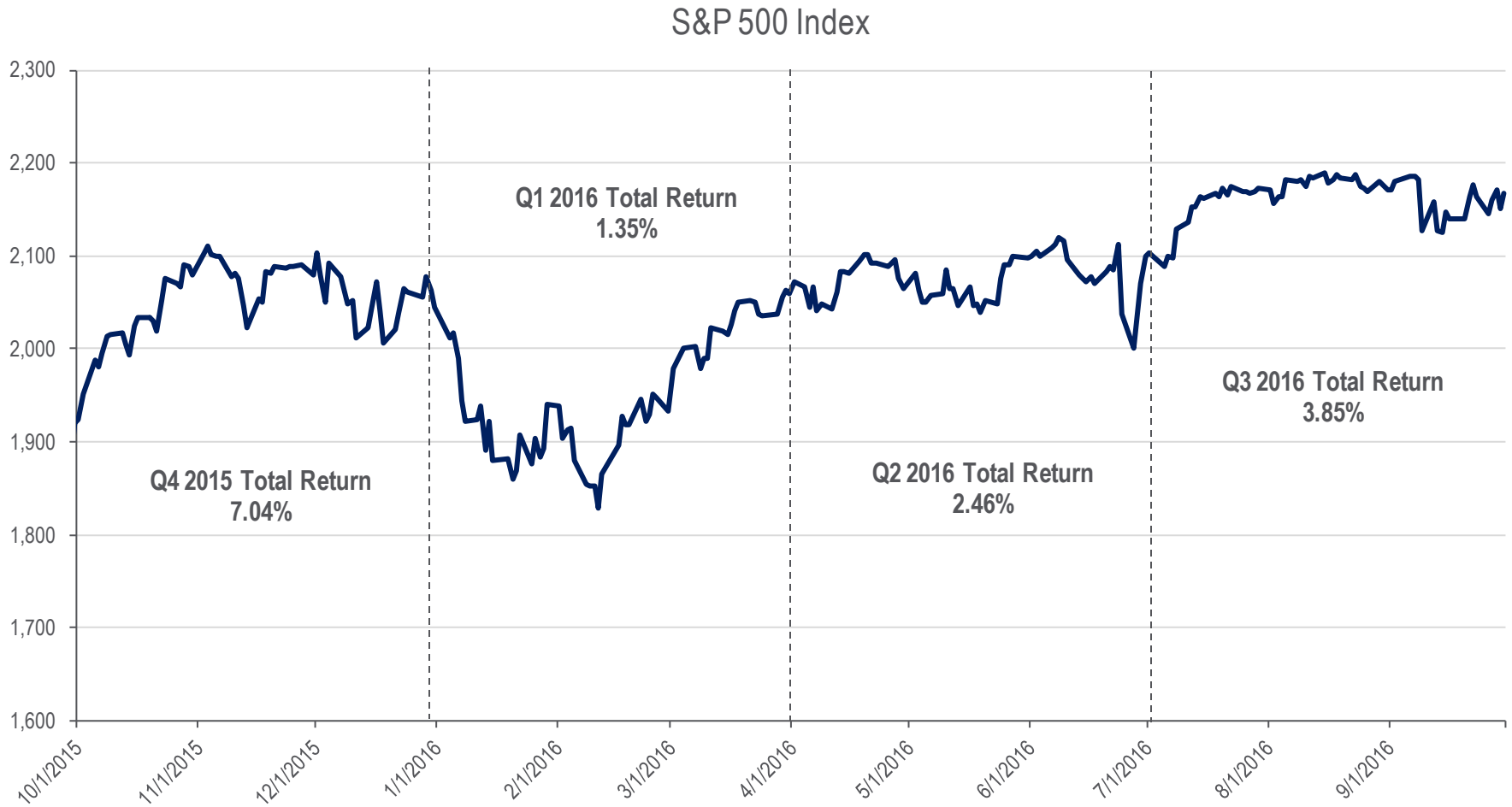
Impact of Rising Rates on Stock Market Returns

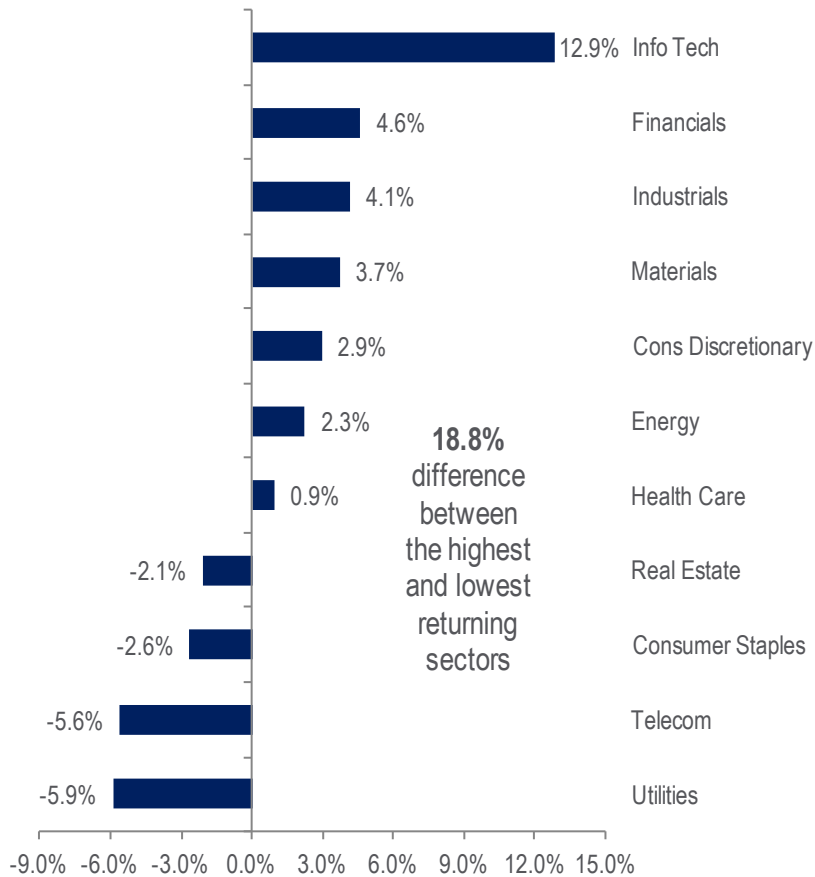

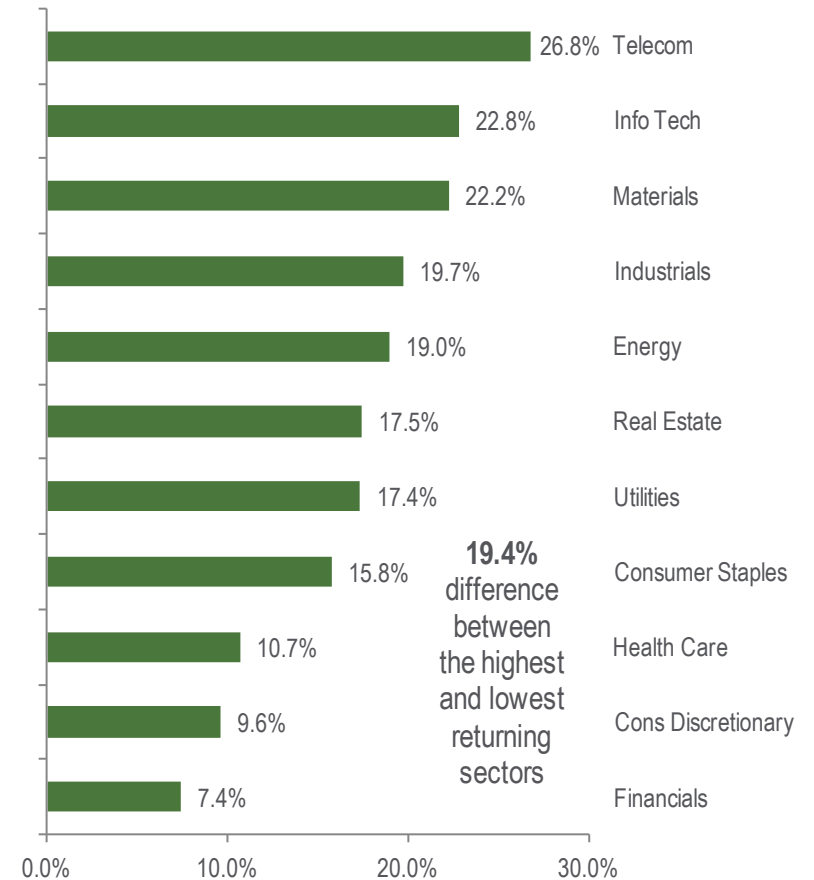

Glossary

- **Alpha** - Risk-adjusted excess return of a fund over its benchmark. A positive alpha number means that the fund is generating excess return relative to its expected excess return.
- **Beta** - A measure of a fund's volatility compared to its benchmark. A beta of 1.1 indicates that the fund is 10% more volatile than its benchmark.
- **Duration** - A common gauge of the price sensitivity of a fixed income asset or portfolio to a change in interest rates.
- **Expense ratio** - A measure of a fund's overall expenses.
- **Investment policy** - A fund's stated investment objectives and operating policy.
- **R²** - The percentage of the variability in the returns of one investment that can be associated with the variability in the returns of its applicable benchmark.
- **Risk** - Refers to performance volatility, or the probability of not meeting the specified investment objectives.
- **Sharpe Ratio** - Measures return per unit of risk assumed. It is calculated by subtracting the risk free return from the total return of the fund and dividing it by the fund's risk level (standard deviation).
- **Standard Deviation** - A measure of dispersion which determines how much the values within it differ from the mean.
- **Trailing Period** - A snap shot of a specific period of time. A 1-year trailing return represents the previous 12-month period.

Stable Value – Key Concepts

■ **Book Value Wrap Contract:**

- A stable value contract issued by insurance companies and/or banks that guarantees:
 - preservation of principal and accumulated interest
 - payment of an interest rate for a specified period of time
 - participant-initiated withdrawals and transfers at book value

■ **Benefit Responsiveness:**

The responsibility of the investment contracts to pay defined contribution plan benefits at book value.

■ **GICs (Guaranteed Investment Contract):**

A group annuity insurance contract that pays a specified rate of return for a specified period of time. This type of contract offers book value accounting, typically pays benefits to plan participants, and provides annuities upon request.

■ **Wrapped Assets:**

A term for a variety of stable value products which separate the invested portfolio from the benefit responsive contract. The assets backing the contract, usually high-grade securities, are owned by the plan and held in a trust account or custody account for the plan. The plan sponsor relies on the credit of the wrap issuer to support the book value guarantee.

■ **Blended Rate:**

The aggregate return of the book value investments in a stable value fund.

■ **Crediting Rate:**

The interest rate calculated for wrapped assets expressed as an “effective annual yield”. The formula reflects the portfolio’s current yield with an adjustment for amortization of the difference between the portfolio market and book value. The crediting rate may remain fixed for the term of the contract or may be reset at predetermined intervals.
