


Market Value Allocation - Asset Classes (Quarter over Quarter)


Market Value Allocation - Mutual Funds



This chart illustrates the percent of PCRA participant assets in each mutual fund category, as classified by Morningstar Inc., as a percentage of total PCRA long-term mutual fund assets. Net Asset Flow - All Investment Categories (3-month period ending 12/31/2016)


