










Net Flow - All Non-Cash Assets (3-Month Period Ending 9/30/2018)


Market Value Allocation - Mutual Funds (Quarter over Quarter)


Net Flow by Sector - Equities (3-Month Period Ending)

Market Value Allocation - ETF (Quarter over Quarter)


