




Net Flow - All Non-Cash Assets (3-Month Period Ending 6/30/2021)



#### Market Value Allocation - Mutual Funds (Quarter over Quarter)






#### Net Flow by Sector - Mutual Funds (3-Month Period Ending 6/30/2021)








