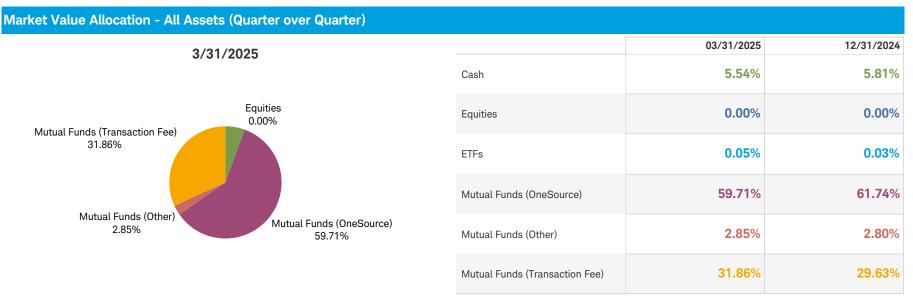

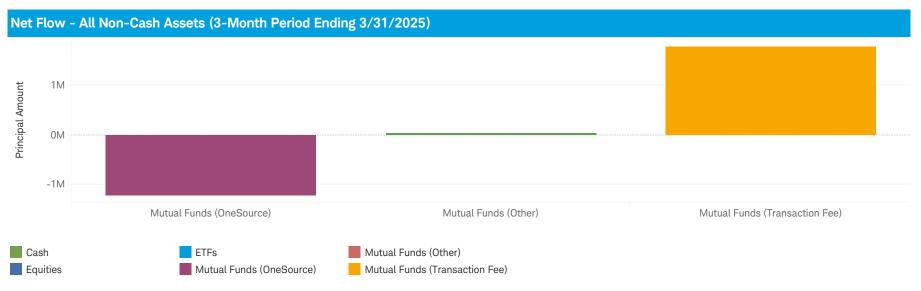

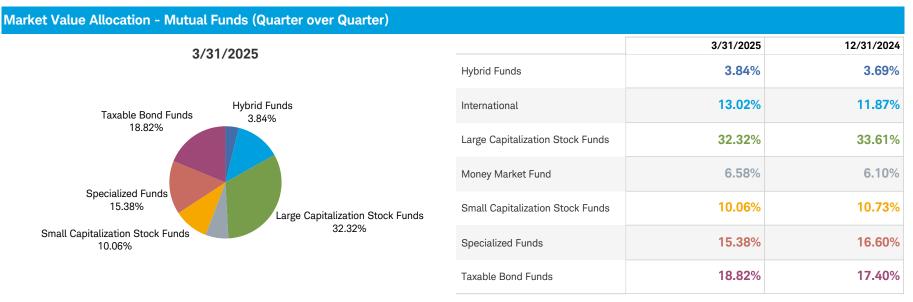

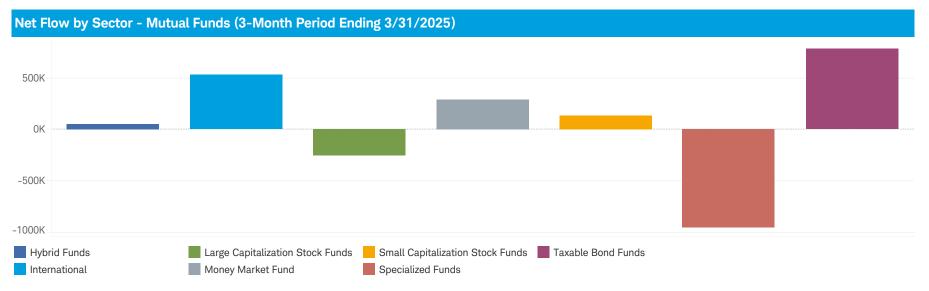


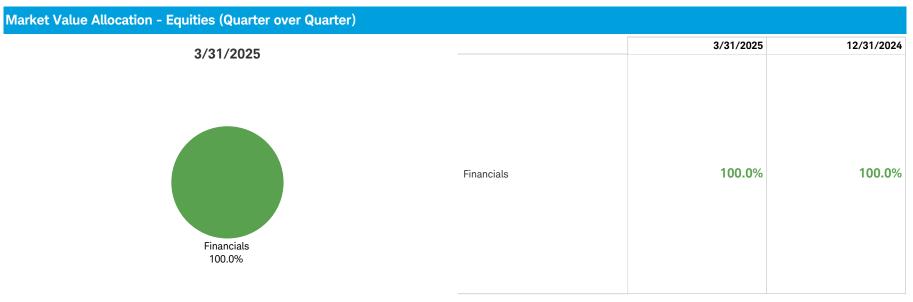

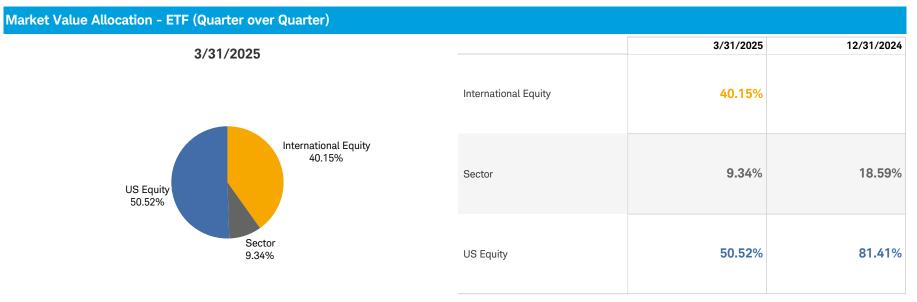

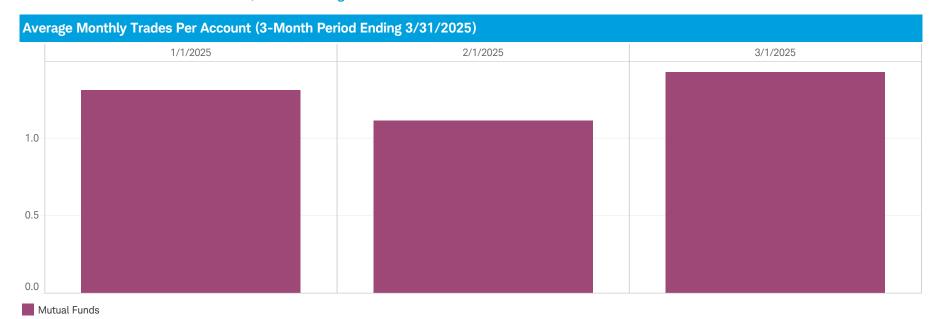

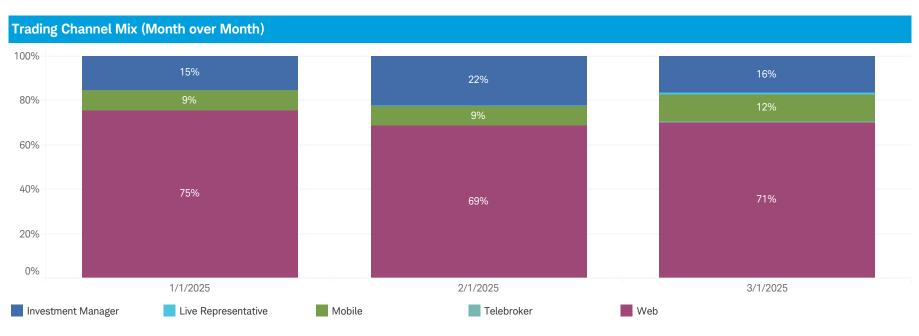
### Net Flow by Sector - Equities (3-Month Period Ending 3/31/2025)
