Plan assets grew by \$738.12 million (10.7%) from January 1, 2024 to December 31, 2024

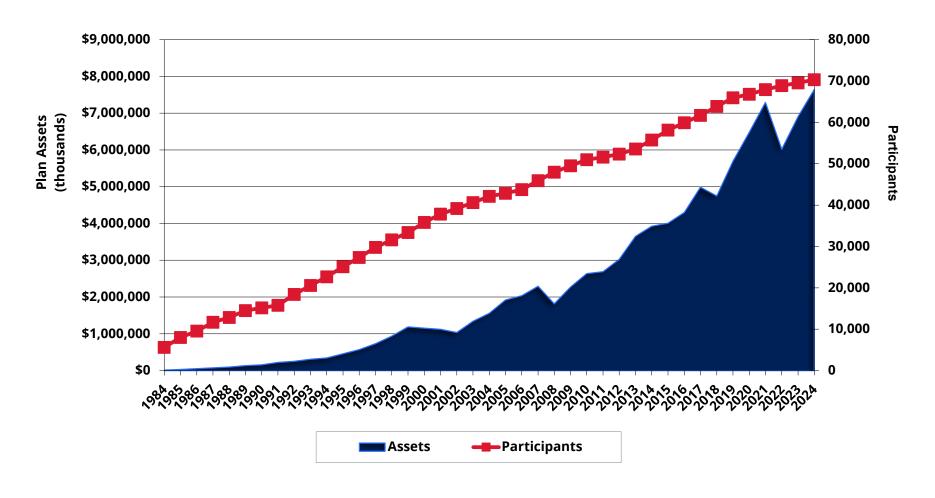

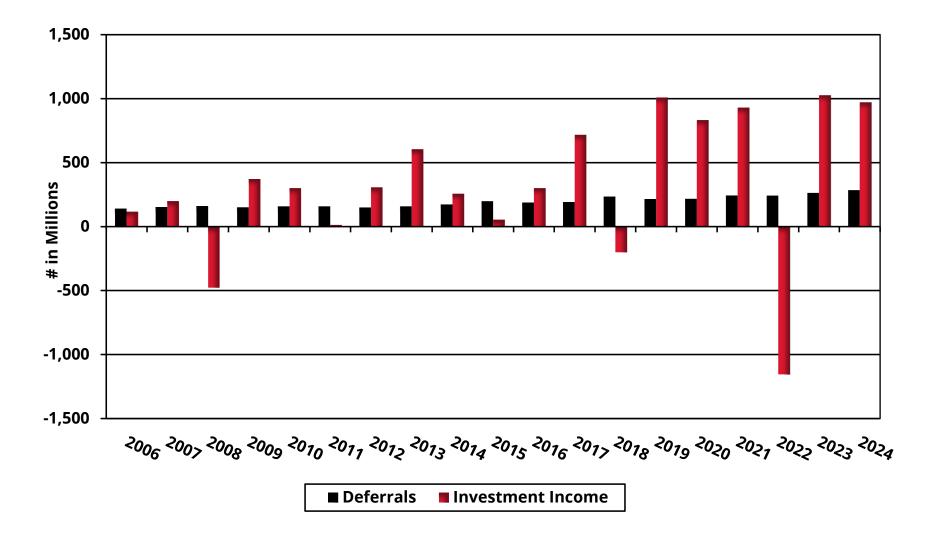

#### WDC Assets and Participation as of December 31, 2024



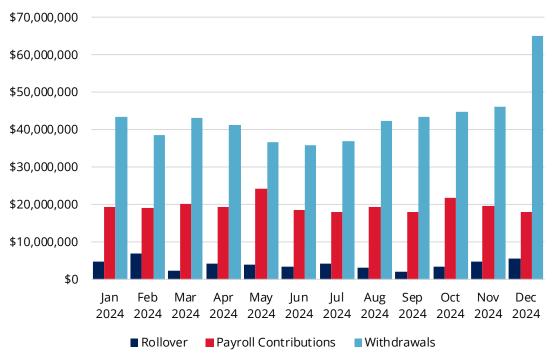

#### 2024 WDC Eligible and Overall Participant Population

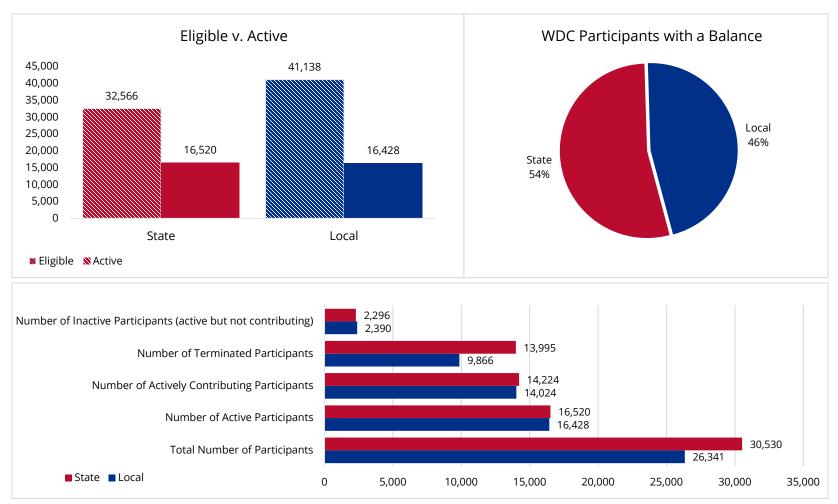

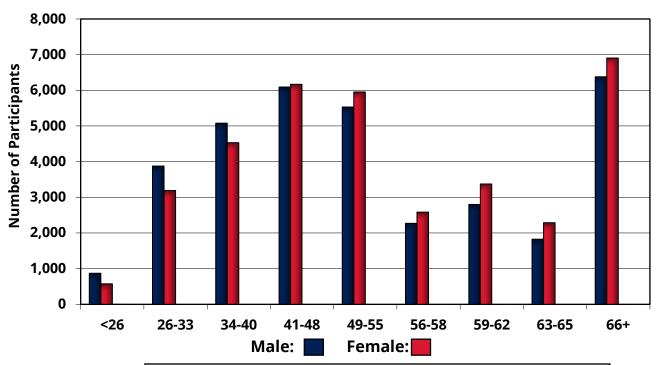
#### 2024 WDC Participant Population – 403b Market







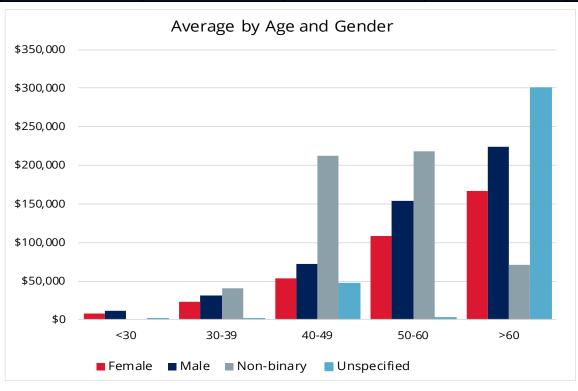

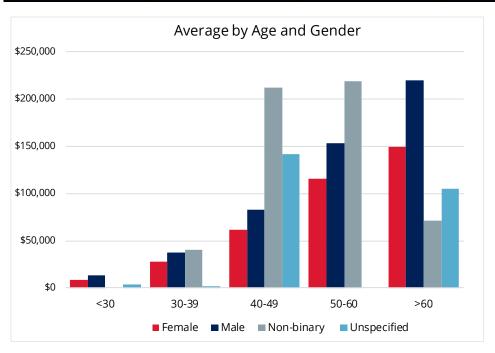

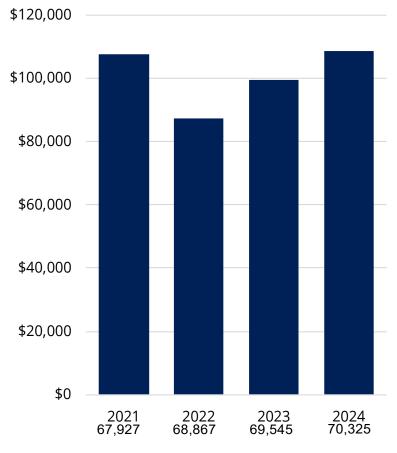

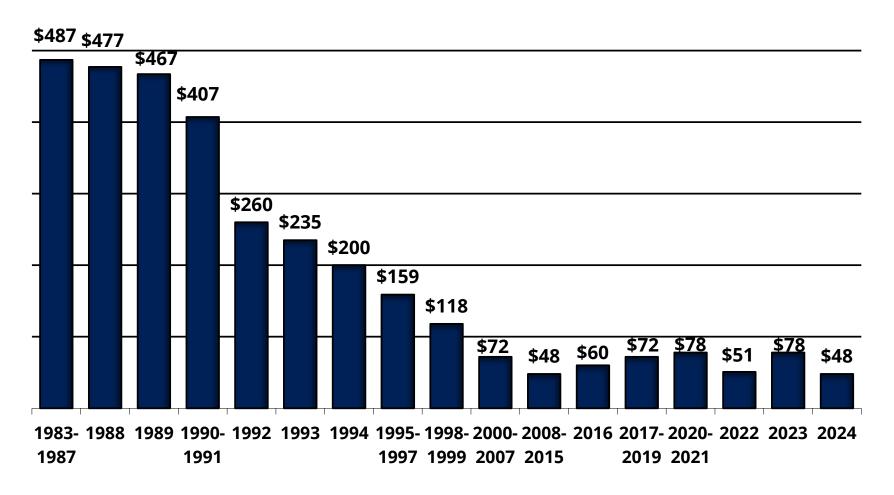

# of Participants with a Balance

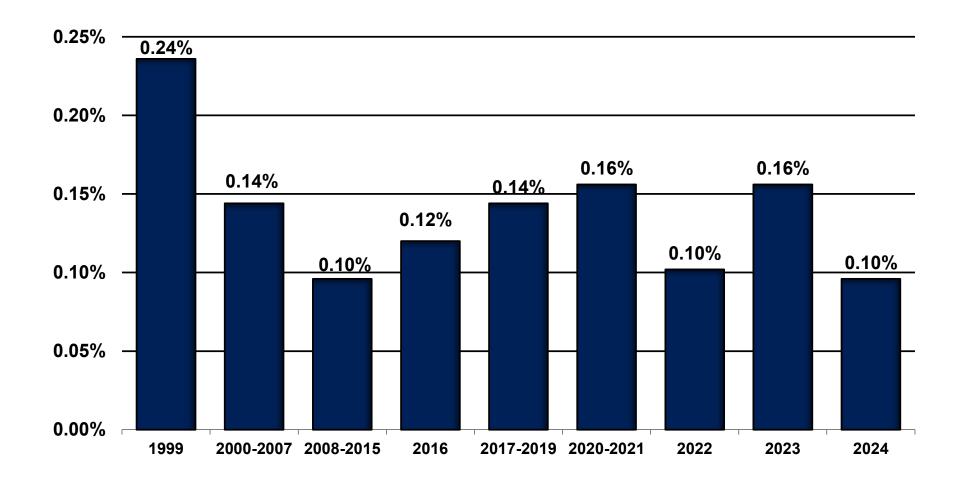


#### WDC Participant Annual Fee History

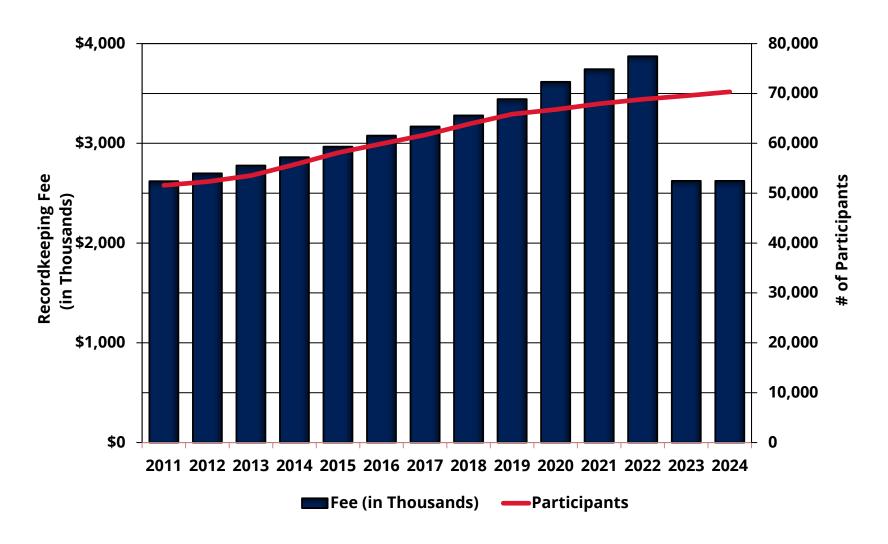

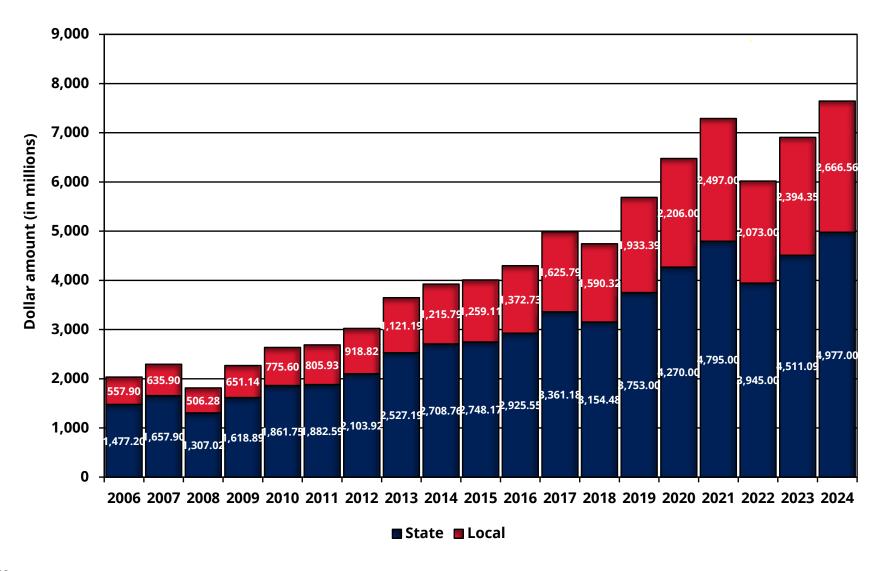

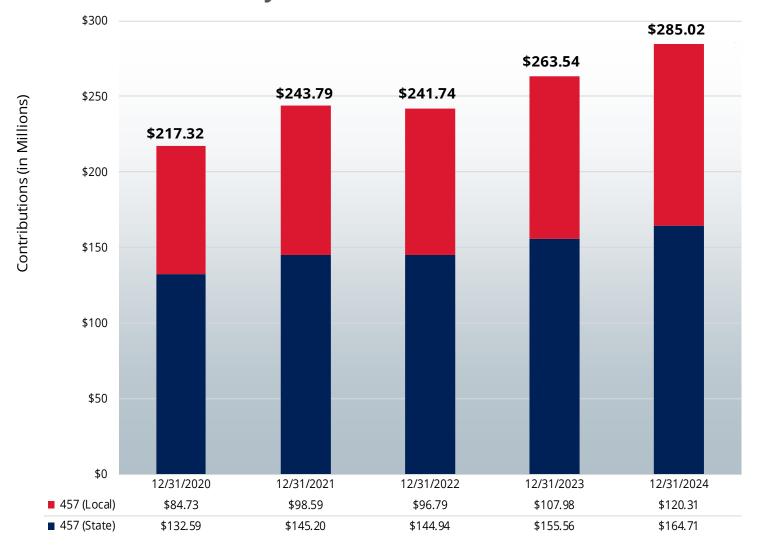
#### WDC Annual Recordkeeping Fee History

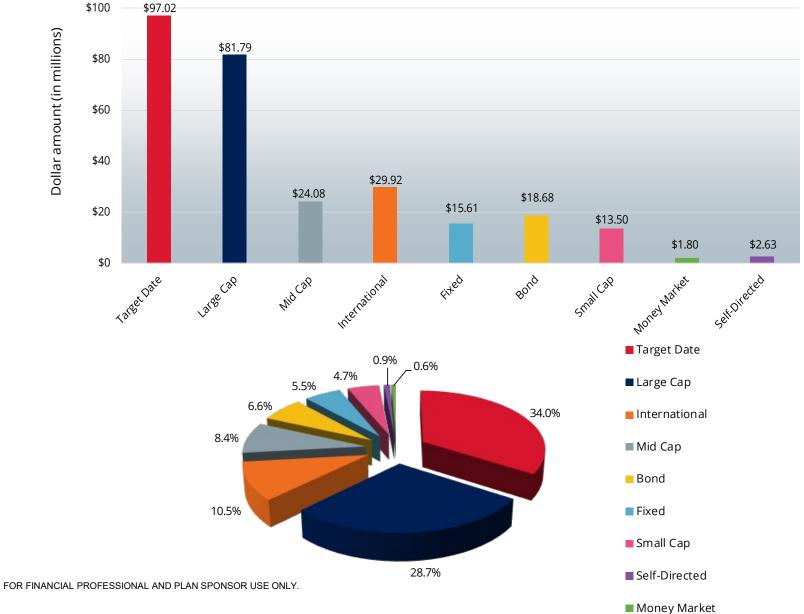
### Participant Deferrals by Asset Class 2017 vs. 2024

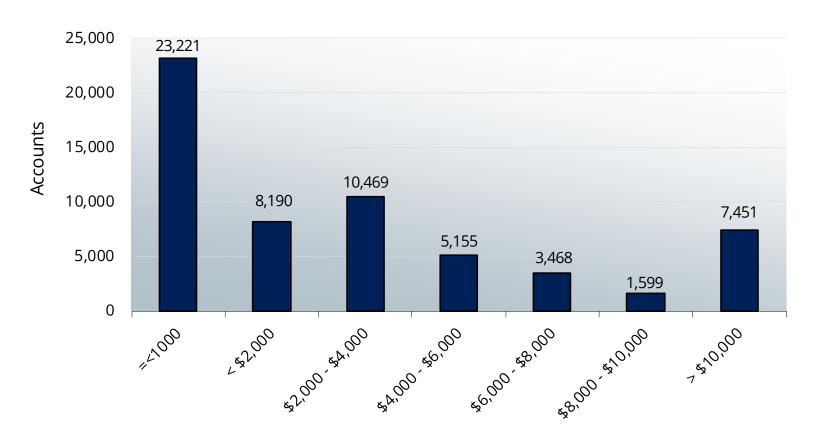

### Number of Accounts by Annual Regular Contributions

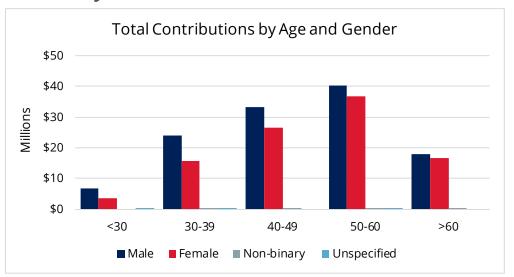


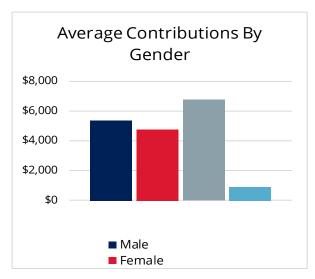

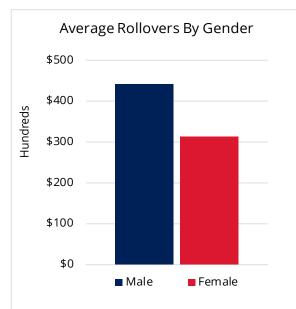
### Total Payroll Contributions from 1/1/2024 to 12/31/2024





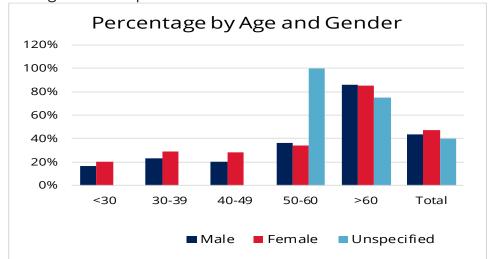
#### Total Rollover Contributions from 1/1/2024 to 12/31/2024

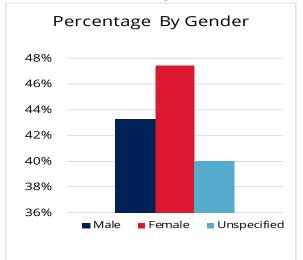




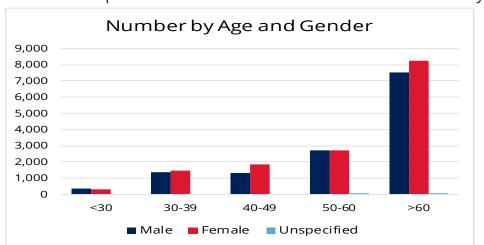

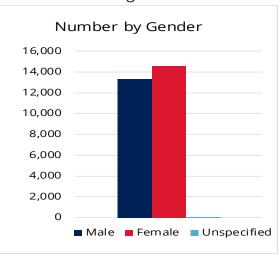
Percentage of Participants with an Account Balance and No Current Paycheck Contributions During the Period

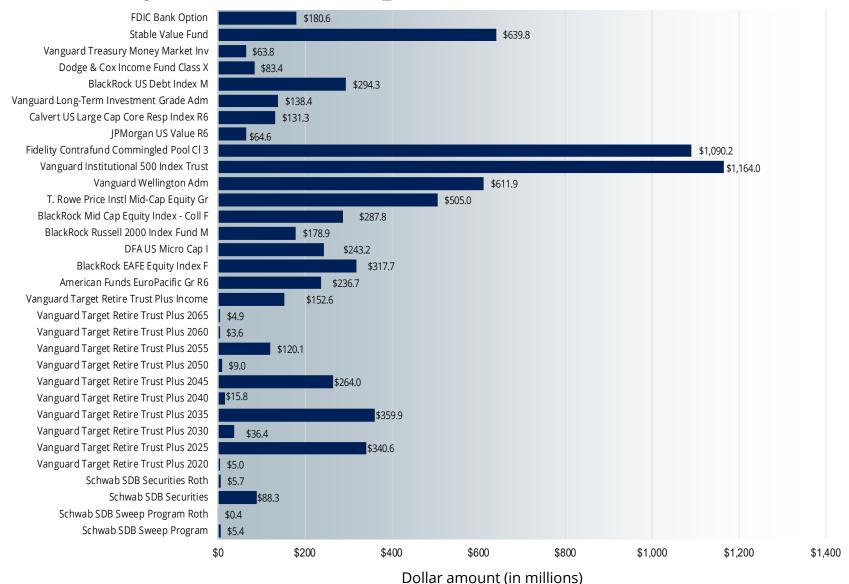

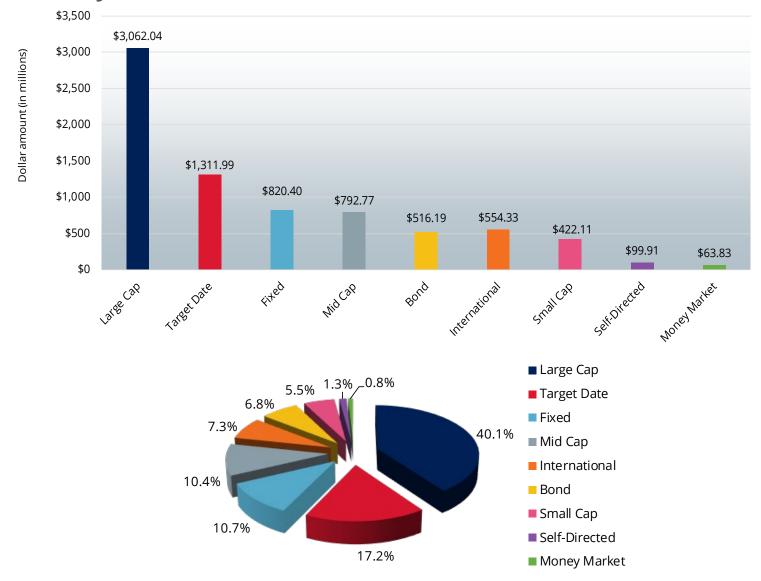

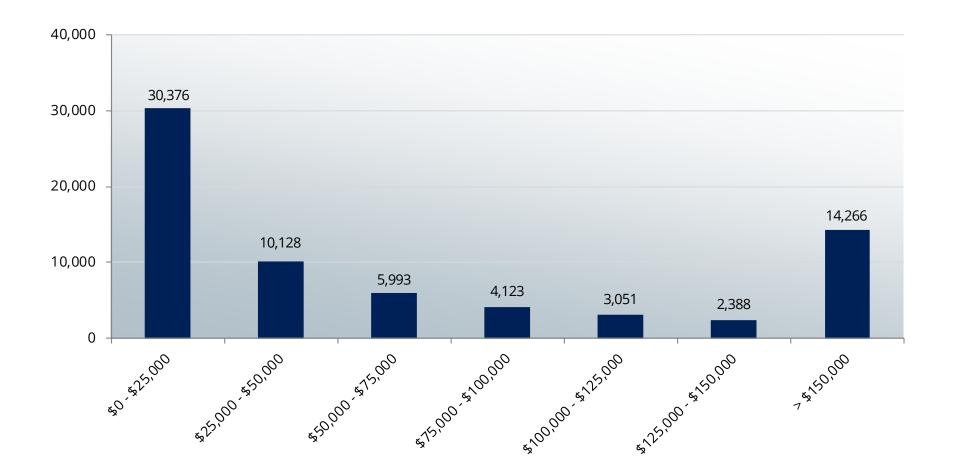
### Assets by Investment Option



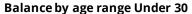

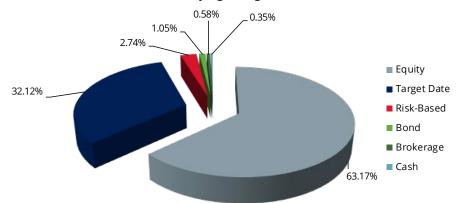


## Number of Accounts by Account Balance

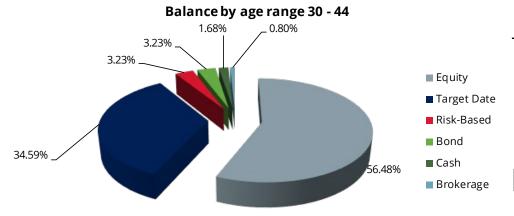


# Asset Allocation by Age (As of 12/31/2024)



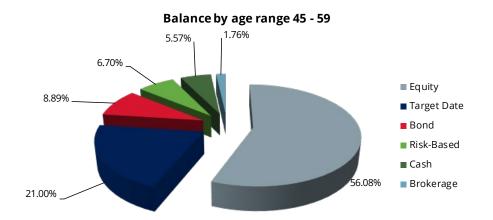

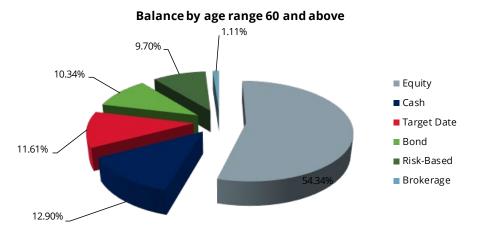

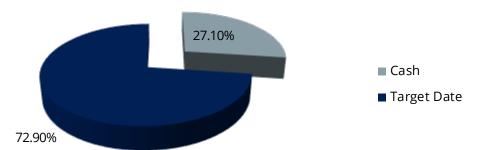

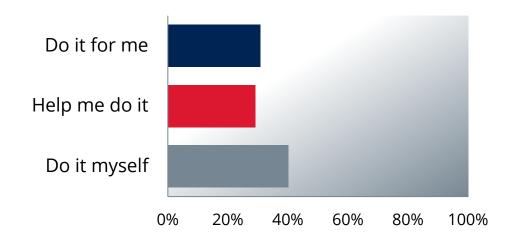

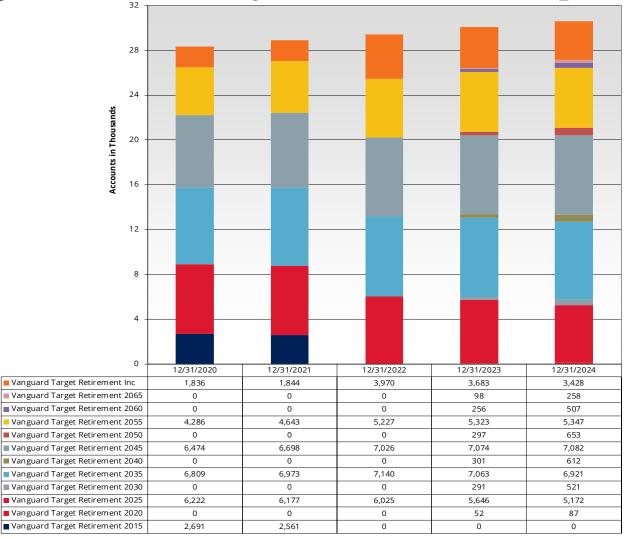

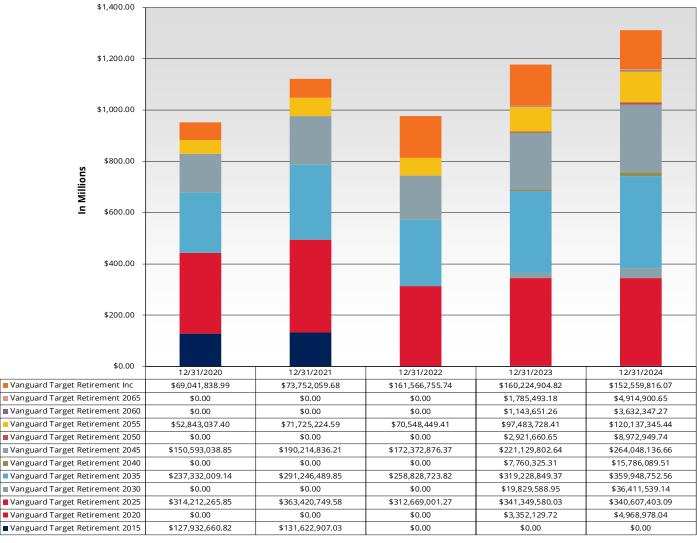

## Target Date Funds by Number of Participants



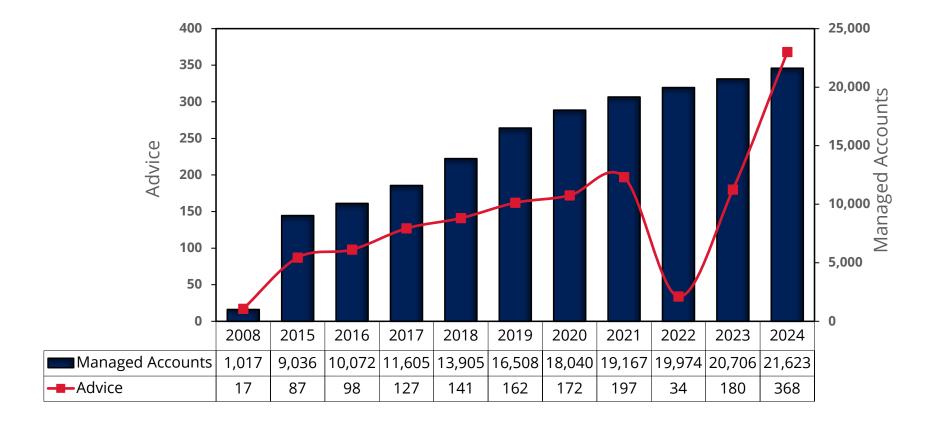

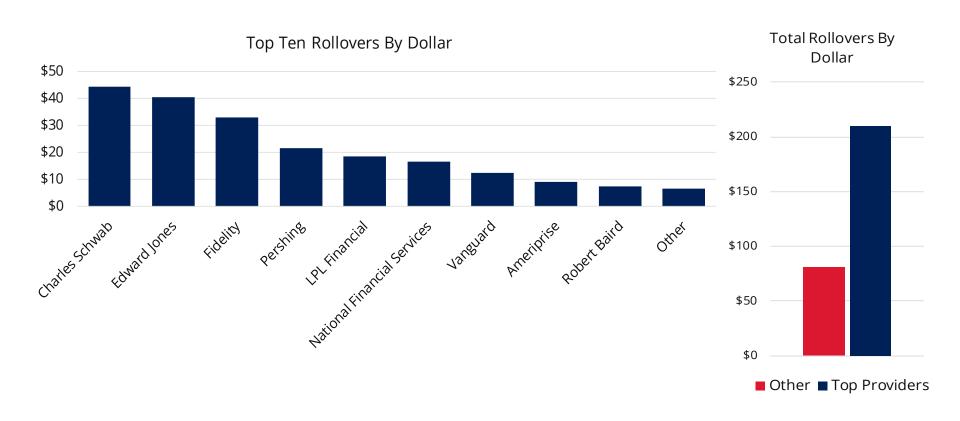
### Full Withdrawal Rollover Summary by Top Providers by Number of Participants



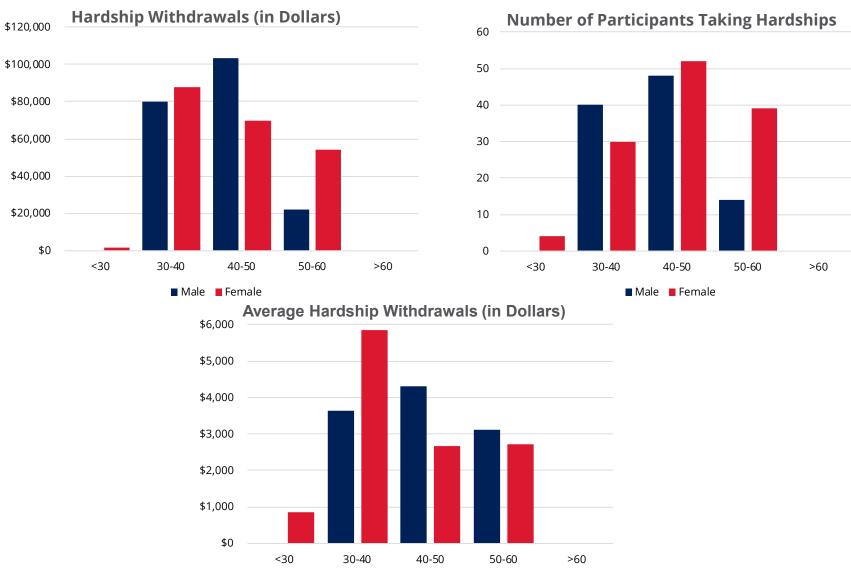

### Full Withdrawal Rollover Summary by Top Providers by Dollars



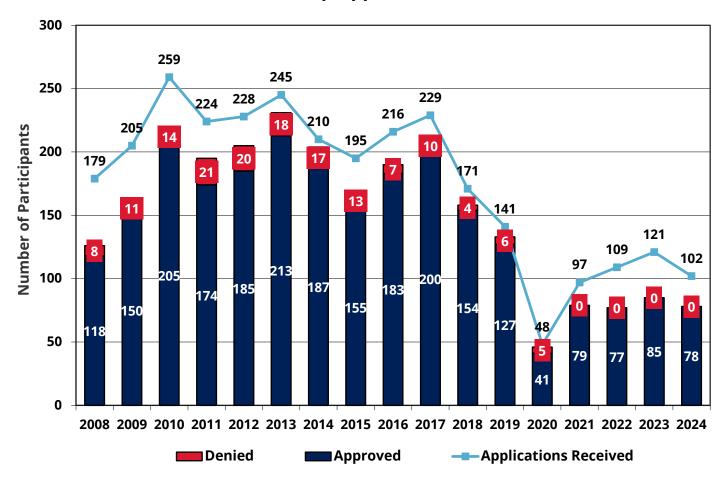

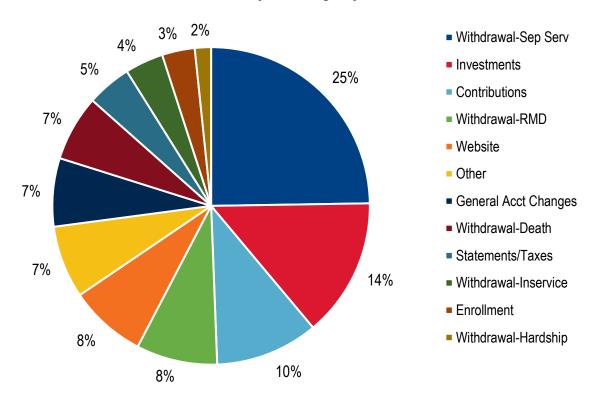
		Glossary
Web	Average Session Duration	The average amount of time (in seconds) all Web Users spent interacting with a website during a group of Sessions.
	Bounce Rate	The percentage of time a Session(s) begins and ends on the first page viewed, without any on-page interaction or additional pageview. Often considered a failure.
	Click	A non-unique count of interactions with a link, file download, or other on-page activity which does not change the page URL.
	Exit Rate	Viewed at the page level. The percentage of the time a Web User left a website from a specific page.
	New Web User	A unique device and browser pair which does not already have a Google Analytics cookie value assigned. A new User is also identified when an existing User uses a new browser, device, or enables "private browsing" mode.
	Pages/Session	The number of Pageviews divided by the number of Sessions.
	Pageview	A single view of a page, which most often involves a change to a browser URL. A Pageview is an instance of a page being loaded (or reloaded) in a browser. Pageviews is a metric defined as the total number of pages viewed.
	Returning Web User	A unique device and browser pair which already has a Google Analytics cookie value assigned.
	Sessions/Web User	The number of Sessions divided by the number of Unique Web Users.
	Unique Participants (Individuals)	Calculated using Individual ID + Plan ID (ga_id), this is a distinct count of both values tracked at least once in Google Analytics during a specific date range.
	Unique Web User (User, Visitor)	A single Device and Browser pair uniquely identified by a Google Analytics browser cookie. A Web User ID does not directly identify a single person if they utilize multiple devices (and are assigned multiple unique cookie values). A Web User can be unique and counted again ("new") in Google Analytics if the browser or device is changed, "private" mode is used, or cookies are deleted.
	Web Session (Visit)	A single visit to a website, which can include one or more Pageviews. A Session persists and is counted only once, up to 30 minutes after the last User interaction during the site Visit. By default, if a User is inactive for 30 minutes or more, new activity is attributed to a new Session. Users who leave our site and return within 30 minutes are counted as part of the original Session.
Арр	Screenview	A single view of an app screen, which most often involves a change to the interface. A Screenview is an instance of a new screen being loaded (or reloaded) on a device.
	Screenviews/Session	The number of Screenviews divided by the number of Sessions.
	Sessions/App User	The number of Sessions divided by the number of Unique App Users.
	Unique App User	A single Device with App installed, uniquely identified by a Google Analytics device cookie. This identifier typically does not reset unless an app is uninstalled and reinstalled, or if a new device is used.

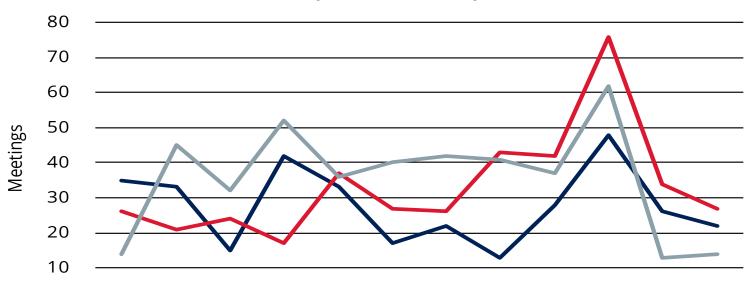

#### Contact Reason by Category



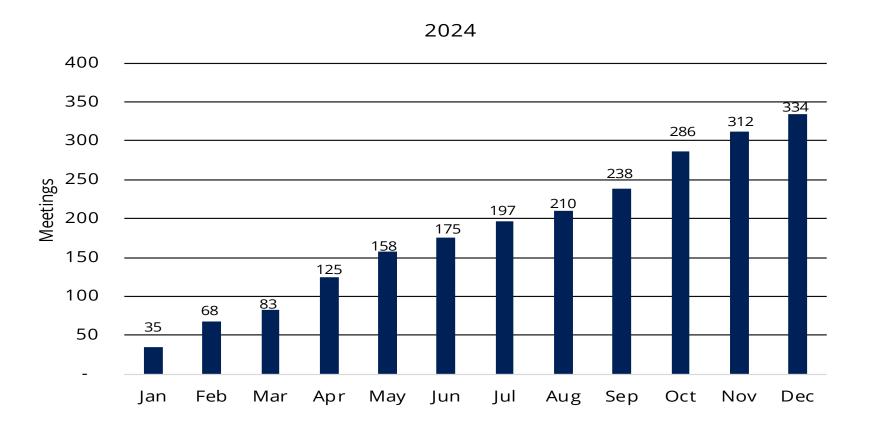

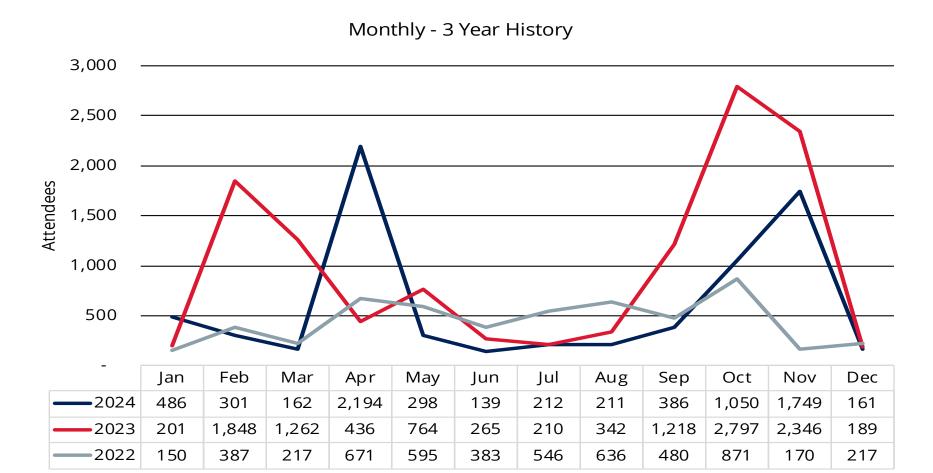

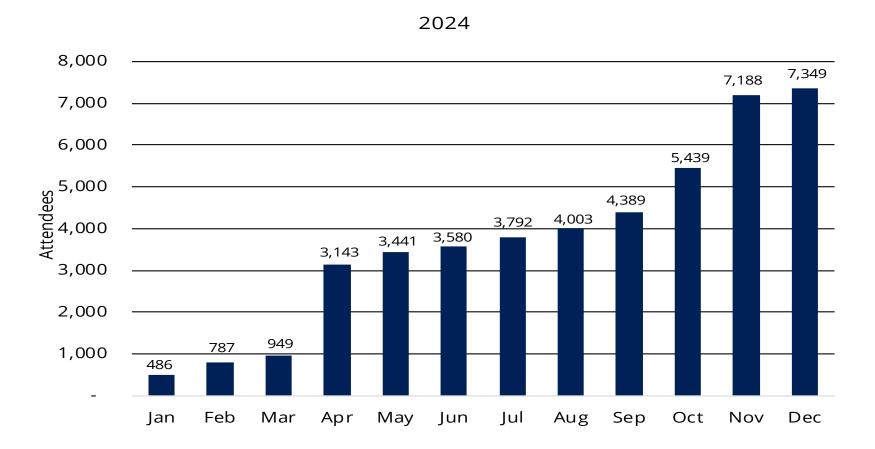

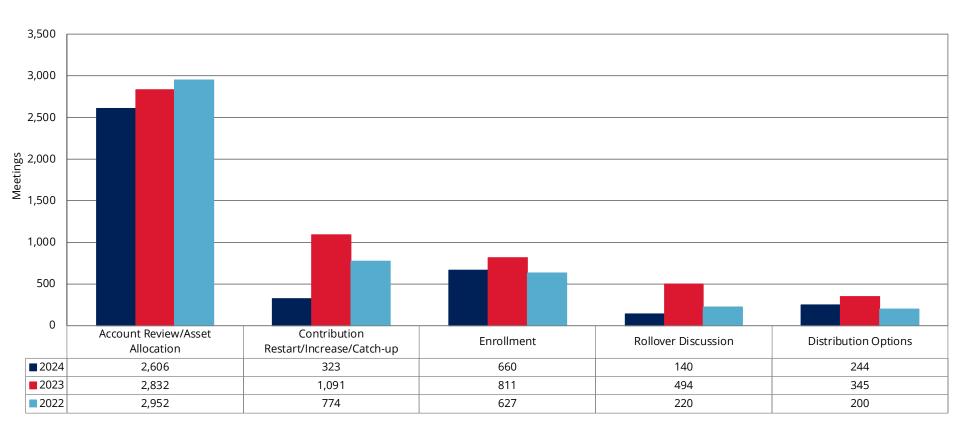
#### Number of Attendees at Group Meetings

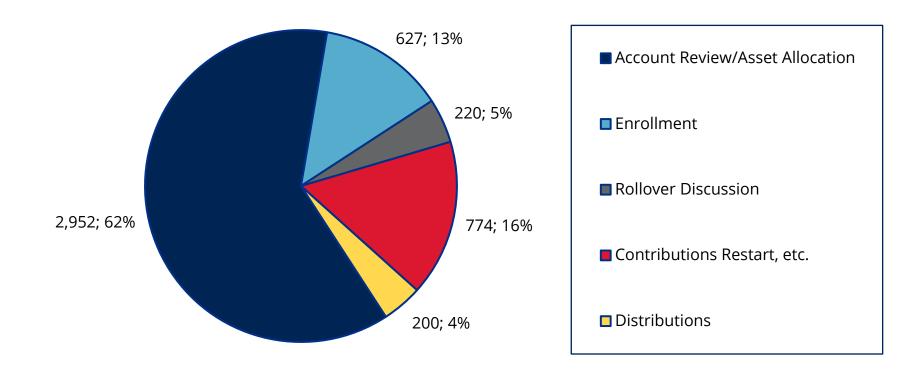


## Type of Individual Meetings



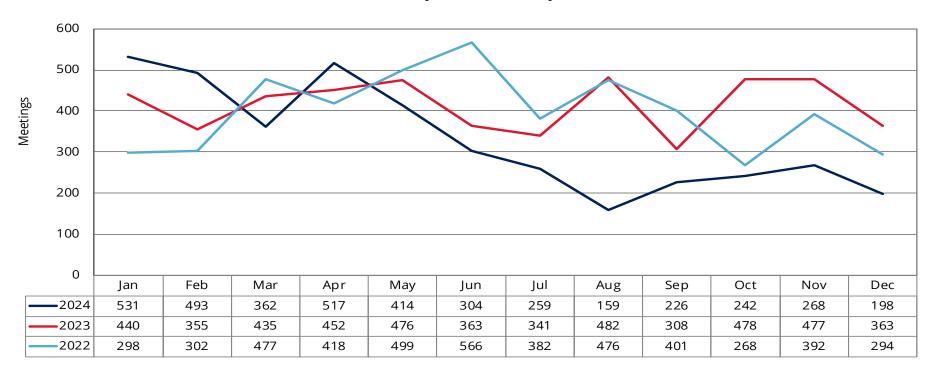

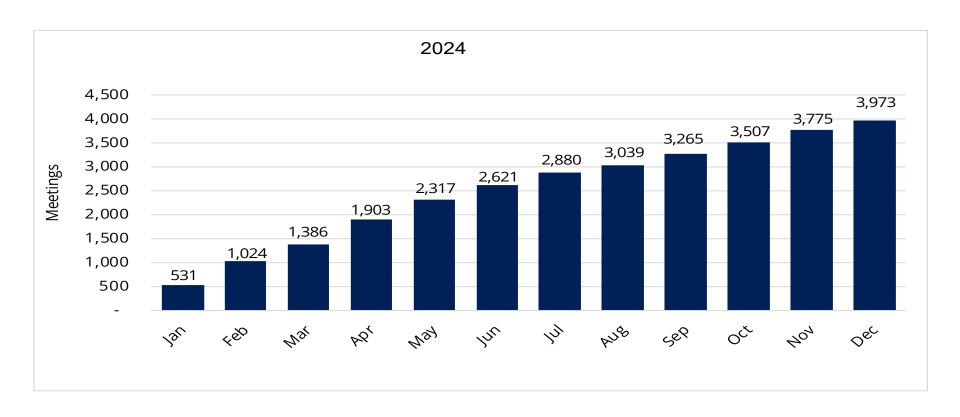


## **Individual Counseling Sessions**
