**SUBJECT:** 2009 Benefit Annuity Statistics

### This memo is for informational purposes only. No Board action is required.

Attached is the Wisconsin Retirement System (WRS) *Disability Annuity Statistics* for 2009. The report provides information on disability benefit annuity applications approved by the Boards throughout 2009.

#### 2009 DISABILITY ANNUITY HIGHLIGHTS

- The Department completed disability benefit estimates for 725 participants.
- § 40.63 Disability Retirement benefits were started for 175 participants.
- Duty Disability benefits were started for 23 participants.
- For the disability annuity benefits approved by both the Teachers Retirement Board and the Wisconsin Retirement Board, the most popular benefit option was "100% Continued to Named Survivor (Joint Survivor) with 180 Payments Guaranteed."

#### TEACHERS RETIREMENT BOARD SPECIFICS

- 94% of Teachers Retirement Board (TRB) disability applications were approved/deemed approved. Only 3% were cancelled/void/withdrawn/invalid, and 3% were denied.
- 55% of TRB disability annuities started were for females and 45% were for males.
- 28% of TRB disability applications were for participants aged 51-55, 23% were for participants aged 56-60, and 34% were for participants aged 61-65.
- 69% of TRB disability applications had one of three disabilities: Cancer (32%), Neurology (22%), and Mental Illness (15%).



#### WISCONSIN RETIREMENT BOARD SPECIFICS

- 88% of Wisconsin Retirement Board (WRB) disability applications were approved/deemed approved. Only 3% were denied and 9% were cancelled.
- 53% of WRB disability annuities started were for females and 47% were for males.
- 18% were for participants aged 46-50, 45% of WRB disability applications were for participants aged 51-55, and 29% were for participants aged 56-60.
- 60% of the WRB disability applications had one of three disabilities: Orthopedic (26%), Neurology (18%), and Cancer (16%).
