# Current Status of Active ETF Board Contracts and other Procurements

Consulting Actuary for the Wisconsin Retirement System and Related Programs Amendment #10 was signed by the ETF Secretary with Gabriel, Roeder, Smith & Company (GRS) for a sick leave conversion credit report for \$3,000.

Amendment #11 was signed by the ETF Secretary with GRS for on-going work regarding calculations connected to the benefit limitation of Internal Revenue Code Section 415(b). ETF is budgeting \$25,000 per fiscal year for this work.

# **Request for Proposals and Requests for Information**

## Federal Tax and Contract Counsel

ETF is drafting a Request for Proposals (RFP) for federal tax counsel for publication in Fall 2020 as approved by the Board at the June 2020 Board Meeting.

## Insurance Administration System

Vendor responses to the Request for Proposals (RFP) to replace insurance administration legacy systems were received on May 13, 2020 and are under review by an evaluation committee.

## Master Data Management (MDM) Software

A Request for Information (RFI) was released on May 4, 2020. ETF answered vendor questions until May 20, and vendor responses were due June 5, 2020. The information gathered from this RFI will be used to determine the procurement method for the best solution to meet master data management requirements for the modernization program.

#### Application Programming Interface (API) and Event Management (EM) Software

A Request for Information (RFI) was released on May 11, 2020, and vendor responses were due June 12, 2020. The information gathered from this RFI will be used to determine the procurement method for the best solution to meet data integration requirements for the modernization program.

#### Professional Staffing Services

The goal of the RFP is to award and negotiate a contract by the end of September for hiring contractors for non-IT functions such as benefits specialists and accountants. The evaluation period has concluded. A Notice of Intent to Award is being prepared for release in late August. Additional information can be shared on the winning vendors after the Notice of Intent to Award is published.

# **Program Appropriation Charges**

Information on non-benefit disbursements charged to ETF's benefit program appropriations for the one-year period ending on June 30, 2020 are reported below. Reported costs include third-party administration (TPA) expenses, as well as data warehouse and analytical service expenses. Costs reported do not include:

- indirect expenses that are charged to ETF's operational appropriations, such as: staff salaries and fringe benefits, travel/training, rent, contract staff, and other contractual services; or
- benefit disbursements made to participants.

#### Administrative Appropriation Charges

Information on ETF administrative expenses for the one-year period ending on June 30, 2020 are reported below. Over the last 12 months, ETF spent \$48.7 million on administrative expenses. In comparison, total administrative expenses increased year-to-year by \$4.5 million from \$44.2 million to \$48.7 million. This increase can be partly attributed to additional contractual service costs resulting from IT modernization efforts. Excluding salary and fringe benefit-related costs, contractual services is ETF's largest expense category.
