Subject: Summary of 2023 ETF Board WRS Annuitant Election Results

ETF requests the ETF Board Election Certification Committee certify Mr. William Ford as the successful candidate for the WRS annuitant member seat under Wis. Stat. § 15.16 (1)(d) with the term expiring May 1, 2027.

Attached is the report from the University of Wisconsin Survey Center regarding the results of the 2023 Employee Trust Funds Board Election-WRS annuitant member seat. The report summarizes the number of ballots sent, the votes received and the number of invalid or questionable ballots. Of the 232,633 ballots distributed, 51,478 were received by the deadline with 50,285 votes cast (21.6%). The candidates' vote totals are as follows:

William Ford	29,041
Mark Williams Walters	11,557
Norman A Cummings	5,736
Richard J Brunner	3,951

Of the 51,478 ballots received, 2% were determined to be invalid or questionable ballots, which is not unusual. However, the same lack of diversity concerns from 2019 were again prevalent. Of the 194 "no vote cast" ballots, 39 made a diversity comment, in addition to several more diversity comments on the ballots of those annuitants who also voted.

As you are aware, the WRS annuitant seat plus the other board seats are self-nominating. However, ETF will continue to encourage and promote greater candidate diversity on the boards for future elections.
