EXECUTIVE COMMITTEE QUARTERLY HUMAN RESOURCES REPORT DECEMBER 2012

- The Department continued its partnership with the Lincoln Elementary School with staff serving as mentors or tutors to students during their lunch hours.
- The Department of Revenue is partnering with the ETF AA Committee by inviting ETF employees to activities their agency is hosting such as "Experience the Taste of DOR" which was held on October 17, 2012, in the Events Room at the Rimrock Road facility.
- The AA Committee wrapped up its school supply drive to help children at Lincoln Elementary School by providing school supplies and cash donated by ETF employees.
- The AA Committee kicked off a drive to provide hats, mittens and scarves to children at Lincoln School with an article in the November *Trusty News*.

- The Social Committee sponsored a pizza day and Halloween costume contest in October.

PARTNERS IN GIVING

- ETF employees were invited to attend Partners in Giving Charity Day events with invited speakers at both the Badger Road and Rimrock locations in October.
- The campaign chairs worked with staff to raise funds by conducting a media sale, pizza day, pumpkin carving contest, bake sale, and a live and silent auction among other tasty activities that provided opportunities to give donations.
- About 56% of ETF employees have pledged and ETF employees have donated \$22,630 to date through pledges and special events. The campaign ends on November 30, 2012.

MISCELLANEOUS

- The Health and Safety Committee sponsored a seasonal flu shot clinic and blood drive in October and November.
- The Employee Assistance Program (EAP) distributed monthly employee and supervisor newsletters and provided information to all staff on topics such as effects of insufficient sleep, signs and symptoms of abuse, exercise tips for healthier living, and simple ways to prevent disease. Information targeted specifically at supervisors and managers included topics such as motivation techniques, 8 tips for embracing change, and negotiating workplace conflict.
- The EAP offered a series of Wellness Webinars in October for staff and supervisors on topics such as Maximizing Employee Productivity, Stress & Its Impact on Your Health, and How to Become a More Resilient Person.
- The ETF Wellness Workgroup continued to publish its monthly issues of ETF Wellness Now! and promoted consumption of fruits and veggies, benefits of yoga, safe driving, and National Breast Cancer Awareness Month. The ETF Wellness Workgroup also promoted several area walks, runs, and bike rides, including the Trek Breast Cancer Awareness Ride to help support the Breast Cancer Research Foundation.
- Moved and reconfigured several work units within and between Rimrock and Badger Road buildings to realign functions and staff more appropriately and accommodate additional space needs.
