- ETF's AA/EEO Plan was approved by Secretary Conlin and the Office of State Employment Relations. The new plan will be effective from July 1, 2014 through June 30, 2017.
- The Department continued its partnership with Lincoln Elementary School, with staff volunteering to tutor students during their lunch hours. ETF sponsored a very successful school supply drive for Lincoln School students. Very generous donations were made by past and present ETF employees.
- The Affirmative Action Committee (AAC) formed a subcommittee to draft an application for the 2014 State Council on Affirmative Action Diversity Award. The application was submitted late August.
- Kristen Schipper was appointed to the AAC to replace Bryan Foster.
- Emma Minkoff was hired as a Communications Specialist intern for the Office of Communications through the Summer Affirmative Action Internship Program.
- ETF sponsored two interns through the PEOPLE Program Summer Internship program. One individual worked in the Project Management Office and the other in Division of Retirement Services, Benefits Initiation Section. The program exposes lowincome/minority high school students to a professional business setting where they learn important job skills.
- ETF formed a partnership with the Urban League of Greater Madison, located near the Badger Road building on Park Street. ETF was joined by representatives from other agencies in providing a job fair and career development session in late June for members of the community interested in learning about employment with the State of Wisconsin.
- ETF sponsored a workshop on Respectful Workplace, Harassment and Bullying provided by Bob Gregg of Boardman & Clark Law Firm. All ETF employees, LTEs and long-term contractors were encouraged to attend one of the four sessions provided.

- The ETF Wellness Workgroup organized the summer picnic for all staff held on August 6 in the courtyard at Badger Road.
- Excerpts of letters we receive complimenting staff are posted on the ETF Community.

The award was presented to Anne in July by Secretary Conlin and recognizes ETF employees who demonstrate a commitment to those we serve by providing excellent customer service through creativity, innovation, warmth, friendliness, individual pride and agency spirit.
