2014-2017 AA/EQUAL EMPLOYMENT OPPORTUNITY (EEO) PLAN

- ETF's AA/EEO Plan is effective July 1, 2014 through June 30, 2017. Strategies and projects to meet the goals contained in the AA/EEO plan have begun. Several are highlighted in the bullet points below.
- ETF's Affirmative Action Committee (AAC) sponsored Transgender Awareness Training in October.
- ETF's AAC organized the annual school supply drive to further our partnership with Lincoln Elementary School. This effort provides much-needed school supplies for the year.
- ETF was awarded the Diversity Award sponsored by the State Council on Affirmative Action. The application was based on the efforts of the EMPOWER Campaign, which aims to improve retirement financial security among women public employees.
- The Empower campaign also received the 2015 Innovator Award from the Pension & Investments magazine, a leading trade publication. As founders of the program, Tarna Hunter and Shelly Schueller accepted the award on behalf of ETF at an annual conference in San Francisco.
- The AAC, in conjunction with the ETF Human Resources Team, participated in a Dane County Job Fair in September. The goal was to increase the diversity of ETF job applicant pools.
- The AAC donated \$300 on behalf of ETF employees to the Leader Dogs for the Blind and received a very thoughtful acknowledgement of the donation from the organization.
- ETF launched a "Mittens for School" campaign to provide hats, mittens and scarves to the students at Lincoln Elementary School.

EMPLOYEE RECOGNITION/APPRECIATION

- ETF conducted an all staff Town Hall meeting held in September with the theme of "We Dare Because We Care." Each office and division provided an entertaining lookback at the accomplishments of the past year and goals for the future. In addition, the keynote speaker, Michael Perry, provided a motivating, humorous talk covering among many other topics, how ETF's purpose reaches populations all across Wisconsin and beyond including his family.

- Diane Vultaggio was recognized in September at her retirement party for over 41 years
 of service to ETF. Reflections of Diane's accomplishments were shared at an open
 house with her ETF colleagues and family members.
