EXECUTIVE COMMITTEE QUARTERLY HUMAN RESOURCES REPORT December 2017

- In October the IDEA Committee sponsored and promoted a Lunch & Learn session titled "[In]visible Disability". The IDEA committee chair, Laura Ogle, gave an insightful presentation about the visibility and invisibility of disability, and how it applies to the workplace. A total of 9 ETF staff were in attendance.
- A total of 10 Thoughtful Thursday events have been held to date. This informal dropin lunchtime gathering, hosted by a representative of the IDEA committee on the 1st and 3rd Thursdays of the month, has been well received and has fostered interaction and camaraderie among staff.
- The AA Officer and IDEA Chair restructured the IDEA committee to include two
 subcommittees on inclusivity and diversity to focus more on social activities and on
 education on diversity and AA topics. The committee membership will increase from
 the current seven members to nine. The purpose of the restructuring will be to
 establish specific expectations for committee members to accomplish its goals in a
 more effective and efficient fashion.
- The IDEA committee in conjunction with the Department of Revenue Diversity Committee jointly hosted a Cultural Potluck in November. Staff prepared ethnic dishes to share; proceeds were donated to the Partners in Giving campaign.

- Excerpts and letters we receive complimenting staff are posted in *ETF Community*.
- ETF staff attended an ETF Town Hall in September. The theme, "Making a Difference," focused on how ETF staff make a difference to our members, employers, community and each other.
- ETF staff may purchase Microsoft Office 2016 software for their home computers at a significantly reduced price.
- For Veterans Day ETF recognized staff who served in the military, through an *ETF Community* article and on Twitter.

PARTNERS IN GIVING

 Several activities were hosted at both ETF locations to support the Partners in Giving campaign. Some of those activities included a cultural potluck, bake sale, chili/curry cook-off/costume contest, coin wars, sports gear day and silent auction. The goal for ETF is to raise \$35,000 and have a 57% participation rate by the close of the campaign.

MISCELLANEOUS

- The ETF Health and Safety Committee sponsored an American Red Cross blood drive in September.
- The ETF Health and Safety Committee sponsored two flu shot clinics.
- The Wellness Workgroup sponsored activities for staff, including on-site chair massages, weekly yoga and posted helpful articles in *ETF Community* on topics such as Understanding Health Values and The Truth About Addiction.
- The Wellness Workgroup wrapped up another successful season with the Community Supported Agriculture (CSA) program. This program allows ETF employees to receive fresh vegetables locally grown on a weekly basis during the growing season.
- The Wellness Workgroup supported the Great American Smokeout campaign via an *ETF Community* article highlighting tips for supporting those trying to stop smoking.
