#### **GOVERNANCE MATTERS**

#### Board Agenda Review

Mr. Voelker mentioned that the December 14, 2023, Audit Committee Meeting will now be completely virtual for operational reasons. The Committee discussed the importance of board members appearing in person at meetings. The Committee asked staff to review the Governance Manual to determine what policies are in place related to board member attendance and to bring back the information to a future Committee meeting for discussion.

Mr. Voelker reviewed the agenda for the December 14, 2023, ETF Board Meeting. There are a variety of action items including:

- 1) Approval on a contract extension for current oversight vendor (Segal) of the Insurance Administration System (IAS).
- 2) Approval of the contract for the new Pension Administration System (PAS) oversight vendor, plus delegation of authority to sign the contract and any amendments/extensions.
- 3) Approval to solicit proposals for actuarial audit services for several benefit programs.

## **OBJECTIVES AND ACCOMPLISHMENTS**

## Executive Committee Accomplishments Report: September–November 2023

Ms. Eckes discussed the "Executive Committee Accomplishments Report: September–November 2023" (Ref. EXC | 12.13.23 | 5A) and provided insight on ETF's progress meeting transformation journey challenges while performing necessary day-to-day work.

Specifically, this past quarter the agency was focused on building our resource capacity, staying focused on enhancing our information security and implementing the insurance administration system, and completing open enrollment. A key milestone is at the end of January, when an initial go-no-go decision to go live in June 2024 is needed for IAS. This will entail a discussion of risks, contingencies, and alternative dates, if necessary.

This year's IYC enrollment saw a decrease in member inquiries. Our average speed of answer this year was 2 minutes 48 seconds. Last year it surpassed a 10-minute wait time, largely because WEA Trust, affecting over 50,000 members, exited the health insurance program.

#### Other highlights include:

- Implementing law changes associated with Jailers, onboarding City of Milwaukee employers, and implementing Secure 2.0.
- Discussing potential initiatives with the Group Insurance Board that focus on program sustainability.
- Health insurance costs continue to increase, and our reserve balances are depleting.
- Receiving clean Legislative Audit Bureau audit opinions for our standalone financial statements that are sent to our employers for them to incorporate into their financial reporting prior to year-end.

# Executive Committee Quarterly Human Resources Report: December 2023

Ms. Henning provided an update on current vacancies and recent hires that was included as part of the "Executive Committee Quarterly Human Resources Report: December 2023" (Ref. EXC | 12.13.23 | 6A). She mentioned that the agency's Equity and Inclusion Plan for 2024-2026 was submitted to the Division of Personnel Management with initiatives focusing on a mentoring program and continuation of a

Staff Network Group on diversity, equity, and belonging. In addition, ETF's mandatory training completion rate is 99% for all staff. Examples of mandatory training to complete are IT security, privacy, public records, and respectful workforce.

- A message from the ETF Board Chair, Bill Ford
- Secretary Voelker's overview of ETF's modernization/transformation journey

- A keynote speaker highlighting how to find bright spots in daily work and life interactions
- Recognition of one contractor and one permanent employee as recipients of the ETF Excellence Awards.
