The attached table outlines board authority for each of the benefit programs ETF administers. The responsibility for the administration of the separate benefit programs is enumerated in Chapter 40 of Wis. Stats. The attached table was originally prepared in response to a request made at the June 25, 2015 Joint Meeting of the Retirement Boards. Staff will modify the table when there are vendor or other notable changes.

This memo serves as a quick reference guide to the designated authority for each benefit program. Included is the business area within ETF that has administrative responsibility, and, if applicable, the third-party administrator (TPA) that ETF contracts with to administer the program.
