Subject: Alternate Health Plan Qualifications for 2010

Staff recommends that the Board accept the attached qualification recommendations.

Background

Every year the Group Insurance Board (Board) takes formal action on "qualifying" alternate plans for each county in the state. The State Maintenance Plan (SMP) is offered in counties in which there is no qualified tier-1 health plan and a non-qualified health plan is excluded from the 105% premium contribution formula for local governments. Each health plan was notified of our recommendation to the Board and given the opportunity to correct any errors in reporting the provider counts that serve as the basis for the qualification decision. See Attachment A for more information on alternative health plan qualification criteria.

Health Plan Changes

HealthPartners, a Minnesota-based health plan with 700,000 members, is new to the program in 2010. In addition to offering a broad network in Minnesota, HealthPartners will be available in Pierce, Polk, and St. Croix Counties because it meets the minimum provider requirements to be qualified. As a new health plan to our program, HealthPartners will not be used in qualification formulas to determine contribution rates or SMP placement in the state or local programs.

Tiering Change from 2009 to 2010

Anthem Blue Northwest is currently a tier-2 health plan and will be a tier-1 plan for 2010. As a result of this change, all alternate health plans will participate at the tier-1 level for 2010.

Qualification and Non-Qualification Changes

There were a total of 44 changes in qualification and non-qualification status in the state program from 2009, of which 28 resulted in changes in qualification for 2010. There were 15 qualification "gains" and 13 qualification "losses". Table 1 (attached) presents a listing of these changes in status, using the following categories:

- Newly-listed and qualified in 2010; Number (N) =3
- Newly-listed in 2010 (as a non-qualified health plan); N=9

- Newly-qualified in 2010 (listed as non-qualified in 2009); N=12
- Lost qualification status for 2010 (listed and qualified in 2009); N=13
 - ✓ In 11 cases the health plan will remain qualified in the county for the local program.
- Lost listing status in 2010 (listed as non-qualified in 2009); N=7

There are 176 instances of a health plan remaining qualified and listed and 72 remaining non-qualified. See Attachment B for a 2009 and 2010 map of qualified health plans by county.

Table 2 (attached) presents a complete listing of qualification and service areas by health plan and Table 3 (attached) presents health plan qualification and non-qualification status by county. Notable changes by select health plan from 2009 to 2010 include:

Anthem Blue Northeast will lose qualification for state (but not for local) in Green Lake, Marinette, Waupun, and Waushara Counties, due to losing contracts with dentists.

Anthem Blue Northwest will newly qualify in Pierce County as a result of adding the River Falls Hospital and Medical Center in River Falls. Anthem Blue Northwest will lose qualification for state (but not for local) in Ashland, Douglas, Polk, St. Croix, and Washburn Counties, due to losing contracts with dentists.

Arise Health Plan will newly qualify in Fond du Lac and Waupaca Counties. In Fond du Lac, Arise contracted with St. Agnes Hospital. In Waupaca County, Arise is adding two chiropractors to become qualified in the county. Additionally, Arise has added the Waupun Memorial Hospital in Dodge County.

GHC-SCW added the Access Community Health Center Wingra Clinic effective July 1, 2009, and will add the Access Community Health Center on September 1, 2009. These clinics will continue to be available in 2010.

Gundersen Lutheran Health Plan will newly qualify in Chippewa County as a result of adding St. Joseph's Hospital in Chippewa Falls.

Health Tradition will newly qualify in Buffalo, Dunn, and Sauk Counties, adding providers in Pepin County to its network.

HealthPartners will enter the program meeting the minimum provider requirements for qualification in Pierce, Polk and St. Croix Counties. In addition to providing a broad network of providers in Minnesota such as the Abbott, Allina Medical Group, Cambridge Medical Center, HealthPartners and the Stillwater Medical Group, HealthPartners also offers providers in Wisconsin such as the Amery Regional Medical Center, the Baldwin Clinic, the Hudson Physicians, the New Richmond Clinic, the Osceola Medical Center and the River Falls Medical Group.

Humana Western will lose qualification in Douglas County due to lack of a dentist. Humana will not be contracting with the following hospitals in 2010: the Chippewa Valley Hospital in Durand and the Lakeview Medical Center in Rice Lake.

Physicians Plus will no longer be offering the OB/GYN providers at UW Health— 20 S Park, UW Health Fitchburg, UW Health-East Towne, and UW Health-West Towne as Primary Care Providers (PCPs) in 2010. These providers will still be available to provide specialty care. Current patients will be switched to new PCPs.

Security Health Plan will no longer be qualified in Adams County, due to losing a contract with a chiropractor. Security has added the CareNorth and Northstar physician networks which are based in Duluth, Minn. and will improve access to members living in and around Superior, Wis.

UnitedHealthcare NE will newly qualify in Door, Shawano, and Waupaca Counties as a result of adding dentists in these counties.

UnitedHealthcare SE will newly qualify in Walworth County as a result of adding a dentist in the county.

Unity UW—as with Physicians Plus OB/GYN providers, UW Health OB/GYN providers will no longer practice as PCPs effective January 1, 2010, but will continue to provide specialty care.

Qualification in Counties with No Hospital

In 2005, the Board approved a change in the qualification criteria for counties with no hospital. If a health plan has hospitals available in surrounding counties, as determined by staff, then the hospital criteria would be considered fulfilled. Staff recommends that the Board qualify the following health plans in counties without a hospital:

Arise Health Plan qualifies in Kewaunee County.

- Door County: Door County Memorial Hospital, Sturgeon Bay.
- Brown County: St. Mary's, St. Vincent's, and Bellin Memorial hospitals, Green Bay.
- Manitowoc County: Holy Family Memorial Medical Center, Manitowoc.

Network Health Plan qualifies in Kewaunee County.

- Door County: Door County Memorial Hospital, Sturgeon Bay.
- Brown County: St. Mary's and St. Vincent's hospitals, Green Bay.
- Manitowoc County: Holy Family Memorial Medical Center, Manitowoc.

Health Tradition newly qualifies in Buffalo County.

- Pepin County: newly contracted with the Chippewa Valley Hospital, Durand.
- Trempealeau County: Franciscan Skemp Healthcare Center.

SMP is offered to state employees and retirees in counties in which there is no qualified tier-1 health plan. There are eight counties in which SMP will be available to state employees and retirees in 2010. SMP will be removed from the state and local programs in Buffalo and Pierce counties for 2010. In Buffalo County, Health Tradition will be newly qualified as a result of adding providers in adjacent Pepin County. In Pierce County, Anthem Blue Northwest, newly a tier-1 health plan for 2010 will qualify as a result of adding the River Falls Hospital and Medical Center in River Falls.

The following ten counties only have one qualified tier-1 health plan for the state program in 2010:

Consideration for Non-Qualification Status

In cases where a health plan meets the qualification criteria described on page one, the Board can still assign non-qualification status if there is some deficiency in access to providers. There is one such recommendation for 2010:

Staff recommends that Dean Health Plan not be qualified in Waukesha County because the majority of its providers are in the City of Oconomowoc, which does not provide adequate access for the majority of members who live in Waukesha and the eastern part of the county.

Consideration for Qualification Status

Staff recommends that the Board qualify UnitedHealthcare NE in Manitowoc County. Although the health plan does not contract with Holy Family Memorial Medical Center in the city of Manitowoc, it does contract with the Aurora Medical Center, which is in the same metropolitan area, about four miles from the city border. Staff feels that this allows adequate access to a hospital for Manitowoc residents.

Consideration for Qualification Status in the Local Program

For the third year, staff recommends that the Board set Physicians Plus as the low-cost health plan in Marquette County. In 2007, the Marquette County administration requested that one of the health plans that actually covers its participants be considered the low-cost plan and the Board responded by setting Physicians Plus as the low-cost health plan in the county for 2007. The Physicians Plus network includes the CHN Medical Center in the adjacent counties of Green Lake and Waushara, as well as the Berlin Memorial Hospital and the Wild Rose Community Memorial Hospital. Therefore, staff recommends that the Board continue to set Physicians Plus as the low-cost qualified health plan in Marquette County; however, staff did not recommend qualification status in the state program because Physicians Plus lacks dentists in Marquette and the surrounding counties, with the exception of Columbia County.




2009 QUALIFIED HEALTH PLANS BY COUNTY

ALTERNATIVE HEALTH PLAN QUALIFICATION CRITERIA

The Board has adopted qualification criteria applicable to health plans. By establishing qualification criteria, the Board provides a means by which only those health plans with an adequate provider base and operating experience will be used to determine the employer contribution for local governments and ensure a reasonable quality tier-1 health plan for state employees. The qualification criteria adopted by the Board are:

- 1. The ratio of full-time equivalent primary physicians to total health plan members in a county or major city is at least 1/2000 with a minimum of five physicians (with admitting privileges to the plan's hospital in the county) per county or major city.
- 2. The plan must have at least one general hospital available per county (or major city, if applicable). This criterion only applies in counties and major cities in which there is a hospital. For counties with no hospital, staff makes a qualification recommendation based on the availability of hospitals in the contiguous counties.
- 3. A dentist (if applicable) must be available in each county (or major city, if applicable).
- 4. A chiropractor must be available in each county (or major city, if applicable).
- 5. The plan must have a minimum of one year of operation in the state plan.
- 6. After being offered to state employees for one year, the health plan must have achieved an enrollment of 100 subscribers or 10% of the employees in the service area, whichever is less.

Major cities are those that have over 33% of the county population. Those cities are Antigo, Appleton, Ashland, Eau Claire, Florence, Fond du Lac, Green Bay, Janesville, Kenosha, LaCrosse, Madison, Manitowoc, Menomonie, Merrill, Milwaukee, Monroe, Oshkosh, Prairie du Chien, Racine, Sheboygan, Stevens Point, Sturgeon Bay, and Superior.
