Alternate Health Plan Qualifications for 2011

Staff recommends the Board accept the attached qualification recommendations.

Background

Every year the Group Insurance Board (Board) takes formal action on "qualifying" alternate plans for each county in the state. The State Maintenance Plan (SMP) is offered in counties in which there is no qualified tier-1 health plan and a non-qualified health plan is excluded from the 105% premium contribution formula for local governments. Each health plan was notified of our recommendation to the Board and given the opportunity to correct any errors in reporting the provider counts that serve as the basis for the qualification decision. See Attachment A for more information on alternative health plan qualification criteria.

Health Plan Changes

WEA Trust PPP (WEA), a Wisconsin-based health plan with 49,681 subscribers, is new to the program in 2011. In addition to offering a broad network in Eastern Wisconsin, WEA will be available in Brown, Fond du Lac, Green Lake, Kenosha, Kewaunee, Manitowoc, Marinette, Milwaukee, Oconto, Outagamie, Ozaukee, Racine, Shawano, Sheboygan, Walworth, Washington, Waukesha, Waupaca, Waushara, and Winnebago counties because it meets the minimum provider requirements to be qualified. As a new health plan to our program, WEA will not be used in qualification formulas to determine contribution rates or SMP placement in the state or local programs.

Tiering Change from 2009 to 2010

Anthem Blue Northwest, Northeast and Southeast, and Humana Eastern and Western are currently tier-3 health plans in the local program and will be tier-1 plans for 2011. As a result of this change, all alternate health plans will participate at the tier-1 level in both the state and local programs for 2011.

as illustrated below. Table 1 (attached) presents a listing of these changes in status, using the following categories:

- Newly-listed and qualified in 2011; Number (N)=4
- Newly-listed in 2011 (as a non-qualified health plan); N=6
- Newly-qualified in 2011 (listed as non-qualified in 2010); N=11
- Lost qualification status for 2011 (listed and qualified in 2010); N=9
- Lost listing status in 2011 (listed as non-qualified in 2010); N=5

Table 2 (attached) presents a complete listing of qualification and service areas by health plan. Table 3 (attached) presents health plan qualification and non-qualification status by county. Notable changes by select health plan(s)? from 2010 to 2011 include:

Anthem Blue Northeast will newly qualify in Calumet and Winnebago counties for state, and newly qualify in both Calumet and Kewaunee counties for local as a result of adding the Affinity Health Group in the Northeast portion of Wisconsin.

Arise Health Plan will be newly listed as non-qualified in Clark, Dodge, Florence, Forest, and Green Lake counties as a result of adding providers in these counties to their network.

Dean Health Plan will newly qualify in LaFayette County for both state and local as a result of adding a chiropractor in Darlington.

GHC-EC will lose listing in Buffalo, Clark, Jackson, Pierce, St. Croix, and Trempealeau counties due to a reduction in their service area.

Gundersen Lutheran Health Plan will newly qualify in Crawford and Sauk counties as a result of additional providers in this county.

HealthPartners now qualifies in Pierce, Polk, and St. Croix counties due to the fact that this is its second year participating in the program.

Health Tradition will newly qualify in Grant County and lose qualification in Buffalo County as a result of changes to the number of PCPs to their network. In addition, Health Tradition will also lose listing in Barron, Chippewa, Dunn, Eau Claire, Grant, Pepin and St. Croix counties.

Humana Eastern will newly qualify in Green County due to the addition of the Monroe Clinic Hospital.

Humana Western will once again qualify in Douglas County due to the addition of a dentist in the county.

Network Health Plan will newly qualify in Oconto County due to the addition of a chiropractor in the county. Network has also added the ThedaCare providers to its network in Calumet, Outagamie, Shawano, Winnebago, and Waupaca counties.

Security Health Plan will once again qualify in Adams County, due to the addition of a chiropractor and will newly qualify in Juneau due to adding dentists in the county. Security will also lose qualification in Vilas County due to the loss of PCPs with admitting privileges to a hospital in the county.

UnitedHealthcare SE will be newly listed and qualify in Dodge, Jefferson and Rock counties as a result of adding hospitals and PCPs to its network in these counties.

Unity Community will lose listing in Lafayette County due to the Monroe Clinic choosing not to replace the PCP who retired.

WEA Trust PPP will participate in the program for 2011 by meeting the minimum provider requirements for qualification in Brown, Fond du Lac, Green Lake, Kenosha, Kewaunee, Manitowoc, Marinette, Milwaukee, Oconto, Outagamie, Ozaukee, Racine, Shawano, Sheboygan, Walworth, Washington, Waukesha, Waupaca, Waushara, and Winnebago counties. WEA will also offer providers in Calumet, Door, Florence, and Marquette counties. While WEA's network overlaps in a number of these counties with those currently offered by Anthem, Arise, Humana, Network and UnitedHealthcare, it will likely add additional choices for members wishing to use different provider systems residing in Calumet, Green Lake, Marquette, Oconto and Waushara counties.

Qualification in Counties with No Hospital

In 2005, the Board approved a change in the qualification criteria for counties with no hospital. If a health plan has hospitals available in surrounding counties, as determined by staff, then the hospital criteria would be considered fulfilled. Staff recommends the Board qualify the following health plans in counties without a hospital:

Arise Health Plan qualifies in Kewaunee County.

- Door County: Door County Memorial Hospital, Sturgeon Bay.
- Brown County: St. Mary's, St. Vincent's, and Bellin Memorial hospitals, Green Bay.
- Manitowoc County: Holy Family Memorial Medical Center, Manitowoc.

Network Health Plan qualifies in Kewaunee County.

- Door County: Door County Memorial Hospital, Sturgeon Bay.
- Brown County: St. Mary's and St. Vincent's hospitals, Green Bay.
- Manitowoc County: Holy Family Memorial Medical Center, Manitowoc.

State Maintenance Plan (SMP) Placement

SMP is offered to state employees and retirees in counties in which there is no qualified tier-1 health plan. There are nine counties in which SMP will be available to state employees and retirees in 2011. SMP will be removed from the state and local programs in Crawford County for 2011. In Crawford County, Gundersen Lutheran will be newly qualified as a result of adding providers in Prairie du Chien.

Competition Analysis

The following seven counties only have one qualified tier-1 health plan for the state program in 2011:

Consideration for Non-Qualification Status

In cases where a health plan meets the qualification criteria described on page one, the Board can still assign non-qualification status if there is some deficiency in access to providers. There is one such recommendation for 2011:

Staff recommends Dean Health Plan not be qualified in Waukesha County because the majority of its providers are in the City of Oconomowoc, which does not provide adequate access for the majority of members who live in Waukesha and the eastern part of the county.

Consideration for Qualification Status

Staff recommends the Board qualify UnitedHealthcare NE in Manitowoc County.

Although the health plan does not contract with Holy Family Memorial Medical Center in the City of Manitowoc, it does contract with the Aurora Medical Center, which is just outside the city limits. Staff feels that this allows adequate access to a hospital for Manitowoc residents.

Consideration for Qualification Status in the Local Program

For the fourth year, staff recommends the Board set Physicians Plus as the low-cost health plan in Marquette County.

In 2007, the Marquette County administration requested that one of the health plans that actually covers its participants be considered the low-cost plan. The Board responded by setting Physicians Plus as the low-cost health plan in the county for 2007. The Physicians Plus network includes the CHN Medical Center in the adjacent counties of Green Lake and Waushara, as well as the Berlin Memorial Hospital and the Wild Rose Community Memorial Hospital. Therefore, staff recommends that the Board continue to set Physicians Plus as the low-cost qualified health plan in Marquette County. However, staff did not recommend qualification status in the state program because Physicians Plus lacks dentists in Marquette and its surrounding counties, with the exception of Columbia County.

ALTERNATIVE HEALTH PLAN QUALIFICATION CRITERIA

The Board has adopted qualification criteria applicable to health plans. By establishing qualification criteria, the Board provides a means by which only those health plans with an adequate provider base and operating experience will be used to determine the employer contribution for local governments and ensure a reasonable quality tier-1 health plan for state employees. The qualification criteria adopted by the Board are:

- 1. The ratio of full-time equivalent primary physicians to total health plan members in a county or major city is at least 1/2000 with a minimum of five physicians (with admitting privileges to the plan's hospital in the county) per county or major city.
- 2. The plan must have at least one general hospital available per county (or major city, if applicable). This criterion only applies in counties and major cities in which there is a hospital. For counties with no hospital, staff makes a qualification recommendation based on the availability of hospitals in the contiguous counties.
- 3. A dentist (if applicable) must be available in each county (or major city, if applicable).
- 4. A chiropractor must be available in each county (or major city, if applicable).
- 5. The plan must have a minimum of one year of operation in the state plan.
- 6. After being offered to state employees for one year, the health plan must have achieved an enrollment of 100 subscribers or 10% of the employees in the service area, whichever is less.

Major cities are those that have over 33% of the county population. Those cities are:




2010 QUALIFIED HEALTH PLANS BY COUNTY
