SUBJECT: Alternate Health Plan Qualifications for 2012

Staff recommends the Board accept the attached qualification recommendations.

Background



Every year the Group Insurance Board (Board) takes formal action on “qualifying” alternate health plans for each county in the state. The State Maintenance Plan (SMP) is offered in counties in which there is no qualified Tier-1 health plan and a non-qualified health plan is excluded from the 88% premium contribution formula for local governments. Each health plan was notified of our recommendation to the Board and given the opportunity to correct any errors in reporting the provider counts that serve as the basis for the qualification decision. See Attachment A for more information on alternative health plan qualification criteria.

Health Plan Changes

WEA Trust PPP (WEA), a Wisconsin-based health plan new to the program in 2011, is set to expand its service area for 2012. In addition to expanding its network in eastern Wisconsin, WEA Trust will now be available in northwest Wisconsin. WEA Trust will be newly available in Ashland, Barron, Burnett, Chippewa, Columbia, Dodge, Door, Douglas, Dunn, Eau Claire, Jackson, Jefferson, Marathon, Pierce, Polk, Portage, Rock, Rusk, St. Croix, Sawyer, Trempealeau, Washburn and Wood counties because it meets the minimum provider requirements to be qualified.

GHC-Eau Claire decided to limit its plan participation for 2012. GHC-Eau Claire will only be available in Ashland, Bayfield, Burnett, Douglas, Sawyer and Washburn counties. This plan will no longer be available in Barron, Chippewa, Dunn, Eau Claire, Pepin, Polk, or Rusk counties.

Tiering Change from 2011 to 2012

There are no Tiering changes recommended for 2012. Therefore, all alternate health plans will participate at the Tier-1 level in both the state and local programs for 2012.

Qualification and Non-Qualification Changes

There were a total of 44 changes in qualification status in the state program from 2011, as illustrated below. Table 1 (attached) presents a listing of these changes in status, using the following categories:

- Newly-qualified and listed in 2012; Number (N)=24
- Newly-listed in 2012 (as a non-qualified health plan); N=4
- Newly-qualified in 2012 (listed as non-qualified in 2011); N=6
- Lost qualification status for 2012 (listed and qualified in 2011); N=2
- Lost listing status in 2012 (listed as non-qualified in 2011); N=1
- Plan withdrawn for 2012 (listed in 2011); N=7

See Attachment B for a 2011 and 2012 map of qualified health plans by county.

Table 2 (attached) presents a complete listing of qualification and service areas by health plan. Table 3 (attached) presents health plan qualification and non-qualification status by county. Notable changes by select health plan from 2011 to 2012 include:

GHC-Eau Claire will no longer be available in Barron, Chippewa, Dunn, Eau Claire, Pepin, Polk, or Rusk counties due to the plan not submitting a premium bid for these counties.

Gundersen Lutheran Health Plan will not be listed in Pepin County as a result of having no hospital or primary care providers in this county.

Health Tradition will not be qualified in Trempealeau County as a result of having no hospital in this county.

HealthPartners now qualifies in Burnett and Douglas counties and will be newly listed in Bayfield County.

Security Health Plan will qualify in Ashland, Vilas and Waupaca counties.

UnitedHealthcare NE will qualify in Calumet County as a result of adding a hospital and will lose qualification but be listed in Waupaca County as a result of not having a dentist in this county.

Unity Community will qualify in Juneau County as a result of adding additional primary care providers and a hospital.

WEA Trust PPP will become two separate service areas: East and Northwest.

- **WEA Trust Northwest** will participate in the program for 2012 by meeting the minimum provider requirements for qualification in Ashland, Barron, Burnett, Chippewa, Douglas, Dunn, Eau Claire, Jackson, Pierce, Polk, Rusk, St. Croix, Sawyer, Trempealeau and Washburn counties and will be listed in Bayfield, Buffalo and Pepin counties.
- **WEA Trust East** will qualify in Columbia, Dodge, Door, Jefferson, Marathon, Portage, Rock and Wood counties.

Qualification in Counties with No Hospital

In 2005, the Board approved a change in the qualification criteria for counties with no hospital. If a health plan has hospitals available in surrounding counties, as determined by staff, then the hospital criteria would be considered fulfilled. **Staff recommends the Board qualify the following health plans in counties without a participating hospital:**

- Anthem NE, Arise, Network Health and WEA Trust East health plans qualify in Kewaunee County.
- Door County: Ministry Door County Medical Center (formerly Door County Memorial Hospital), Sturgeon Bay.
- Brown County: St. Mary's and St. Vincent's hospitals, Green Bay.
- Manitowoc County: Holy Family Memorial Medical Center, Manitowoc.

State Maintenance Plan (SMP) Placement

There are eight SMP counties for 2012:

SMP is offered to state employees and retirees in counties in which there is no qualified Tier-1 health plan. There are eight counties in which SMP will be available to state employees and retirees in 2012. SMP will be removed from the state and local programs in Vilas County for 2012 since Security Health will be newly qualified as a result of adding providers.

Competition Analysis

The following five counties only have one qualified Tier-1 health plan for the state program in 2012:

Consideration for Non-Qualification Status

In cases where a health plan meets the qualification criteria described on page one, the Board can still assign non-qualification status if there is some deficiency in access to providers. As in previous years, there is again one such recommendation for 2012:

Staff recommends Dean Health Plan not be qualified in Waukesha County because the majority of its providers are in the City of Oconomowoc, which does not provide adequate access for the majority of members who live in Waukesha and the eastern part of the county.

Consideration for Qualification Status

Staff recommends the Board qualify UnitedHealthcare NE in Manitowoc County.

Although the health plan does not contract with Holy Family Memorial Medical Center in the city of Manitowoc, it does contract with the Aurora Medical Center, which is just outside the city limits. Staff feels that this allows adequate access to a hospital for Manitowoc residents.

Consideration for Qualification Status in the Local Program

For the fifth straight year, staff recommends the Board set Physicians Plus as the low-cost health plan in Marquette County. In 2007, the Marquette County administration requested that one of the health plans that actually covers its participants be considered the low-cost plan. The Board responded by setting Physicians Plus as the low-cost health plan in the county for 2007. The Physicians Plus network includes the CHN Medical Center in the adjacent counties of Green Lake and Waushara, as well as the Berlin Memorial Hospital and the Wild Rose Community Memorial Hospital. Since WEA Trust has completed a year in our program, it may now be considered for the low-cost health plan in Marquette County. However, unlike Physicians Plus, WEA Trust does not have a participating hospital in Adams County. Therefore, staff recommends the Board continue to set Physicians Plus as the low-cost qualified health plan in Marquette County. However, staff did not recommend qualification status in the state program because Physicians Plus lacks dentists in Marquette and its surrounding counties, with the exception of Columbia County.

ALTERNATIVE HEALTH PLAN QUALIFICATION CRITERIA

The Board has adopted qualification criteria applicable to health plans. By establishing qualification criteria, the Board provides a means by which only those health plans with an adequate provider base and operating experience will be used to determine the employer contribution for local governments and ensure a reasonable quality Tier-1 health plan for state employees. The qualification criteria adopted by the Board are:

1. The ratio of full-time equivalent primary physicians to total health plan members in a county or major city is at least 1/2000 with a minimum of five physicians (with admitting privileges to the plan's hospital in the county) per county or major city.
2. The plan must have at least one general hospital available per county (or major city, if applicable). This criterion only applies in counties and major cities in which there is a hospital. For counties with no hospital, staff makes a qualification recommendation based on the availability of hospitals in the contiguous counties.
3. A dentist (if applicable) must be available in each county (or major city, if applicable).
4. A chiropractor must be available in each county (or major city, if applicable).
5. The plan must have a minimum of one year of operation in the state plan.
6. After being offered to state employees for one year, the health plan must have achieved an enrollment of 100 subscribers or 10% of the employees in the service area, whichever is less.

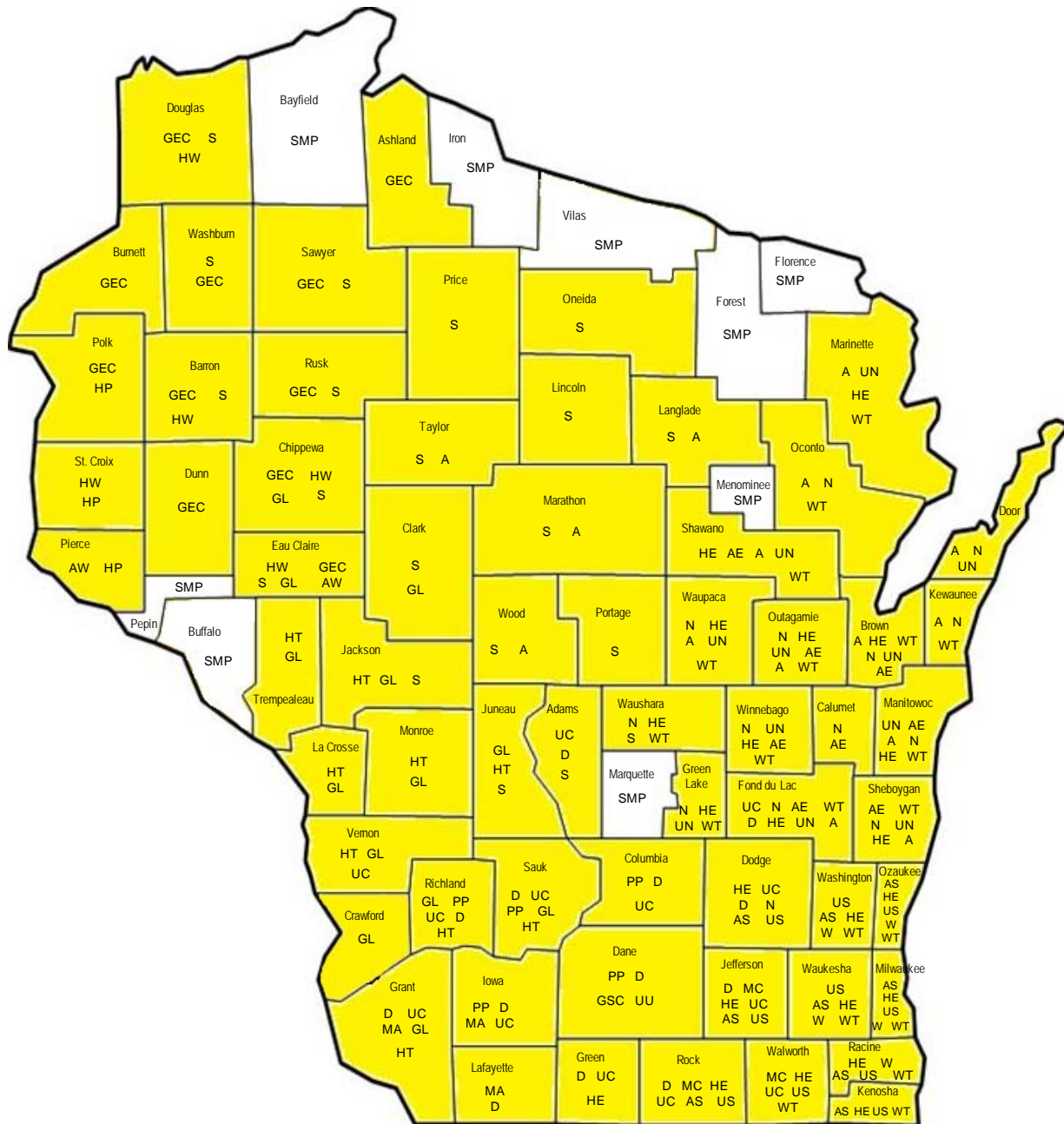
