CORRESPONDENCE MEMORANDUM

SUBJECT: Plan Changes to the Optional Dental Benefits as of January 1, 2012

This memo is for informational purposes only. No Board action is required.

This memo is provided to inform the Group Insurance Board (Board) that two health plans have proposed changes to dental coverage and two are presenting clarifications. This memo describes these changes and clarifications. Note that all alternate health plans (HMOs and PPPs that offer Uniform Benefits) will offer dental coverage to State employees and annuitants. For participating Wisconsin Public Employers, nine health plans will continue to offer dental coverage.

Benefit changes:

- Dean Health Plan (Dean) will reduce dental benefits by increasing the out-ofnetwork office visit copay to \$40, from \$25. Dean will also reduce the annual benefit maximums to \$1,500 per individual for in-network services and \$1,000 per individual for out-of-network services. Currently, these maximums are combined, and the combined maximum is \$2,000 per individual. Attached is an updated benefit outline from Dean with changes highlighted.
- Unity-UW Health is changing its dental administrator to Momentum Insurance Plans, from Delta Dental. This change results in significant provider network differences. Attached is a letter from Unity-UW Health specifying the providers in the new network. Existing orthodontia patients will have their covered services at their current provider continue to be payable in 2012.

Benefit clarifications:

- Medical Associates clarified its benefit description to specify existing age limits for fluoride and sealants. In addition, basic and restorative services accumulate to their current \$1,000 annual benefit maximum.
- Security Health Plan clarified its benefit description to specify that providers are available only in the United States.

* Out-of-Network benefit allowances will be based on Network Provider contracted fees in the following counties: Brown, Dane, Eau Claire, Green, Kenosha, La Crosse, Milwaukee, Outagamie, Ozaukee, Racine, Rock, Sauk, Sheboygan, Washington, Waukesha, Winnebago. With an out-of-network provider, outside these counties, allowances are based on the dentist's actual charges.

To find out if your dentist is a member of the Ameritas PPO network, or to find a network dentist that is most convenient for you, visit deancare.com/wi-employees and select 'Group Dental Providers.' Under the Dental Information call out on the right side of the page you can also find information about your coverage, FAQs, you can review your complete employee certificate.

While using a PPO dentist will almost always lower your out-of-pocket costs, every Ameritas Group plan gives you the freedom to visit any dentist you choose.

Ameritas PPO dentists agree to charge plan members based on negotiated fees, often including discounts for non-covered services such as whitening procedures, root canals, and dental implants. This results in member savings when visiting an Ameritas PPO plan provider.

Note: Outside of Wisconsin, state law may impact the availability of discounts.

Pretreatment

Ameritas Group does not require a pretreatment authorization for any procedure. However we recommend a pretreatment estimate of benefits for any dental work you consider expensive. If you want to know your share of the cost up front, simply ask your dentist to submit the information for a pretreatment estimate to the Ameritas customer relations department: Ameritas Group Claims, PO Box 82520, Lincoln, NE 68501, fax: 402.467.7336.

Ameritas will inform both you and your dentist of the exact amount your insurance will cover and the amount that you will be responsible for. That way, there won't be any surprises once the work has been completed.

Dear Ms. Larson:

Unity Health Insurance is changing its dental administrator for *only* the UW Health Network in 2012. We have a signed contracted with Momentum Insurance Plans, Inc. to provide the dental network and claims administration for members who have a primary care physician in the UW Health Network.

The dental benefits are *not* changing; however there will be a significant change to the dental network. Participating dental groups include:
