

SUBJECT: 2012 *It's Your Choice* Enrollment Results

This memo is for information purposes only. No Board action is required.

This memo highlights the shifts in participant enrollment during the 2012 *It's Your Choice* (IYC) enrollment period. Attached are 2012 IYC statistical tables indicating counts of contracts gained or lost by health plan, coverage level, and employee type. In addition to the IYC information, the Division provides the total contract counts as of January 1, 2012, by health plan and coverage level, with a comparison to January 1, 2011, total contract counts.

The 2012 IYC health plan changes, including the addition or termination of dependents, were all received through the myETF Benefits system for the second year. All contract counts, health plan changes, gains, and losses are by health plan and coverage type. This memo also contains information regarding new contracts resulting from the change to an open enrollment period.

SUMMARY OF CHANGES IN HEALTH PLANS

The 2012 IYC enrollment period experienced a significant number of health plan changes. Changes in coverage by one plan, the addition of another plan, and employee premium changes resulting from 2011 Wisconsin Acts 10 and 32 drove many of the changes. However, all alternative health plans continued to remain at the tier-1 level.

IT'S YOUR CHOICE APPLICATIONS SUBMITTED FOR 2012

All IYC enrollment or coverage changes were either electronically submitted directly by the member via the myETF Benefits online health insurance enrollment system or by the employer on behalf of the member. There were 100.39% more IYC requests submitted for 2012 (13,071) than were submitted for 2011 (6,072). Of the 13,071 requests submitted, 11,038 were requests to change health plans.

The majority of requests to change health plans resulted from significant changes in coverage areas in northwestern Wisconsin, particularly the loss of Group Health Cooperative of Eau Claire in seven counties. Also, Unity-UW Health and Unity-Community gained a large number of subscribers due to their lower premiums and related changes in Acts 10 and 32 that require local employers to pay no more than 88% of their counties' average low cost tier for their employees' health insurance premiums.

The breakdown of all IYC requests entered into myETF Benefits are:

- 11,038 health plan change requests
- 394 add dependent requests
- 668 remove dependent requests
- 971 new contract requests due to the open enrollment period

Effective retroactively to January 1, 2011, 2011 Wisconsin Act 49 eliminated the imputed income requirement for adult dependents on their parents' health insurance coverage. Because this law passed in November 2011, Employee Trust Funds (ETF) allowed subscribers to add their adult dependent children to their coverage under IYC through the end of the year. During the 2011 IYC enrollment period, ETF received 394 add dependent requests.

The IYC enrollment for 2012 was a true open enrollment period for the first time, a result of federal health care reform.

- The total number of active contracts on January 1, 2012, increased by 635 (0.57%) to 111,331 (vs. 110,696 on January 1, 2011).

- The State contracts increased by 642, or 0.67% (up 96,199 vs. 95,557 on January 1, 2011).
- The local contracts decreased by 7, or 0.05% (down 15,132 vs. 15,139 on January 1, 2011).

The number of new contracts is noteworthy because it is inconsistent with anecdotal evidence of employees withdrawing from the State health insurance program due to changes in 2011 Wisconsin Acts 10 and 32.

HEALTH PLAN CONTRACT GAINS AND LOSSES

WEA Trust PPP Northwest expanded into 18 counties in northwest Wisconsin and several counties in Minnesota. Other health plans made significant changes by adding or terminating contracts with provider groups.

For local active employees in the southern half of Wisconsin, 1,250 switched to Unity-Community and 884 switched to Unity-UW Health in Dane County. We believe this is primarily due to these plans offering lower premiums than competitors in the counties they serve. Note that many local employers could remain under the previous 105% contribution formula. Dean Health Plan lost 1,319 subscribers, Physicians Plus lost 339, and Group Health Cooperative of South Central Wisconsin lost 179.

Health Plans that gained the greatest number of contracts resulting from subscribers changing health plans include:

- WEA Trust PPP Northwest received 4,367 new contracts.
- WEA Trust PPP East (formerly WEA Trust PPP) expanded into Dodge, Door, Columbia, Jefferson, Marathon, Portage, Rock, and Wood counties. It received 2,048 new contracts.
- Unity-Community increased by 1,314 contracts.
- Unity-UW Health increased by 1,266 contracts.
- The State Maintenance Plan (SMP) is no longer available in Vilas County. It increased by 9 contracts.

Health plans that lost the greatest number of contracts due to subscribers changing health plans include:

- Group Health Cooperative of Eau Claire no longer offers providers in Barron, Chippewa, Dunn, Eau Claire, Pepin, Polk, or Rusk Counties. It lost 4,288 contracts.
- Dean Health Plan decreased by 1,582 contracts.
- Physicians Plus decreased by 706 contracts.
- Humana Eastern decreased by 586 contracts.
- Security Health Plan decreased by 411 contracts.

- United HealthCare NE decreased by 331 contracts.
- Group Health Cooperative of South Central Wisconsin decreased by 168 contracts.
- Health Tradition decreased by 154 contracts.
- Anthem Blue Southwest decreased by 146 contracts.
- Network Health Plan decreased by 121 contracts.
- Arise Health Plan decreased by 103 contracts.
- Gundersen Lutheran Health Plan decreased by 95 contracts.
- MercyCare Health Plan decreased by 92 contracts.
- UnitedHealthCare SE decreased by 84 contracts.
- HealthPartners Health Plan added Bayfield, Burnett, and Douglas counties. It decreased by 58 contracts.
