SUBJECT: Alternate Health Plan Qualifications for 2015

CONFIDENTIAL

Staff recommends the Board accept the following qualification recommendations.

Background

Each year the Group Insurance Board (Board) takes formal action on “qualifying” alternate health plans for each county in Wisconsin. The State Maintenance Plan (SMP) is offered in counties in which there is no qualified Tier 1 health plan and, for local governments, where a non-qualified health plan is excluded from the 88% premium contribution formula. Each health plan that would be negatively affected by qualification changes and had not already provided an explanation for the changes, was notified of our recommendation to the Board. These plans were given the opportunity to correct any errors in reporting of the provider counts that serve as the basis for the qualification decision. See Attachment A for more information on alternate health plan qualification criteria.

Health Plan Changes

WEA Trust (WEA):

In 2014 WEA developed two provider networks in its Northwest service area. Members were required to select one of the two networks if they decided to enroll in the WEA Trust – Northwest plan. For 2015 WEA Trust will use these networks to create two individual service areas: **WEA Trust - Northwest Mayo Clinic Health System** and **WEA Trust - Northwest Chippewa Valley**. The providers that were under one plan in 2014 are now split between the two service areas for 2015. Members were required to select between the two networks in 2014, but in 2015 will need to select between the two **plans**. We expect minimal member disruption with the two service areas.

The **Northwest Chippewa Valley** service area will be qualified in Ashland, Barron, Burnett, Chippewa, Clark, Douglas, Eau Claire, Jackson, Pepin, Pierce, Polk, Rusk, St. Croix, Sawyer and Washburn counties, while only listed in Bayfield, Dunn, Iron, and Trempealeau counties. The **Northwest Mayo Clinic Health System** service area will be qualified in Barron, Chippewa, Dunn, Eau Claire, and Trempealeau counties, while only listed in Buffalo, Pierce and St. Croix counties.

There are no qualification changes for the **WEA Trust - East** service area for 2015. And, while the **WEA Trust - South Central** service area has a presence in Green, Iowa, Lafayette and Sauk counties, it will once again only be qualified in Dane County for 2015, due to a lack of contracts with PCPs and hospitals in the other counties.

WPS Metro Choice / Arise Health Plan:

WPS will no longer offer **Metro Choice Northwest** and **Metro Choice Southeast** in the 2015 plan year. However, Arise Health Plan will be expanding its service area and creating two separate regions: **Arise Health Plan Northern** and **Arise Health Plan Southeast**. This expansion by Arise Health Plan will absorb the service areas previously covered by the **Metro Choice Southeast** plan.

Dean Health Insurance (Dean):

In past years staff recommended the Board consider non-qualified status for Dean in Waukesha County, due to a lack of providers in the eastern part of the county. In December 2013, Dean contracted with ProHealth, which resulted in the addition of a greater number of providers more effectively dispersed throughout Waukesha County. This has resulted in Dean being qualified in Waukesha County.

Dental Network Changes

Three plans, **Dean Health Insurance**, **Dean Health Insurance-Prevea 360** and **Gundersen Health Plan**, made major changes to their dental provider networks by contracting with Delta Dental to administer the 2015 dental benefits. Dean was previously contracted with Ameritas, and Gundersen previously had no dental vendor under contract. Delta Dental is also the dental vendor used by four other health plans participating in the State and Wisconsin Public Employers (WPE) programs group health insurance programs. These plans include **Arise Health Plan** (Northern and Southeast), **MercyCare Health Plans**, **Network Health** and **Unity Health Insurance – Community**. Two factors that are driving this change are the requirement to accumulate the maximum out of pocket (MOOP) amounts dictated by the federal Affordable Care Act (ACA) and accumulation of deductibles due to the implementation of the high deductible health plan (HDHP) for 2015. Delta Dental has the experience and familiarity with the requirements of the State and WPE group health insurance programs.

Tiering Changes from 2014 to 2015

For 2015 staff recommends that, based on their premium bids, Group Health Cooperative of Eau Claire (GHC-EC), Humana Eastern, Humana Western, and Security Health Plan be placed in Tier 3 in the Wisconsin Public Employers (WPE) program.

In consultation with the Board's actuary, the premium bids provided by these plans for the WPE program were at the top of the acceptable range at which they could bid. While their bids were acceptable for continued participation in the WPE program, their lack of experience, very low enrollment, and unjustified higher premiums places them in Tier 3. Each of the plans was provided the opportunity, through negotiations, to lower their bids; none did so. Both Security Health Plan and Humana Eastern were placed in Tier 3 for the WPE program in 2014. Overall this recommendation will affect 53 of the 72 Wisconsin counties. Out of all four plans affecting this recommendation, the only active employee contracts are held by **GHC-EC** (two family contracts with six total members). There are only 70 annuitant contracts held by all four plans, most of which are Medicare contracts, which are not affected by the tiering.

The following 42 counties where these Tier 3 plans participate will have at least two qualified Tier 1 plans:

The following seven counties will have only one qualified Tier 1 plan:

- Burnett
- Lincoln
- Oneida
- Pepin

- Rusk

While the plans affected by this recommendation have a presence in four additional counties – Bayfield, Forest, Iron, and Vilas – there are no qualified plans in these

counties; the State Maintenance Plan will be offered in these counties, as discussed later in this memo (see Attachment B).

Qualification and Non-Qualification Changes

There were a total of 59 changes in qualification status in the State program from 2014 to 2015, as illustrated below. Table 1 enclosed with this memo presents a listing of these changes in status, using the following categories. The number of instances is also provided:

Notable changes from 2014 to 2015, made by certain health plans include:

Arise Health Plan, as mentioned above, has expanded into two separate service areas for 2015. The Northern service area gained qualification in Door County (chiropractor) and Waushara County (increased the number of PCPs, contracted with a hospital and chiropractor). The Southeast service area will now be qualified in Kenosha, Milwaukee, Ozaukee, Washington and Waukesha counties.

GHC-Eau Claire is expanding into six counties, where it will be newly qualified for 2015. These include Clark, Langlade, Lincoln, Marathon, Oneida, Price and Taylor counties. The plan is also expanding into Iron and Vilas counties but does not meet the minimum requirements to qualify in those counties, due to a lack of dentists, chiropractors, PCPs and hospital, and therefore will be listed only.

GHC of South Central Wisconsin has expanded into Columbia, Marquette and Sauk counties. They do not meet the minimum requirements to qualify in these counties due to a lack of dentists, chiropractors, PCPs and hospital, and will be listed only.

Health Tradition Health Plans has lost qualification for 2015 in Grant, Richland and Sauk counties, due to a lack of dental providers.

Health Partners Health Plan has become newly qualified in ten counties for 2015. The plan has also contracted with enough PCPs in 14 other counties to be newly listed in 2015. In six of those 14 counties the plan will be qualified for the WPE program only.

Please refer to Tables 1, 2 and 3 enclosed with this report for more details on the impacted counties.

Physicians Plus has expanded into Dodge County and will be newly qualified for 2015. The plan has also expanded into Juneau, Vernon, Waukesha and Wood counties for 2015, but does not meet the minimum requirements to qualify in those counties, due to a lack of dentists, chiropractors and PCPs, and will be listed only.

Security Health Plan has lost its qualified status in Vilas County, due to not having a minimum number of PCPs contracted. They will still be listed in Vilas County for 2015.

Plan Enrollment in Counties after the First Year of Participation

As noted in the Alternative Health Plan Qualification Criteria in Attachment A, health plans participating in the State program are required, after being offered to state employees for one year, to have achieved an enrollment of 100 subscribers or 10% of the employees in the service area, whichever is less. Based on their enrollment of members in 2014, two plans have been asked to provide a marketing plan to show how they will meet this requirement. The two plans affected are **Dean Health Insurance – Prevea 360** in Brown County and **WEA Trust – South Central** in Dane County. This will not affect either plan's qualification for 2015. Staff will continue to monitor this matter and report back to the Board.

Qualification in Counties with No Hospital

<p>Staff recommends the Board qualify Arise Health Plan - Northern, Network Health and WEA Trust - East health plans in Kewaunee County for the State and WPE programs without a participating hospital.</p>

In 2005, the Board approved a change in the qualification criteria for counties with no hospital. If a health plan has hospitals available in surrounding counties, as determined by staff, then the hospital criteria would be considered fulfilled.

Qualification in Kewaunee County is based on plans being contracted with all of the following hospitals in surrounding counties:

- Door County: Ministry Door County Medical Center, Sturgeon Bay.
- Brown County: St. Mary's, Bellin Memorial, and St. Vincent's hospitals, Green Bay.
- Manitowoc County: Holy Family Memorial Medical Center, Manitowoc.

Anthem Blue Preferred Northeast, Humana Eastern and UnitedHealthcare of Wisconsin are all listed in Kewaunee County, but they are not otherwise qualified plans since they have no dentist in Kewaunee County and provide dental coverage to both the State and WPE (Local) programs. **Dean Health Insurance - Prevea360** is also listed in

Kewaunee County, but does not contract with the hospitals in all of the surrounding counties.

You may recall that in 2014 **Anthem Blue Preferred Northeast** was qualified in the WPE program only because it did not provide dental coverage to the WPE (Local) program. They were contracted with hospitals in all surrounding counties and the lack of a hospital was the only factor that would not qualify them for the WPE (Local) program in Kewaunee County. However, starting in 2015 **Anthem Blue Preferred Northeast** will provide dental coverage for the WPE program, but have no contracted dentists, as indicated above, and thus will not be qualified in Kewaunee County.

State Maintenance Plan (SMP) Placement

SMP is offered to state employees and retirees in counties in which there is no qualified Tier 1 health plan. There are eight counties in which SMP will be available to state employees and retirees in 2015. Seven of the eight counties have the same SMP placement recommendation from 2014 for the state’s program. Pepin County is no longer recommended for SMP placement because **WEA Trust - Northwest Chippewa Valley** will be qualified in Pepin County, based on an increase in the number of contracted PCPs. However, Vilas County is being recommended for SMP placement in 2015, due to **Security Health Plan** losing its qualification status based on having less than the required number of contracted PCPs for qualification.

The exclusion of Local SMP in Marquette County is discussed under the heading, “Consideration for Qualification Status in the Local Program” below.

Competition Analysis

There are two counties that have only one qualified Tier 1 health plan for the State program in 2015. Please see the table on the next page for the list of affected counties:

Pepin County is added to this list for 2015. **WEA Trust - Northwest Chippewa Valley** gained qualification status in Pepin County and is the only qualified plan for 2015. In 2014 Pepin County had no qualified plans.

For the WPE program, in addition to Pepin County, there are six additional counties with only one qualified Tier 1 health plan, due to **GHC – Eau Claire, Humana Eastern, Humana Western, and Security Health Plan** being placed into Tier 3. Lafayette County is not included for the WPE program because **Physicians Plus** is qualified for the WPE program only.

Consideration for Qualification Status in the WPE (Local) Program

Staff recommends the Board set Physicians Plus as the low-cost qualified health plan in Marquette County.

In 2007, the Marquette County administration requested that one of the health plans covering its participants be considered the low-cost plan for the 88% formula calculation or employer share of premium. The Board qualified **Physicians Plus** as the low-cost health plan in the county for 2007 due to the availability of providers in the surrounding counties. **Physicians Plus** remains the low-cost plan and its network includes the CHN Medical Center in the adjacent counties of Green Lake and Waushara, as well as the following hospitals in the four surrounding counties:

- Adams County: Moundview Memorial Hospital
- Columbia County: Columbus Community Hospital and Devine Savior Healthcare
- Green Lake County: Berlin Memorial Hospital
- Waushara County: Wild Rose Community Memorial Hospital

For 2015 **WEA Trust - East** has the same participating hospitals and providers in the surrounding counties and thus could be qualified in Marquette County for the WPE program only, as it was in 2014.

Physicians Plus still has the lower cost between the two plans; therefore, **Physicians Plus** should be the low-cost qualified health plan in Marquette County for the WPE program only. Staff does not recommend qualification status in the State program because **Physicians Plus** lacks dentists in Marquette County and its surrounding counties, with the exception of Columbia County.

Network Health also participates in Marquette County; however, Network only has hospitals in two of the four surrounding counties. While **Arise Health Plan Northern, GHC of South Central Wisconsin, UnitedHealthcare of Wisconsin** and **Unity Health Insurance - Community** are listed in Marquette County, none participates in all of the surrounding counties; therefore, they are not considered qualified.

Summary

2015 will see a higher-than-usual number of plan qualification changes. However, because only eight of those changes involve plans losing qualification status, the disruption for members should be minimal. While **Security Health Plan** will be losing qualification status in Vilas County and **SMP** will be placed there, the introduction of **GHC – Eau Claire** and **Health Partners Health Plan** being listed in Vilas County provides members with other health plan opportunities. Overall, the expansion by many plans, particularly **Arise, Health Partners** and **GHC – Eau Claire**, will provide more options for members.

ALTERNATIVE HEALTH PLAN QUALIFICATION CRITERIA

The Board has adopted qualification criteria applicable to health plans. By establishing qualification criteria, the Board provides a means by which only those health plans with an adequate provider base and operating experience will be used to determine the employer contribution for local governments and ensure a reasonable quality Tier 1 health plan for State employees. The qualification criteria adopted by the Board are:

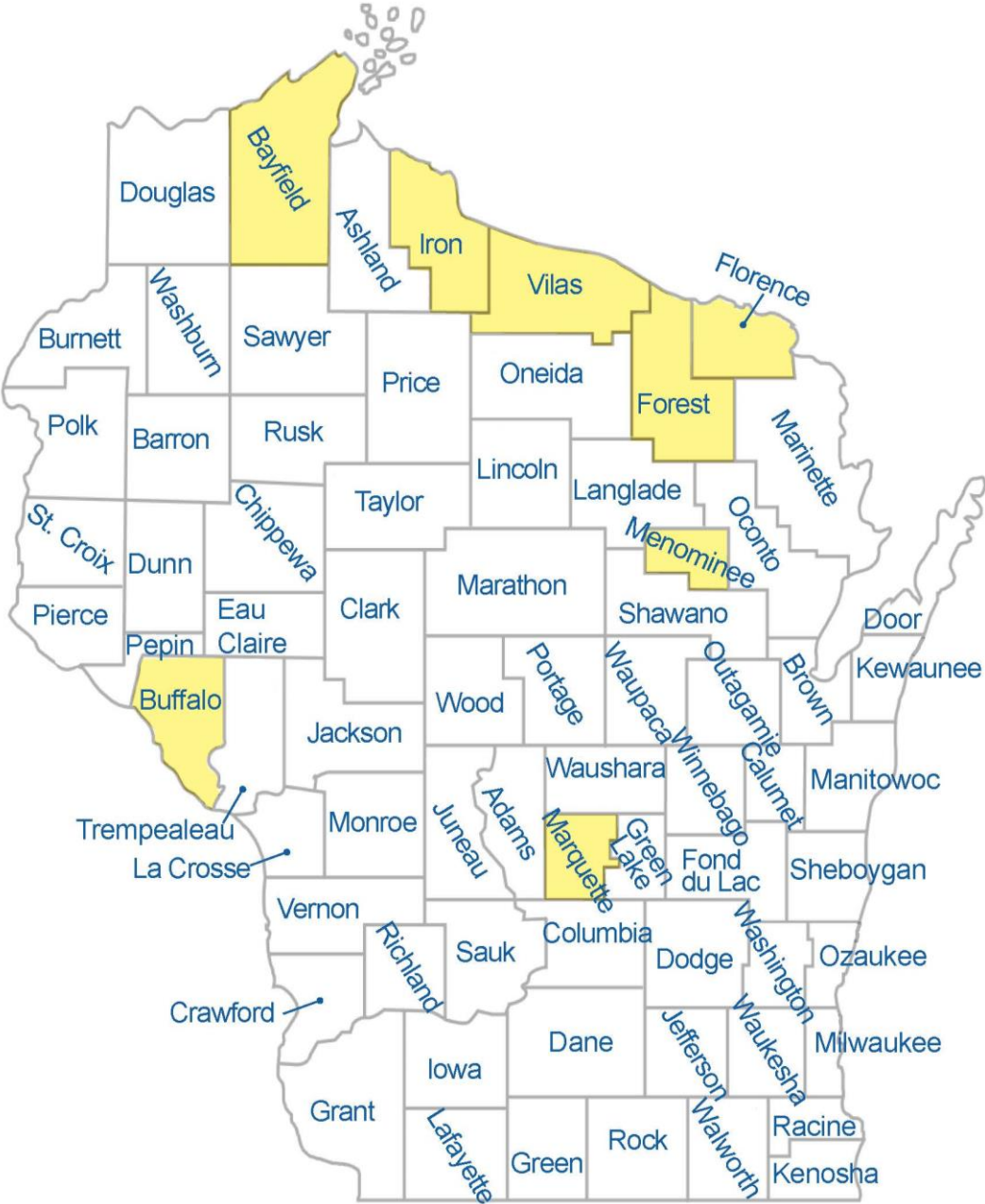
1. The ratio of full-time equivalent primary physicians to total health plan members in a county or major city is at least 1/2000 with a minimum of five physicians (with admitting privileges to the plan's hospital in the county) per county or major city.
2. The plan must have at least one general hospital available per county (or major city, if applicable). This criterion only applies in counties and major cities in which there is a hospital. For counties with no hospital, staff makes a qualification recommendation based on the availability of hospitals in the contiguous counties.
3. A dentist (if applicable) must be available in each county (or major city, if applicable).
4. A chiropractor must be available in each county (or major city, if applicable).
5. The plan must have a minimum of one year of operation in the State plan.
6. After being offered to State employees for one year, the health plan must have achieved an enrollment of 100 subscribers or 10% of the employees in the service area, whichever is less.

Major cities are those that have over 33% of the county population. Those cities are:
