SUBJECT: Update – Alternate Health Plan Service Area Qualification for 2016

This memo is to be taken under consideration with the recommendations provided by staff in the memo, “Alternate Health Plan Service Area Qualification for 2016”, dated August 19, 2015, previously provided to the Board.

This memo is to advise the Board of updated information regarding the plan qualification status of two health plans. The following information was not available to be included in the memo dated August 19, 2015.

Network Health - Northeast in Sheboygan County

Network was initially considered a non-qualified plan in the county for 2016 since they did not have a contracted hospital. Network had been negotiating with St. Nicholas Hospital in the city of Sheboygan throughout the Addendum 2 submission process and had previously informed staff of the pending contract. Network informed staff on Monday, August 24, 2015, that they had secured their contract with St. Nicholas. With this contracted hospital, Network can be considered a qualified plan in the county, as they had been in 2015, since they meet all other requirements to be qualified.

WEA Trust - Northwest - Chippewa Valley in Pierce County

The River Falls Area Hospital is uniquely situated, straddling the border of Pierce and St. Croix Counties, as is the City of River Falls. Staff have allowed HealthPartners Health Plan to list this hospital in both St. Croix and Pierce Counties in their Addendum 2 reporting, and will extend this same accommodation to WEA Trust.

While WEA had included the hospital on their preliminary Addendum 2 submission, they were initially considered a non-qualified plan in Pierce County for 2016, since they erroneously omitted the hospital from their final Addendum 2 report. WEA contacted staff on Monday, August 24, 2015, and informed them of the omission.

SUBJECT: Alternate Health Plan Service Area Qualification for 2016

CONFIDENTIAL

Staff recommends the Group Insurance Board (Board) accept the following qualification recommendations.

Background

Each year the Board takes formal action on “qualifying” alternate health plans for each county in Wisconsin. The actions taken are based on the requirements included in Section 2 of the guidelines contract. Attachment A is an excerpt of alternate health plan qualification criteria. Please note that with the uniform dental benefits being carved out from the participating health plans for plan year 2016, the dental provider qualification requirements are no longer valid or applicable and have been removed.

The alternate health plans provide a detailed list and a summary of their contracted providers and facilities via their annual Addendum 2 submission. After the qualification criteria are analyzed by staff, if a county has no qualified Tier 1 health plan, then the State Maintenance Plan (SMP) is offered in that county. All participating plans were given the opportunity to correct any errors staff discovered in the plans’ reporting of the provider/facility counts submitted on Addendum 2. Each health plan was notified of staff’s qualification status recommendation to the Board prior to this meeting.

Health Plan Changes

Arise Health Plan:

For 2016 Arise will refine its service areas by consolidating the two existing regions (Northern and Southeast) into one service area and create a new offering called Arise Health Plan – Aspirus; the result of new provider contracting with the Aspirus network. The counties covered by these two service areas in 2016 are shown on the following page.

Network Health Plan:

Network Health Plan will expand into a new service area in Southeast Wisconsin for 2016. The existing service area will be designated Northeast, and maintains Network's presence in those counties. Following are the counties that will be covered by each of these service areas.

WEA Trust (WEA):

Based on WEA's Addendum 2 reporting and the counties indicated on WEA's best and final premium rate bids, a number of counties that WEA included in its service areas for 2015 have been dropped for the 2016 plan year. The list of affected counties follows:

It should also be noted that the following four counties were added to WEA's Northwest Mayo Clinic Health System service area: Crawford, La Crosse, Monroe and Vernon.

Health Plan Tiering Status for 2016

For 2016 staff recommends, based on premium bids, Group Health Cooperative of Eau Claire (GHC-EC), Humana Eastern, Humana Western, and Security Health Plan be placed in Tier 3 in the Wisconsin Public Employers (WPE) program.

In consultation with the Board’s actuary, Segal Consulting (Segal), the premium bids provided by these plans for the WPE program were deemed at the top of the acceptable range at which they could bid. While the bids were acceptable for continued participation in the WPE program, lack of claims experience, very low enrollment and unjustified higher premiums place these plans in Tier 3. Overall, this recommendation will affect 59 of the 72 Wisconsin counties. Out of the four plans affecting this recommendation, the only contracts with active employees are held by **GHC-EC** (two family contracts) and **Humana Eastern** (one individual contract). There are also 64 annuitant contracts held by all four plans, 63 of which are Medicare contracts and which are not affected by the tiering.

The following 44 counties where these Tier 3 plans participate will have at least two qualified Tier 1 plans:

The following nine counties will have only one qualified Tier 1 plan:

While the plans affected by this recommendation have a presence in six additional counties – Bayfield, Forest, Iron, Pepin, Price, and Vilas – there are no qualified plans in these counties; the State Maintenance Plan will be offered in these counties, as discussed later in this memo.

Qualification and Non-Qualification Changes

There were a total of 58 changes in qualification status in the State program from 2015 to 2016, as illustrated below. Table 1 (attached) presents a list of changes in status, using the following categories:

Notable changes from 2015 to 2016 include:

As noted earlier in this memo, **Arise Health Plan** consolidated two existing service areas to create one (**Arise Health Plan**) and then created the new **Arise Health Plan - Aspirus** service area. The new Arise Health Plan - Aspirus service area accounts for 12 of the 58 instances in Change Categories E and F noted above. The **Arise Health Plan** service area also lost qualification in Waushara County (Change Category C).

GHC of South Central Wisconsin has gained qualification in both Columbia and Sauk counties for 2016. In 2015 GHC had expanded into Columbia, Marquette and Sauk counties but did not meet the minimum requirements to qualify due to a lack of contracted dentists, chiropractors, primary care providers (PCPs) and hospital.

Health Tradition Health Plans has gained qualification in Richland and Sauk counties for 2016. This plan lost qualification in both counties for 2015, due to a lack of dental providers, which is no longer an issue because the uniform dental benefits have been carved out.

Health Partners Health Plan had a major expansion of its service area in 2015, becoming newly qualified in ten counties and listed, but not qualified, in 14 other counties. In 2016, this plan gained qualification in seven of the counties it was previously only listed in and will be newly listed, but not qualified, in Trempealeau County.

Humana has gained qualification in Polk County for its Western service area. However, this plan has lost qualification in Douglas County, in addition to losing qualification in

Calumet, Door, Green, Rock and Shawano Counties in its Eastern service area, mainly due to a loss of contracted PCPs.

Physicians Plus has gained qualification for 2016 in Adams, Grant, Juneau, Lafayette and Waushara Counties due in part to the dental provider requirement being removed for qualification. This plan also had an increase in provider contracting in these counties for 2016.

The table below shows non-qualified health plans that were not qualified and listed only in certain counties in 2015, and who have lost that listing status for 2016:

Qualification in Counties with No Hospital

Staff recommends the Board qualify Anthem Blue Preferred Northeast, Arise Health Plan, United Healthcare of Wisconsin and WEA Trust - East health plans in Kewaunee County for the State and WPE programs without a participating hospital.

In 2005 the Board approved a change in the qualification criteria for counties with no hospital. If a health plan has hospitals available in surrounding counties, as determined by staff, then the hospital criteria would be considered fulfilled.

Qualification in Kewaunee County is based on plans being contracted with all of the following hospitals in surrounding counties:

The four health plans recommended for qualification contract with all of the hospitals in the surrounding counties as listed above. The lack of a hospital in Kewaunee County is the only factor that would not allow them to be qualified.

Dean Health Insurance - Prevea360 and **Network Health Plan** will both be listed in Kewaunee County, but not qualified. **Dean Health Insurance - Prevea360** does not contract with the hospitals in all of the surrounding counties. **Network Health Plan** was qualified in Kewaunee County in 2015 under this special provision. However, they are no longer contracted with St. Mary's and St. Vincent's hospitals in Brown County, or Aurora hospitals in Brown and Manitowoc Counties. **Humana Eastern** will no longer be qualified or listed in Kewaunee County since they do not have PCPs contracted in that county.

State Maintenance Plan (SMP) Placement

SMP is offered in counties in which there is not a qualified Tier 1 health plan. There are ten counties in which SMP will be available in 2016. Eight of the ten counties have the same SMP placement recommendation from 2015.

Pepin County was not recommended for SMP placement in 2015 because **WEA Trust - Northwest Chippewa Valley** has gained qualification. However, for 2016, WEA Trust has lost its qualification status since the plan has only two contracted PCPs in Pepin County.

Price County will have SMP placement for the WPE/Local program only. GHC of Eau Claire and Security Health Plan are both Tier 3 plans under the WPE/Local program for 2016 if the Board approves staff's recommendation. They are both Tier 1 plans under the State program.

The exclusion of the SMP in Marquette County under the WPE/Local program is discussed under the heading, "Consideration for Qualification Status in the Local Program" below.

Competition Analysis

There are three counties that have only one qualified Tier 1 health plan for the State program in 2016. In Lafayette County, **Medical Associates Health Plan** lost qualification, but **Physicians Plus** gained qualification for both the State and WPE programs. Pierce County was added to this list due to **WEA Trust - Northwest Chippewa Valley** losing qualified status.

Price County is included on this list for the State program due to **GHC of Eau Claire** qualifying as a Tier 1 plan under the State program, but a Tier 3 plan under the WPE program (if the Board approves staff's recommendation). In addition, **WEA Trust – East** discontinued service in Price County. Pepin County was removed from this list, as well as the WPE program list, due to **WEA Trust - Northwest Chippewa Valley** losing qualified status and SMP being placed in the county.

For the WPE program, in addition to Lafayette and Pierce Counties, there are eight additional counties with only one qualified Tier 1 health plan, due to **GHC – Eau Claire**, **Humana Eastern**, **Humana Western**, and **Security Health Plan** being placed into Tier 3 (if the Board approves staff's recommendation).

Consideration for Qualification Status in the WPE (Local) Program

Staff recommends the Board set Physicians Plus as the low-cost qualified health plan in Marquette County for the WPE Program.

In 2007, the Marquette County administration requested that one of the health plans covering its participants be considered the “low-cost plan” for the calculation of the employer share of the premium. The Board qualified **Physicians Plus** as the low-cost health plan in the county for 2007, due to the availability of providers in the surrounding counties. The Board has continued to consider this recommendation annually.

For 2016 three health plans have contracted with at least the minimum number of PCPs required for qualification: **Dean Health Insurance, Physicians Plus** and **WEA Trust – East**. None of the health plans with Marquette County in their service area contracted with a chiropractor or a hospital in Marquette County. **Physicians Plus’s** network includes the CHN Medical Center in the adjacent counties of Green Lake and Waushara, as well as the following hospitals in the four surrounding counties:

- Adams County: Moundview Memorial Hospital
- Columbia County: Columbus Community Hospital and Devine Savior Healthcare
- Green Lake County: Berlin Memorial Hospital
- Waushara County: Wild Rose Community Memorial Hospital

For 2016 **WEA Trust - East** has the same participating hospitals and providers in the surrounding counties and thus could be considered qualified in Marquette County for the WPE program only, as it was in 2015. **Physicians Plus** still has the lower cost between the two plans; therefore, **Physicians Plus** should be the low-cost qualified health plan in Marquette County for any employers participating in the WPE program who use the 105% formula to calculate the maximum employer contribution. The premiums for **WEA Trust - East** and **Physicians Plus** will be averaged for participating employers who use the 88% formula to calculate the maximum employer contribution.

It should be noted that **Dean Health Insurance** will expand its service area into Marquette County for 2016; however, the plan does not contract with Wild Rose Community Memorial Hospital, or with PCPs in Waushara County. Other health plans that participate in Marquette County include **Arise Health Plan, GHC of South Central Wisconsin, UnitedHealthcare of Wisconsin** and **Unity Health Insurance – Community**. These plans do not contract with the same providers and hospitals in the surrounding counties, therefore, they are not considered qualified.

Summary

2016 will experience a higher-than-usual number of plan qualification changes. While 13 of the qualification changes involve plans losing qualification status in various counties, the disruption for members is expected to be minimal. The placement of **GHC – Eau Claire, Humana Eastern, Humana Western**, and **Security Health Plan** in Tier 3 for the WPE program will limit the competition in many counties. However, it does not

significantly affect the SMP placement compared to 2015. Overall, the adjustment of service areas by **Network** and **Arise**, along with the 22 instances of plans gaining qualified status in counties they previously had a presence in, will provide more options for members.

2016 ALTERNATIVE HEALTH PLAN QUALIFICATION CRITERIA

[Excerpt from Guidelines Contract Section 2]

The Board has adopted qualification criteria applicable to health plans. By establishing qualification criteria, the Board provides a means by which only those health plans with an adequate provider base and operating experience will be used to determine the employer contribution for local governments and ensure a reasonable quality Tier 1 health plan for State employees. The qualification criteria adopted by the Board are:

1. The ratio of full-time equivalent primary physicians to total health plan members in a county or major city is at least 1/2000 with a minimum of five physicians (with admitting privileges to the plan’s hospital in the county) per county or major city.
2. The plan must have at least one general hospital available per county (or major city, if applicable). This criterion only applies in counties and major cities in which there is a hospital. For counties with no hospital, staff makes a qualification recommendation based on the availability of hospitals in the contiguous counties.
3. A chiropractor must be available in each county (or major city, if applicable).
4. The plan must have a minimum of one year of operation in the State plan.
5. After being offered to State employees for one year, the health plan must have achieved an enrollment of 100 subscribers or 10% of the employees in the service area, whichever is less.

Major cities are those that have over 33% of the county population. Those cities are:
