Background

At its February 17, 2016 meeting, the Board approved proceeding with the development and distribution of the following Requests for Proposals (RFP) in 2016:

- Wellness and Disease Management Vendor
- Data Warehousing and Business Intelligence Vendor
- Evaluation of Self-Insurance and Regional/Statewide Health Insurance Program Structure
- Pharmacy Benefit Manager

The purpose of this memo is to provide the Board with a status report on the aforementioned procurement activities.

RFP for Data Warehousing / Business Intelligence Vendor

Staff will issue a Request for Information (RFI) in early June to share a draft of the RFP with prospective vendors and provide an opportunity for input and feedback prior to the RFP release. Staff will incorporate appropriate changes into the final RFP. The purpose of this exercise is to ensure a strong RFP product that will attract best-in-class vendors. ETF has also engaged Segal Consulting (Segal) to assist with the development of the RFP.

RFP to Evaluate Self Insurance and Regional/Statewide Health Insurance Program Structure

Additional detail on this item is available in Board memo 3B, Self-Insuring Request for Proposals – Update & Discussion.

The target date to release this RFP is July 22, 2016, and results and evaluation will be presented to the Board at the November 15, 2016 meeting. ETF has engaged Segal to assist with the development of the RFP, with a particular focus on the cost and provider access and disruption aspects of the RFP.

ETF and Segal are providing two opportunities for prospective vendors to provide feedback as part of the RFP development process. The first request was issued May 4, 2016 and sought feedback on the proposed regions and prospective bidders' ability to submit claims data in a prescribed format.

ETF and Segal are issuing a second request in early June to share a draft of the RFP with prospective vendors and provide an opportunity for input and feedback prior to the RFP release. Staff will incorporate appropriate changes into the final RFP. The purpose of this exercise is to ensure that qualified vendors are able to participate in the RFP process and for ETF and Segal to attain additional feedback that will strengthen the final RFP.
