Background

At its February 17, 2016 meeting, the Board approved proceeding with the development and distribution of the following Requests for Proposals (RFP) in 2016:

- Wellness and Disease Management Vendor
- Data Warehousing and Business Intelligence Vendor
- Evaluation of Self-Insurance and Regional/Statewide Program Structure
- Pharmacy Benefit Manager

The purpose of this memo is to provide the Board with a status report on the aforementioned procurement activities.

RFP for Wellness and Disease Management Vendor

At the July 12, 2016 Board meeting, the Board approved the staff recommendation to issue a letter of intent to award the contract to The StayWell Company LLC (StayWell). The letter of intent was issued July 12 and contract discussions kicked off with StayWell on July 15. The original contract start date target was August 15, 2016. This will be delayed, as the Board will act on a vendor appeal regarding this contract at the August 16, 2016 Board meeting (see Agenda Item 12).
