**Subject:** Alternate Health Plan Service Area Qualification for 2017

Staff recommends the Group Insurance Board (Board) accept the qualification recommendations for the 2017 plan year described in this memo. Highlights of the 2017 recommendations include:

- Tier 3 designation in the Wisconsin Public Employee (WPE) Local program for the following plans: Arise Health Plan, Humana Eastern, Humana Western, Security Central, Security Valley, WEA Trust Mayo, and WEA Trust Chippewa Valley.
- Elimination of Anthem Blue Preferred Southeast in the State and WPE programs.
- Qualification status in Kewaunee County for the following health plans without a participating hospital: Anthem Blue Preferred Northeast, Arise Health Plan, WEA Trust-East, and UnitedHealthcare.
- Designation of Physicians Plus health plan as the low-cost qualified health plan in Marquette County for the WPE Program.

Staff also requests Board approval to make additional minor adjustments as service areas are confirmed with the health plans.

# **Background**

Qualification criteria ensure that participating health plans offer an adequate provider base and have sufficient operating experience to service members. The qualification criteria adopted by the Board are listed below.

1. The ratio of full-time equivalent primary physicians to total health plan members in a county or major city is at least 1/200 with a minimum of five primary care physicians (with admitting privileges to the plan's hospital in the county) per county or major city.

- 2. The plan must have at least one general hospital available per county (or major city, if applicable). This criterion only applies in counties and major cities in which there is a hospital. For counties with no hospital, staff makes a qualification recommendation based on the availability of hospitals in the contiguous counties.
- 3. A chiropractor must be available in each county (or major city, if applicable).
- 4. The plan must have a minimum of one year of operation in the State plan.
- 5. After being offered to State employees for one year, the health plan must have achieved an enrollment of 100 members or 10% of the employees in the service area, whichever is less.

Each year, the alternate health plans provide detailed data on contracted providers and facilities via their annual "Addendum 2" submission. Staff analyze this data against the qualification criteria to determine each health plan's qualification status for each county. If a county has no qualified Tier 1 health plan, the State Maintenance Plan (SMP) is offered in that county.

Based on the requirements noted above, each year the Board takes formal action on "qualifying" alternate health plans for each county in Wisconsin.

Prior to this meeting, all participating plans were notified of the qualification status recommendations staff planned to present to the Board.

# Notable Health Plan Changes for 2017

## Arise – Aspirus Health Plan

Arise – Aspirus Health Plan did not submit a bid and will not be offered for the 2017 plan year. The current 67 contracts / 155 members covered by Arise – Aspirus will be required to select a new health plan for the 2017 plan year. Staff analysis indicates that ninety-three percent (93%) of current Arise – Aspirus Health Plan providers are available through other health plans in the region.

# WEA Trust – South Central Health Plan

WEA Trust Health Plan will no longer be offering the WEA Trust – South Central service area. Currently there are 100 contracts / 167 members enrolled in the WEA Trust – South Central Health Plan. These members will be required to select a new health plan for the 2017 plan year.

#### Security Health Plan

For 2017, Security Health Plan will be offering a new, narrow-network plan named "Valley" in the ten counties listed below. The network features the providers and facilities that are part of the Bellin Health and ThedaCare accountable care organizations in northeastern Wisconsin. Three of the ten counties for this narrow-network plan are also included in Security Health Plan's core service area. Those three counties are designated with asterisks below (\*\*) and members residing in these counties will be able to choose from Security Health Plan's historic provider network – Security Health Plan-Central or the new Bellin Health/ThedaCare network – Security Health Plan-Valley.

#### Network Health Plan

Effective July 1, 2016, the ThedaCare provider network was no longer covered under Network Health. The continuity of care provisions in the Board contract with health plans assured our members who had ThedaCare providers could finish out the year without needing to change providers. It should be noted that the ThedaCare provider network is available through a majority of the other qualified health plans in the region.

#### Anthem Blue Preferred Southeast

Staff recommends that the Board remove Anthem Blue Preferred Southeast from participation in the State and WPE programs for 2017.

In consultation with the Board's actuary (Segal Consulting), the premium bids provided by Anthem for the Southeast service area were not acceptable for participation in the State and WPE programs. Through negotiations, Anthem was provided an opportunity to provide adjustments to bids to be in line with the expectations for program participation. While Anthem did lower the state bid to qualify as a Tier 3 plan, Anthem was unwilling to adjust their WPE premium bid sufficiently to warrant continued participation in the Southeast service area. Segal estimates that steering membership to the more efficient plans in the region will likely save employers and members over \$2.5 million in 2017.

In 2016, Anthem Blue Preferred Southeast has 2,856 contracts / 6,660 State and WPE members enrolled in this plan. The following counties will be impacted by removing Anthem Blue Southeast from participation; there are two or more qualified Tier 1 plans available in each county:

Kenosha County is also affected, and there is an alternative qualified Tier 1 plan available to members.

## **Qualification and Non-Qualification Changes**

A quality Tier 1 health plan is considered "qualified" if it meets all qualification criteria that ensures adequate provider coverage and operating experience for State and WPE members. If a quality Tier 1 health plan does not meet all qualification criteria, but meets minimum requirements, the health plan will be "listed" in the "It's Your Choice" materials as having limited provider availability.

There are a total of 47 changes in qualification status in the state program from 2016 to 2017 as illustrated below. Table 1 (attached) presents a listing of these changes, using the following categories.

#### WPE Health Plan Tiering Status for 2017

For 2017 staff recommends Tier 3 designation in the WPE program for the following health plans: Arise Health Plan, Humana Eastern, Humana Western, Security Central, Security Valley, WEA Trust Mayo, and WEA Trust Chippewa Valley.

In consultation with the Board's actuary, Segal, the premium bids provided by these plans for the WPE program were deemed at the top of the acceptable range at which they could bid. While the bids were acceptable for continued participation in the WPE program, lack of claims experience, very low enrollment, and/or unjustified higher premiums place these plans in Tier 3.

Overall, this recommendation will affect 54 of the 72 Wisconsin counties, but there is minimal membership in these plans. Active employee contracts with these plans include: Arise Health Plan (two family contracts), WEA Trust Chippewa Valley (13

individual/10 family contracts), and WEA Trust Mayo (20 individual/8 family contracts). There are also 76 annuitant contracts held by all seven plans, 73 of which are Medicare contracts which are not affect by tiering.

While the plans affected by this recommendation have a presence in six additional counties – Bayfield, Buffalo, Florence, Forest, Iron, Menominee, Pepin, Vilas, and Rusk – there are no qualified plans in these counties, the State Maintenance Plan will be offered in these counties, as discussed later in this memo.

#### **Qualification in Counties with No Hospital**

Staff recommends the Board qualify Anthem Blue Preferred Northeast, Arise Health Plan, WEA Trust-East, and United Healthcare health plans in Kewaunee County for the State and WPE programs without a participating hospital.

In 2015, the Board approved a change in the qualification criteria for counties with no hospital. If a health plan has hospitals available in surrounding counties, as determined by staff, then the hospital criteria would be considered fulfilled.

Qualification in Kewaunee County is based on plans being contracted with all of the following hospitals in surrounding counties:

The four health plans recommended for qualification contract with all of the hospitals in the surrounding counties as listed above. The lack of a hospital in Kewaunee County is the only factor that would not allow them to be qualified.

## **State Maintenance Plan (SMP) Placement**

SMP is offered in counties in which there is not a qualified Tier 1 health plan. There are ten counties in which SMP will be available in 2017. Eight of the ten counties have the same SMP placement recommendation from 2016. Counties marked with an asterisk (\*) in the table below indicate changes to SMP placement for the 2017 plan year.

\*\*Price County will no longer have SMP placement for the WPE/Local program. Group Health Cooperative is a qualified Tier 1 plan for the 2017 plan year for WPE/Local program in Price.

\*\*\*Rusk County will have SMP Placement for the WPE/Local program only. WEA Trust-Chippewa Valley was a qualified Tier 1 plan in 2016. For 2017, WEA Trust is a Tier 3 health plan and no other qualified Tier 1 health plan is available in Rusk County.

#### **Consideration for Qualification Status in the WPE Program**

Staff recommends the Board designate Physicians Plus Health Plan as the low-cost qualified health plan in Marquette County for the WPE Program.

In 2007, Marquette County administration requested that one of the health plans covering its participants be considered the "low-cost plan" for the calculation of the employer share of the premium. The Board qualified Physicians Plus as the low-cost health plan in the county for 2007, due to the availability of providers in the surrounding counties. The Board has continued to consider this recommendation annually.

For 2017, three health plans have contracted with at least the minimum number of PCPs required for qualification: Dean Health Insurance, Physicians Plus, and WEA Trust – East. None of the health plans with Marquette County in their service area contracted with a chiropractor or a hospital in Marquette County. Physicians Plus and WEA Trust – East networks contracts with the following hospitals in the four surrounding counties:

Physicians Plus has the lowest cost between the plans; therefore staff recommends Physicians Plus designation as the low-cost qualified health plan in Marquette County for any employers participating in the WPE program that use the 105% formula to calculate the maximum employer contribution. The premiums for WEA Trust – East and Physicians Plus will be averaged for participating employers that use the 88% formula to calculate the maximum employer contribution.

Unity Health Insurance-Community, Dean Health Insurance, and UnitedHealthcare Wisconsin participate in Marquette County. However, these plans do not contract with the same providers and hospitals in the surrounding counties, therefore, they are not considered qualified.

Staff will be at the Board meeting to answer any questions.
