Contracts and Amendments Executed Since the May 2022 Update:

Supplemental Vision (employee-pay-all) Insurance:

A contract for Supplemental Vision Benefits with Wyssta Insurance Company/Delta Dental of Wisconsin (DDWI) was signed by the Board chair on May 19, 2022, for the period January 1, 2023 through December 31, 2025.

Supplemental Accident (employee-pay-all) Insurance:

A contract for Supplemental Accident Benefits with Securian Life Insurance Company was signed by the Board chair on May 19, 2022, for the period January 1, 2023 through December 31, 2025.

Long-Term Care Insurance:

A contract for Long-Term Care insurance with Health Choice (Agent) and Mutual of Omaha Insurance Company was signed by the Board chair on May 19, 2022, for the period January 1, 2023 through December 31, 2024.

Compliance Audits of the Uniform Dental Benefits Contract:

Amendment #2 was signed by the ETF Secretary on June 1, 2022, assigning contract ETH0045 for the compliance audit of Unform Dental Benefits from Claim Technologies Inc. (CTI) to Brown and Brown of Massachusetts, LLC.

Segal Health Insurance Actuarial Services:

Amendment 19 with Segal was signed by the ETF Secretary on June 20, 2022, for Segal to (a) evaluate six to nine new and current health plan vendors offering to expand their networks to provide Access-type services to ETF's members, (b) build a new tier rate model that will migrate all the various members to the new plans, in qualified counties where they operate, (c) estimate the risk moving to each, (d) develop regional
