Thank you for your email to the Group Insurance Board (Board) regarding United HealthCare (UHC) and Quartz Central availability in your county.

UHC has not applied to be a part of the regular Group Health Insurance Program (GHIP) since leaving the program in 2017. Health plans interested in joining the state Group Health Insurance Program (GHIP) must apply to join the program. If the health plan is approved, the previous information is presented to the Board and the health plan begins to offer coverage effective January 1 of the upcoming year. Any health plan that leaves the GHIP must wait three years to rejoin the program. UHC is currently the Medicare Advantage and Medicare Plus plan administrator for the GHIP, but this is under a separate contract specifically for these retiree-only products.

Regarding Quartz Central's availability in your county, health plans must meet minimum provider access requirements. Plans must also tell ETF that they wish to be offered in a county to be included as an option. Each year, health plans submit counties and service areas in which they would like to provide coverage for members. ETF and the Board's actuaries review the health plan's service area submissions to make sure health plans can indeed provide coverage in the counties indicated previously. In 2023, Quartz's provider network was not qualified for Winnebago County, meaning they did not have enough providers under contract, and Quartz also did not ask to be offered in Winnebago County. This is why they were not an option in 2023. ETF will make Quartz aware of your request for their Central network to extend into Winnebago County.
