Background

The Department of Employee Trust Funds (ETF) tracks changes in the local and national health care industry that may impact the costs of the programs administered by the Group Insurance Board (Board) or access to care under the Board's programs. This memo highlights key mergers, acquisitions, and facility changes that have occurred since the Board's last market report in November 2022 (Ref. GIB | 11.16.22 | 7).

Regulatory Developments

Mergers and acquisitions continue in the health insurance and health care industries, despite evidence that such mergers tend to increase prices without commensurate increases in quality¹. The Federal Trade Commission (FTC) in August 2021 issued a statement that it had received so many merger filings that it would not be able to review all before mandated deadlines. The FTC also issued a warning at that time that it could deem a merger unlawful if the companies do move forward without the FTC's formal review and approval of their premerger filings. More recently, the FTC has identified cross-market mergers—mergers between two entities whose prior service areas do not overlap—as areas of focus for regulation.

In July 2023, the FTC and the United States Department of Justice (DOJ) released draft merger guidelines². These guidelines would be applicable to hospitals and health systems, among other entities. The FTC and DOJ both also withdrew their prior

healthcare antitrust policy statements because they, "no longer reflect market realities"³. Those statements provided "safety zones" for health system mergers⁴. The deadline for public comment on the new merger guidelines was September 18, 2023. The new guidelines received over 3,000 comments and are currently under review.

Insurance Carrier Developments and Trends

Froedtert Memorial Hospital Becomes Sole Owner of Network Health Plan In October 2023, Froedtert Health announced plans to buy Ascension Wisconsin's remaining stake in Network Health Plan, eventually becoming the sole owner. Currently, the two health systems each have a 50% stake in the plan. According to their announcement, Ascension would extend provider contracts through the end of the purchase to remain available to existing members. Currently, Network Health Plan serves 27,752 members of the Group Health Insurance Program in 25 counties.

Provider System Mergers and Acquisitions

Advocate Aurora/Atrium Health Merge

Advocate Aurora Health, whose presence is primarily in southeastern Wisconsin, finalized a merger with North Carolina-based Atrium Health in December of 2022. The merger was first announced in May of 2022. The new organization is called Advocate Health, but Advocate Aurora will continue to use its original branding in Wisconsin. The FTC investigated this merger but did not challenge it. At that time, the merger created the fifth largest nonprofit health system by revenue in the country⁵. Advocate generated the third most profit in 2022 among the largest nonprofit health systems in the country⁶.

<u>UnityPoint Health, Presbyterian Healthcare Services Announce, Call Off Merger</u>
UnityPoint Health, the owner of Madison's Meriter Hospital, and Presbyterian
Healthcare Services of New Mexico announced a letter of intent to merge in March
2023. The merger would have yielded a system generating \$11B in revenue, but both
parties announced in October 2023 that they no longer intend to merge⁷.

Froedtert to Merge with ThedaCare

In April 2023, Froedtert Health and ThedaCare announced plans to merge by the end of 2023; this follows announcements in 2022 of plans between Froedtert, Medical College of Wisconsin, and Theda Care to build new hospitals together in Fond du Lac and Oshkosh. At that time, the entities stated no intention to merge. Medical College of Wisconsin is not currently a part of this planned merger.

St Luke's Duluth to Join Aspirus Health

In July 2023, St Luke's hospital in Duluth, Minnesota, announced plans to join Aspirus Health System. If completed, Aspirus Health would become the headquarters; Aspirus Health is based in Wausau⁸.

Health System Capital Development

<u>UW Hospital Announces New East Madison Surgery Center, Increased Inpatient and Emergency</u>

UW Hospital and Clinics Authority approved adding on to their east Madison hospital campus in December 2022. The new facility will be an ambulatory surgery center and is scheduled to open in 2024. In July 2023, UW Hospital announced it would also be increasing capacity at its east Madison campus, adding a new emergency room and inpatient surgical rooms⁹.

Mayo Clinic Expands In-Progress La Crosse Hospital

Mayo Clinic announced the intent to replace its existing La Crosse hospital in February of 2022. In June 2023, they announced plans to increase the number of total beds from 70 to 96. Mayo Clinic still plans for this facility to open in 2024.

Other Hospital and Healthcare System Changes

Ascension St. Francis Ends Labor and Delivery Services

In December 2022, Ascension announced that it would end labor and delivery at its St. Francis Hospital on Milwaukee's south side, with services moving to Columbia St. Mary's and Ascension's St. Joseph campus, each approximately 10 miles away on Milwaukee's north side. Ascension had the fourth-highest revenue amongst large health systems in 2022¹⁰.

Marshfield Clinic Health System Reducing Workforce

The last market update to the Board in November 2022 noted a potential merger between Marshfield Clinic Health System and Essentia Health which, if completed, would result in a new organization with combined revenues of \$5.4B¹¹. Six months following the announcement of the potential merger, Marshfield Clinic announced plans to lay off 222 workers in May of 2023. Marshfield attributed the need for staff reductions to labor costs, supply expenses, and reimbursement decline¹². Marshfield Clinic and Essentia announced in July of 2023 that they intend to close their merger by the end of 2023¹³.

Commonwealth Fund Report: Wisconsin Ranks 21

The Commonwealth Fund released its annual scorecards of healthcare systems in the U.S. by state in June 2023. Wisconsin ranks 21 overall and leads among Great Lakes states. Wisconsin performed best and reported most improvement in preventable hospitalizations for people ages 18 to 64. While Wisconsin also performed best in maternal mortality, it worsened the most in severe maternal morbidity. It also worsened the most in employer-sponsored insurance spending per enrollee, an issue that the Board and ETF continue to look for ways to actively address¹⁴.
