We have finished our review of services for the coming 2023 plan year and presented our findings to the Board in May, this included a discussion of coverage for marriage or couples counseling. ETF is limited under Wisconsin state law to only adding services when other benefit reductions are made, if the service itself will save money, or if we are legally required to add coverage. Based on this, the Board determined that we cannot add marriage or couples counseling coverage at this time.




