The following are contracts and amendments executed since the November 13, 2024, Group Insurance Board (Board) meeting:

Milliman Consulting Actuary for Wisconsin Group Insurance and Disability Programs
 Contract amendment #24 was signed by the Department of Employee Trust Funds (ETF) Secretary on January 8, 2025. The amendment increased the retainer fee to \$146,027 for calendar year 2025 services described under RFP ETD0013.

Segal Consulting Actuary for Wisconsin Group Health Insurance Programs
 Contract amendment #27 was signed by the ETF Secretary on January 8, 2025. The amendment increased the retainer fee to \$419,701 for calendar year 2025 services described under RFP ETD0012 and provided the performance guarantees for It's Your Choice 2026.

Delta Uniform Dental Benefits
 Contract amendment #1 with Delta Dental of Wisconsin for Uniform Dental Benefits was signed by the Board Chair on January 10, 2025. The amendment extended the contract term two additional years, from January 1, 2027, through December 31, 2028, for the rate of \$1.15 per employee per month. The Board retains the option for renewal for one additional two (2)-year term (2029-2030).

Navitus Health Solutions, LLC TPA Pharmacy Benefit Program
 Amendment #8 with Navitus was signed by the Board Chair on January 22, 2025, to implement and operate the Medicare Prescription Payment Program (M3P) for qualifying members beginning January 1, 2025.

Supplemental (Employee-Pay-All) Vision and Accident Plans

Recommendations for contract awards for the 2026 plan year will be made at the May 2025 Board meeting.

Income Continuation Insurance

Contract amendment #1 with The Hartford was signed by the Board Chair on December 23, 2024. The amendment increased the annual retainer fee paid to The Hartford for administrative fees for 2025 to \$3,136,440 (an 18% increase from 2024) and for 2026 to \$3,334,036 (an increase of 6.3% from 2025).
