Dear Mr. and Ms. Morton,

Thank you for your letter to the Employee Trust Funds Board dated May 27, 2019. It will be shared with the members of that board, as well as the Wisconsin Retirement and Teachers Retirement Boards.

The Department of Employee Trust Funds (ETF) and the boards share your concerns regarding the diversity of nominees that run for election to the three boards attached to the department that include elected members. We are aware of these concerns by Wisconsin Retirement System members as well and are working on ways to foster a more diverse slate of candidates in the future.

A challenge we face is that the candidates are self-selected. If a candidate fits the category for the seat (e.g., annuitant, public school teacher, etc.) and submits a valid nominating petition and candidate statement, the person may run for a seat. So, ETF and the boards have little control over who decides to participate. But, as stated above, we are working on any measures we can take to encourage more diversity in the candidates that go through the self-nomination process.

Thanks again for your thoughtful letter. We appreciate the feedback.
