**SUBJECT:** 2010 Benefit Annuity Statistics Report

### This memo is for informational purposes only. No Board action is required.

Attached for your review are the 2010 Wisconsin Retirement System (WRS) disability annuity statistics reports. The reports provide information on disability benefit annuity applications approved by the Boards throughout 2010. No Board action is required.

## 2010 DISABILITY ANNUITY HIGHLIGHTS

- The Department completed disability benefit estimates for 684 participants. •
- § 40.63 disability retirement benefits were started for 163 participants.
- Duty disability benefits were started for 31 participants.
- For the disability annuity benefits approved by both the Teachers Retirement and Wisconsin Retirement Boards, the most popular benefit option was "100% Continued to Named Survivor with 180 Payments Guaranteed."

### 2010 TEACHERS RETIREMENT BOARD SPECIFICS

- 93% of the disability applications were approved/deemed approved. Only 4% were cancelled/void/withdrawn/invalid, and 3% were denied.
- 65% of the disability annuities started were for females and 35% were for males.
- 37% of the disability applications were for participants aged 51-55, 28% were for participants aged 56-60, and 18% were for participants aged 46-50.
- 58% of disability applications had one of three disabilities: Cancer (21%). Neurology (19%), and Multiple Medical Problems (18%).

## 2010 WISCONSIN RETIREMENT BOARD SPECIFICS

- 89% of the disability applications were approved/deemed approved. Only 4% were denied, 7% were cancelled.
- 53% of the disability annuities started were for females and 47% were for males.
- Participants aged 51-55 and 56-60 had 30% of disability applications each, 23% were for participants aged 46-50.
- 56% of the disability applications had one of three disabilities: Cancer (20%), Neurology (18%), and Multiple Medical Problems (18%).
