DISCUSSION/CONSIDERATION OF DRAFT RULE FOR BOARD ELECTIONS

Steve Hurley, Director of the ETF Office of Policy, Privacy & Compliance, reviewed the proposed draft rule for Board elections and noted that he had incorporated changes suggested by the Board during its last review. The administrative rule allows voters to cast a ballot either by mail (paper ballot) or electronically. Mr. Hurley explained that, if implemented, each voter would be mailed a paper ballot as well as instructions for voting online. If the voter wanted to vote by mail, he/she would use the paper ballot. If the voter wanted to vote online, he/she would use the assigned PIN number and follow the instructions provided. Mechanisms would be in place to prevent anyone from voting twice (once by paper ballot and once online).

OPERATIONAL UPDATES

Rehired Annuitant Update

Matt Stohr, Administrator of the Division of Retirement Services, provided an update on rehired annuitants. He referred the Board to the memorandum in their binders (ref. TR | 6.23.11 | 4A). The attachment mentioned in the memorandum (the May 2011 edition of the Employer Bulletin) is missing from Board members' binders. Mr. Stohr indicated he would forward this attachment to Board members.

Mr. Stohr gave a brief summary as a follow-up to recent presentations on rehired annuitants. He noted that many employers have contacted ETF with follow-up questions, which ETF is handling on a case-by-case basis.
