## CORRESPONDENCE MEMORANDUM

**SUBJECT:** Membership on the Employee Trust Funds Board

The Teachers Retirement (TR) Board is asked to consider appointment of a public school administrator or school board member to a seat on the Employee Trust Funds (ETF) Board at the December 6, 2012, ETF Board meeting.

The TR Board, by statute, appoints four members to serve on the ETF Board. These appointments are staggered, four-year terms.

Dan Nerad was appointed to the ETF Board by the TR Board in 2009 for a term ending May 1, 2013. In October 2012, Mr. Nerad submitted his resignation from the TR Board to the Governor. To date, the Governor has not appointed anyone to fill this seat on the TR Board. As a result, a vacancy exists on the ETF Board.

The TR Board may choose to fill the vacancy on the ETF Board with a public school administrator or school board member, or it can decide to take no action at this time. Roberta Rasmus is the only member of the TR Board currently eligible for this seat.

An appointment to the ETF Board would be for the remainder of Mr. Nerad's term. If the Board wishes to appoint Ms. Rasmus for a 4-year term starting in May 2013, it may include such an intention in the motion. The motion to appoint Ms. Rasmus to another term would be brought before the Board at its next meeting.
