# CORRESPONDENCE MEMORANDUM

**TO:** Teachers Retirement Board

SUBJECT: Membership on the Employee Trust Funds Board

At the March 7, 2013 meeting, the Teachers Retirement Board (TR Board) is asked to consider making the following two appointments to seats on the Employee Trust Funds Board (ETF Board):

- (1) A TR Boad member elected as a City of Milwaukee teacher participant;
- (2) A TR Board member appointed as a public school administrator or school board member.

The TR Board, by statute, appoints four members to serve on the ETF Board. These appointments are for four-year terms.

# Member Elected as a City of Milwaukee Teacher

Under s. 15.16 (1) (a) 3., Wis. Stats., one of the TR Board appointees to the ETF Board must have been elected to the TR Board as a public school teacher in the City of Milwaukee. This seat on the ETF Board is currently held by Michael Langyel, whose term on the ETF Board expires on May 1, 2013. Mr. Langyel is the only member of the TR Board eligible for appointment to this seat on the ETF Board.

# School Administrator or School Board Member

Under s. 15.16 (1) (a) 4., Wis. Stats., one of the TR Board appointees to the ETF Board must have been appointed to the TR Board as either a public school administrator or school board member. This seat on the ETF Board is currently held by Roberta Rasmus. At the December 6, 2012, meeting, the TR Board appointed Ms. Rasmus to the ETF Board to fill the remainder of the unexpired term for the seat previously held by Dan Nerad. That term expires on May 1, 2013. At the December meeting, the TR Board further expressed the intent to reappoint Ms. Rasmus for a full term beginning May 1, 2013. Ms. Rasmus is the only member of the TR Board eligible for this seat on the ETF Board.
