# Correspondence Memorandum

Subject: Appointment to the ETF Board

### ETF recommends the Teacher Retirement Board fill a vacancy on the ETF Board.

Per State Statute 15.16(1)(a), the Teachers Retirement (TR) Board appoints four members to the Employee Trust Funds Board. In June 2018, the TR Board reappointed David Wiltgen to the ETF Board (<u>Ref. TR | 6.21.18 | 4B</u>). Since that time, Mr. Wiltgen has resigned his position as a teacher and his seat on the ETF Board. The vacancy resulting from this resignation creates the need for the TR Board to appoint a new representative to the ETF Board. The new representative will serve the remainder of Mr. Wiltgen's term, which will expire in 2022. TR Board members eligible for this seat include:

- Tony Przybylski

Chris Heller is the only member we are aware of who has communicated his interest in serving. The new representative's term is effective upon the filing of the oath of office. Practically speaking, the representative would start serving at the September ETF Board meeting.
