Subject: Membership on the Employee Trust Funds Board

The Teachers Retirement Board (TR Board) is asked to consider making the following two appointments to seats on the Employee Trust Funds Board (ETF Board):

- (1) A TR Board member elected as a City of Milwaukee teacher participant;
- (2) A TR Board member appointed as a UW teacher participant in the WRS.

Per State Statute 15.16(1)(a), the Teachers Retirement (TR) Board appoints four members to the ETF Board. Currently, three of the four members have expired terms. Those with expired terms include the following:

- Michael Langyel (City of Milwaukee teacher participant)
- Bob Niendorf (UW teacher participant in the WRS)
- Roberta Rasmus (public school administrator or member of a school board)

While the TR Board Chair, Brent Grochowski, has considered asking the TR Board for updated appointments to the ETF Board in the past, until recently there were no eligible TR Board members that met the appointment criteria. Two of the three positions now have eligible candidates.

Member Elected as a City of Milwaukee Teacher

Under s. 15.16 (1)(a)3., Wis. Stats., one of the TR Board appointees to the ETF Board must have been elected to the TR Board as a public school teacher in the City of Milwaukee. This seat on the ETF Board is currently held by Michael Langyel, whose term on the ETF Board is expired. Currently, Amy Mizialko is the only member of the TR Board eligible for appointment to this seat on the ETF Board.

Member Appointed as a UW Teacher Participant in the WRS

Under s. 15.16 (1)(a)2., Wis. Stats., one of the TR Board appointees to the ETF Board must have been appointed to the TR Board as a UW teacher participant. This seat is

currently held by Bob Niendorf, whose term is expired. Currently, Dave Schalow is the only member of the TR Board eligible for appointment to this seat on the ETF Board.

If the TR Board makes these appointments, they would be for a four-year term expiring July 1, 2025.
