#### **CONSIDERATION OF MINUTES**

MOTION: Ms. Ancel moved approval of the December 9, 2020, open session minutes as submitted by the Board Liaison. Mr. Heller seconded the motion, which passed unanimously on a voice vote.

#### **ANNOUNCEMENTS**

Mr. Stohr announced that the restructuring of the Retirement Boards' proposal made it into the governor's proposal. However, the legislature took many items out of the budget bill, including the board restructuring. ETF can look at separate legislation or a future budget session, but the same board structure will remain for now. Mr. Voelker spoke with a few members of the legislature. They did not have a negative reaction to the proposal, rather they preferred it be introduced under a separate bill. There was Board discussion on the topic.

#### **ELECTION OF OFFICERS**

#### Appointments to the Employee Trust Funds (ETF) Board

Therefore, ETF recommends the Board update its appointments to the ETF Board to make appointments current. She reviewed the current TR Board appointment seats on the ETF Board and who is eligible for the seats.

Both Dave Schalow and Amy Mizialko verbally acknowledged they are willing to serve if nominated.

MOTION: Mr. Heller moved to nominate the following Teachers Retirement Board appointees to the Employee Trust Funds Board.

- 1. Amy Mizialko as the City of Milwaukee teacher participant.
- 2. David Schalow as the UW teacher participant in the WRS

The new representatives will serve for a four-year term that will begin July 1, 2021 and expire July 1, 2025. Ms. Ancel seconded the motion,
