## **DISCUSSION/CONSIDERATION**

### Clearinghouse Rule #11-044

Mr. Nispel referred the Board to Clearinghouse Rule (CR) #11-044 (Ref. JI | 12.1.11 | 4B). He explained the rule reflects changes and clarifications in the appeals process.

Mr. Nispel noted the Group Insurance (GIB) and Deferred Compensation Boards approved the rule at their November 2011 meetings and the Teachers Retirement (TR) Board approved the rule at their meeting today. He will ask the ETF Board for their approval of the rule later today.

Mr. Nickel queried whether there was any feedback from the other Boards about the rule. Mr. Nispel replied the GIB approved the rule with the modifications of removing four sections of the rule related to evidence that could be brought to a Administrative Law Judge and what that Judge could do with the evidence. The overall consensus was that those sections limited the Administrative Law Judge.
