# CORRESPONDENCE MEMORANDUM

**DATE:** January 25, 2013

- **TO:** Wisconsin Retirement Board

- SUBJECT: Membership on the Employee Trust Funds Board

### At the March 7, 2013 meeting, the Wisconsin Retirement Board (WR Board) is asked to consider appointing one of its members to a seat on the Employee Trust Funds Board (ETF Board) under s. 15.16 (1) (b) 2., Wis. Stats., for a term commencing on May 1, 2013.

The WR Board, by statute, appoints four members to serve on the ETF Board. These appointments are for staggered, four-year terms. One of these appointments is for a WR Board member who was appointed to the WR Board as a participating state employee. That seat on the WR Board is currently vacant and, therefore, is unavailable for appointment to the applicable seat on the ETF Board.

The WR Board may act, however, with regard to another of its appointments to the ETF Board. Under s. 15.16 (1) (b) 2., Wis. Stats., at least one of the WR Board appointees to the ETF Board must have been appointed to the WR Board as a participating employee of a city or village that participates in the WRS, a participating employee of some other local government that participates in the WRS, or a participating state employee. The term for this seat on the ETF Board expires on May 1, 2013. This seat on the ETF Board is currently held by Mary Von Ruden.

If the WR Board makes this appointment, it would take effect at the end of the current term and would be for a term ending on May 1, 2017. Current members of the WR Board who are eligible for this appointment are Ms. Von Ruden and Mr. Wilding.
