ANNOUNCEMENTS

Mr. Wilding asked if there were any announcements from ETF staff or Board members in addition to those that presented at the Joint Meeting of the Employee Trust Funds, Teachers Retirement, and Wisconsin Retirement Boards (Joint Meeting) earlier that day. None were posed.

CONSIDERATION OF OPEN AND CLOSED MINUTES OF FEBRUARY 28, 2023, MEETING (Ref. WR | 09.21.23 | 2A)

MOTION: Mr. Stinski moved to approve the open and closed session minutes of the February 28, 2023, meeting, as presented by the Board Liaison. Ms. Wathke seconded the motion, which passed unanimously on a voice vote.

Mr. Wilding asked if there were any additional questions or further discussion needed regarding the administrative rule change, but none were posed.

MOTION: Ms. Von Ruden moved to approve the final version of the proposed administrative rule changes, CR 23-023, as recommended by ETF. Ms. Miller seconded the motion, which passed unanimously on a voice vote.

FUTURE ITEMS FOR DISCUSSION

Mr. Stinski expressed interest in having more information concerning the statutory requirements and eligibility criteria, such as those contained in Wis. Stat. § 40.63, for the disability programs. Mr. Stohr stated that ETF staff would present an overview of the disability programs to the Board at an upcoming meeting.
