

IT'S YOUR HEALTH: DIABETES

This program seeks to help participants manage diabetes. If you have diabetes, you can take part in a WebMD condition management program. In exchange, you will receive lower prescription drug copays.

How it Works

- Participate in the telephonic WebMD diabetes coaching program.
- We'll work with you on your individual situation, to help you reach your health goals.
- Your copay for anti-diabetic drugs* will be lowered:
 - Level 1 drugs will have no copay (down from \$5).
 - Level 2 drugs will be the lesser of \$10 or 20% (normally 20% up to a \$50 maximum).

That's it! Stay in touch and save money on anti-diabetic drugs.

There is no cost to participate in the program. WebMD may be reaching out to you to see if you are interested in participating. To enroll, call 800-821-6591.

FREQUENTLY ASKED QUESTIONS

What is a diabetes coaching program?

WebMD's condition management program focuses on empowering participants with managing their overall health. Coaches support participants with understanding their role in managing their health condition and following the treatment plan; building knowledge, skills and confidence to manage their condition; supporting behavior change to improve health.

Why was I selected for this condition management program?

You have received an invitation to participate in this program because you said you had diabetes on the WebMD health assessment and/or you are currently receiving a diabetes-related prescription drug covered through the State of Wisconsin Group Health Insurance Program.

What qualifications does a health coach have?

Lifestyle Coaches, Registered Nurses and Certified Diabetes Educators are all available to support you. We will match you up with a professional resource who will best support your specific needs.

Will my personal health information be shared with my employer, Employee Trust Funds (ETF), or the group health insurance program?

No. Personal health information is protected by federal law and will not be shared with your employer, ETF, or the Group Insurance Board. For more information see the WebMD [Privacy Statement](#) and [ETF's Notice for Wellness Programs](#).

Will my employer, Employee Trust Funds (ETF), or the group health insurance program know whether I choose to participate in this program?

For which prescription drugs will I receive lowered copays?

If you participate in the *It's Your Health: Diabetes* program, you will receive reduced copay on Level 1 and Level 2 drugs. Level 1 drugs will have no copay (down from \$5), and Level 2 drugs will be the lesser of a \$10 copayment or 20% coinsurance. For a list of specific drugs that are eligible for the lowered copay, please see the formulary section of the [Navitus web page](#) found on ETF's web site (no login required) or by logging in to your [Navitus Member Portal](#). If you are in the Navitus MedicareRx Medicare Part D plan log in to your [MedicareRx Member Portal](#). You must be registered to access the member portals. You can also find the list of eligible anti-diabetic drugs on the WebMD wellness portal.

When will I begin receiving reduced copays for my anti-diabetic drugs?

You will begin seeing reduced copays by the 20th of the following month after completing your first condition management call with the WebMD nurse consultant. For example, if you complete your first call on January 15, you will begin receiving reduced copays by February 20.

How long will this program last?

This is a pilot program and has been approved by the Group Insurance Board (Board). You will be notified at least 90 days in advance if the program will end and your copay will change.

I'm currently prescribed a level 3 or 4 drug to manage my diabetes. Will I receive reduced copays?

No. There are not reduced copays for level 3 or 4 drugs. You may, however, still engage in the WebMD condition management program at no additional cost for support in managing your health. You can speak with your doctor to find out if there are drugs covered at level 1 or 2 on the Navitus formulary that would work as alternatives for you.

Can my child participate in the program and receive reduced pharmacy copays for their prescriptions?

No. This pilot program is for subscribers and their spouses enrolled in the State of Wisconsin Group Health Insurance Program.

Can I receive reduced copays for other prescriptions outside of diabetes management?

No. The reduced payments are for diabetes management prescription drugs only. Based on the pilot program results, ETF may explore additional program options.

Can I receive reduced costs for my diabetes-related supplies like test strips and lancets?

No. diabetic-related supplies, like test strips and lancets, are not eligible for reduced cost sharing as part of this pilot program.

**What if I'm engaged in a disease/condition management program with my health plan?
Can I also receive reduced pharmacy costs for my prescription drugs?**

Congratulations on taking action with your health. Unfortunately, most members will not receive a reduced pharmacy cost for prescription drugs by engaging in their health plan's services. The one exception is Dean Health Plan members who are eligible through Dean's *Living Healthy Plus* program. We encourage all members to continue receiving support from your health plan, and to consider also working with WebMD to reduce copays if desired.

I'm enrolled in the high deductible health plan (HDHP), can I still participate in this program?

Participants in the HDHP may participate in the WebMD condition management program; however, because of Internal Revenue Service (IRS) and Wisconsin statutory requirements related to the Health Savings Account (HSA), you will not be eligible for the reduced copays for prescription drugs.

 - Members who self-identify as having diabetes on the WebMD health assessment will receive an invitation from WebMD to participate in the pilot program.
 - Members who are currently taking an anti-diabetic prescription drug and who have a WebMD portal account will also receive an invitation to participate.

- ▶ Eligibility for reduced pharmacy copays begins by the 20th of the following month after completing your first DM call with the WebMD nurse consultant.
- ▶ Reduced copayments will continue throughout the 2022 plan year.
- ▶ Eligible members are limited to subscribers and spouses only.
- ▶ Members CANNOT be enrolled in a High Deductible Health Plan (HDHP) option to be eligible for this pilot program.
