



Beneficiary





You May Name

An individual (or multiple individuals)



An entity
(such as a charity, business, religious organization, funeral home, etc.)



A Trust



Your Estate



Standard Sequence

Surviving Spouse or Domestic Partner



Children (natural or legally adopted)

If one of your children dies before you, that child's share is divided between the deceased child's children



Parent(s)



Estate




Brother(s) and Sisters(s)

If one of your siblings dies before you, that sibling's share is divided between the deceased sibling's children



Beneficiary Designation form

- Designate
 the order and manner
 that benefits will be
 received
- Any benefits payable shall be paid in equal shares, unless otherwise specified

Alternate Beneficiary Designation form

- Specify who shall receive a primary beneficiary's share if a primary beneficiary is deceased
- Specify who shall receive a secondary beneficiary's share if a secondary beneficiary is deceased




Death Benefits Before Annuity




Beneficiary(-ies) receive






Alternate Payees considered same as Inactive Employees

- A divorce, annulment, marriage, or similar event will not invalidate a Beneficiary Designation
- Know your most recent beneficiary designation on file
 - Call us for a copy
- You may update your beneficiary designation as often as you would like


Completing a Beneficiary Designation

- When naming beneficiaries, do not use:
 - Nicknames
 - Overwriting, erasures, "white-out," crossed-out words
 - Numerals denoting order of beneficiaries
 - Special instructions and notations
 - References to future events or use the word "or"
 - Designation by letter



Completing a Beneficiary Designation

- Be sure to fill out the top of the form
- Sign and date the form






