Out of Network Services

• The provider network you choose has a variety and number of providers to meet your health care needs. If you receive services from a provider outside of your network, it will not be covered unless it's for urgent care or an emergency room.

Some services may require prior approval or may not be covered based on medical necessity.

Population Health Management Programs

• The Cooperative offers comprehensive population health management programs for members, which include complex case management and disease management. A list of programs and how to enroll can be found on the Cooperative's website at group-health.com.

Self-Management Tools

• Allows members to play a central role in managing their health and gives members resources to make behavior changes and improve their well-being.

Health and Wellness Video Library

• The Cooperative offers an expansive library of informational videos pertaining to a wide variety of health and wellness questions and concerns.



Utilization Management Program

- The Cooperative's Utilization Management team works closely with members' physicians and hospital staff to ensure that members receive necessary care before, during, and after their hospital stay.
- The dedicated team also assists and coordinates with members to ensure they get the right care at the right place and time.



Pre-service Review

• A request for coverage of medical care or services which the provider must have approved within 14 calendar days prior to rendering services.

Urgent Concurrent Review

• A request for coverage of medical care or services made while the member is in the process of receiving care. Must meet criteria and be completed within 24 hours of the request.

Post Service Review

• A request for coverage of medical care or services that have already been received. Must be completed within 14 calendar days.

Filing an Appeal

• A member may appeal any adverse benefit determination.
