 This allows our members to receive high-quality care, great services, and value at the lowest possible cost. We serve the needs of our members and keep community resources in the community.


You, the members, are the owners.

We actively work to remove barriers to accessing health services by supporting the sustainable development and well-being of our communities.



Benefit Restrictions




- Out of Network Services
 - Only Emergency Room and Urgent Care coverage outside of Provider Network
- Some services may require prior approval or may not be covered based on medical necessity.
- Exclusions and limitations based on benefits can be found on our website or by calling Member Services.

Utilization Management Procedures



Pre-service Review

A request for coverage of medical care or services which provider must have approved within 14 calendar days prior to rendering services.

Urgent Concurrent Review

A request for coverage of medical care or services made while the member is in the process of receiving care. Must meet criteria and be completed within 24 hours of request.

Post Service Review

A request for coverage of medical care or services that have already been received. Must be completed within 14 calendar days.

Filing an Appeal

A member may appeal any adverse medical necessity and benefit decision within 45 days of receiving a denial notification.

Notice of Privacy Practices



Our Privacy Responsibilities include:

- Protecting the privacy of any protected health information created or received about you
- notifying you if there is a breach of your protected health information.
- Using and sharing protected health information only as outlined in our Notice of Privacy Practices and by state and federal laws.
