Subject: Notice of Intent to Award Contracts under RFPs ETB0047-49 – for Well-Being, Mental Health, and

Chronic Condition Management Programs

Dear WebMD:

On February 22, 2023, the Wisconsin Group Insurance Board (Board) granted authority to the Secretary of the Wisconsin Department of Employee Trust Funds (ETF) to issue an intent to award contracts on behalf of the Board for Well-Being, Mental Health, and Chronic Condition Management services (RFPs ETB0047-49) to WebMD Health Services Group, Inc. (WebMD), for the period commencing on January 1, 2024 through December 31, 2026, with the potential for two, 2-year extension periods subject to successful contract negotiations. The bid abstract for this solicitation is on the following page.

Due to the time sensitive nature of an executed contract, the Board approved that the Secretary be allowed to issue an intent to award contracts to the second ranked vendor, Sharecare, if contract negotiations with WebMD fail or extend beyond a reasonable period of time. ETF expects contract negotiations with WebMD to make reasonable progress toward conclusion by the end of May 2023.

RFP Section 3.11 describes the Board's policy for vendor procurement appeals. Should a vendor choose to appeal the intent to award decision herein, the vendor must provide the Department with notice of intent to appeal within five (5) business days of the date of this letter by emailing ETF at both ETFSMBProcurement@etf.wi.gov. Appeal letters must include the information specified in the Board policy (available at http://etf.wi.gov/boards/gov-manual-gib/vendor.pdf) and be sent to the same email addresses above within ten (10) business days of the date of this letter.
